The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 568.060, RSMo, committed the class A felony of abuse or neglect of a child, punishable upon conviction under Section 558.011 in that on or about November 16, 2018, in the County of Jackson, State of Missouri, the defendant, either acting alone or in concert with another, was responsible for the care, custody and control of E.S. (DOB 06/08/2016), a child less than eighteen years of age, and neglected E.S. by failing to seek medical attention and as a result defendant knowingly caused the child to suffer physical injury and, E.S. died as a result of injuries sustained from this conduct.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

The victim was transported to the Jackson County Medical Examiner's Office. A provisional anatomic diagnosis from the Jackson County Medical Examiner's Office listed the victim's cause of death as 1. Severe Malnutrition 2. Probable Dehydration (pending toxicology).

Observations by the responding Officers and Detectives of the victim were the victim's cheeks were sunken in. The victim's stomach was also sunken in and his ribs were easily visible underneath the skin. When the victim was turned, the victim's spine was also easily visible through his skin. When the diaper the victim was wearing was removed the victim's penis and scrotum were observed to be purple in color and bruised. The victim's penis had apparent layers of skin missing.

Observations by the responding Officers and Detectives of the residence the victim was located in were the house was generally unclean and cluttered. Apparent rat feces were located throughout the residence to include the bedroom the victim was located in. The door to the bedroom the victim was found in had a lock on the outside of the door which would not allow the door to open from the inside. A hook latch was also on the outside of the door preventing the door to open from the inside. The closet in the room the victim was in had apparent human feces on the floor and ceiling. Apparent finger streaks made with feces were also observed in the closet. Apparent feces or blood was observed on the wall next to the toddler bed inside the bedroom where the victim was found.

Yepez stated the victim's father lives in Puerto Rico and is not in the victim's life. Yepez stated on 11-16-2018 he went to work between 1200-1300 hours. Yepez stated when he left he heard the victim in his room upstairs playing. Yepez stated after work he went to his mother's house before receiving a call from **Serrano** stating the victim was not breathing. Yepez stated when he returned home he observed the victim and knew he was deceased. Yepez stated the victim looked skinny with blue lips and was wet. Yepez stated **Serrano** told him she bathed the victim. Yepez stated **Serrano** is the primary caretaker for the victim and their daughter. Yepez stated he victim had been sick for a few weeks but stated no one took the victim to a doctor or hospital. Yepez stated he does not normally feed the victim and stated the last time he fed the victim was approximately one year ago.

Serrano was arrested on 11-22-2018 at 1205 and transported to Police Headquarters. After being read her Miranda Rights, Serrano declined to provide a statement.

Yepez admitted he never made sure the victim was fed. Yepez stated he last saw the victim three weeks prior to his death and did not check on the victim at all during the three week span.
