Count I. Sodomy Or Attempted Sodomy - 1st Degree (566.060-001Y20131114.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.060, RSMo, committed the felony of sodomy in the first degree, punishable upon conviction under Section 566.060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or between September 1, 2018 and October 7, 2018, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant knowingly had deviate sexual intercourse with who was incapable of consent because of youth, by touching wagina with his hand.

The offense of sodomy in the first degree or an attempt to commit sodomy in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years. An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served. No person found guilty of sodomy in the first degree or an attempt to commit sodomy in the first degree shall be granted a suspended imposition of sentence or suspended execution of sentence.

Count II. Sexual Exploitation Of A Minor Child (573.023-001Y20036402.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.023, RSMo, committed the class A felony of sexual exploitation of a minor, punishable upon conviction under Sections 558.011 and 573.023, RSMo, in that on or between April 1, 2018 and October 7, 2018, in the County of Jackson, State of Missouri, the defendant, knowingly created a visual depiction of sexually explicit conduct of a person less than fourteen years of age by photographing the vagina of

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

Count III. Possession Of Child Pornography - 1st Offense (573.037-002Y20173704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable upon conviction under Sections 573.037, 558.002 and 558.011, RSMo, in that on or between April 1, 2018 and October 7, 2018, in the County of Jackson, State of Missouri, the defendant knowingly possessed child pornography that was a visual depiction of a person less than eighteen years of age engaged in sexually explicit conduct, consisting of a still image, c58cecaf5ceb7be20f730e4ba2e9cc04, of vagina.

The range of punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count IV. Possession Of Child Pornography - 1st Offense (573.037-002Y20173704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable upon conviction under Sections 573.037, 558.002 and 558.011, RSMo, in that on or between April 1, 2018 and October 7, 2018, in the County of Jackson, State of Missouri, the defendant knowingly possessed child pornography that was a visual depiction of a person less than eighteen years of age engaged in sexually explicit conduct, consisting of a still image, 4379b2a05e00d61b646b3f033b29, of vagina.

State vs. Matthew P. Fryer

The range of punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count V. Possession Of Child Pornography - 1st Offense (573.037-002Y20173704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable upon conviction under Sections 573.037, 558.002 and 558.011, RSMo, in that on or between April 1, 2018 and October 7, 2018, in the County of Jackson, State of Missouri, the defendant knowingly possessed child pornography that was a visual depiction of a person less than eighteen years of age engaged in sexually explicit conduct, consisting of a still image, 9e719202d5d2112cdf6b28bebeb3506c, of vagina.

The range of punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.
