

STATEMENT OF PROBABLE CAUSE

I **Martin Kreissler** a police officer with the Blue Springs Police Department knowing that false statements on this form punishable by law, state that the facts contained herein are true.

1.) I have probable cause to believe during September 2005 through March 2009 at [REDACTED] N.W. Camelot Place, Blue Springs, Jackson County, Missouri, a **Victor Robert Libeer, a white male, date of birth 10/20/1954, [REDACTED]**, committed one or more criminal offenses.

2.) That the facts supporting this belief are as follows:

On 02/05/2013, the Grain Valley Missouri Police Department received information on a victim who was a resident of their city, [REDACTED] (DOB: 9/25/1995) who had been sexually assaulted by **Victor R. Libeer**, the victim's father. Grain Valley Missouri Police Detective Anthony Vigliaturo discovered the victim had a child on 2/05/2013, and the victim's father Victor Libeer was encouraging the victim to give the child up for adoption via the "Light House Adoption Service" based out of Kansas City, Missouri. The specific concern was that the victim would have been 16 years old at the time of conception. The victim denied at the time that Victor Libeer was the father of the victim's newborn child.

On 02/06/2013, Victor Libeer spoke briefly with Detective Vigliaturo and denied he was the child's father. Victor Libeer also immediately declined to provide a "DNA" sample to confirm he was not the child's father. Victor Libeer denied the allegation that he ever molested or had sexual contact with the victim. Detective Vigliaturo learned the victim was going to keep the child and the victim and Victor Libeer were going to move back to Eureka Springs, Arkansas.

On 02/07/2013, the victim spoke with Detective Vigliaturo about the "DNA" testing and other things Detective Vigliaturo wanted to do as part of his investigation. During this time the victim told Detective Vigliaturo the victim and the victim's father smoked marijuana together all the time. The victim said there were times they smoked so much the victim "passed out." The victim did not believe the victim's father would "hurt" the victim while the victim was passed out but feels it was "possible" the victim's father took "advantage" of the victim being unconscious.

On 2/07/2013, Detective Vigliaturo asked Victor Libeer again if he would allow him to take a "DNA" sample and Victor Libeer said he knew it made him look guilty but he was not going to give Detective Vigliaturo a sample. Detective Vigliaturo served Victor Libeer with a Jackson County Missouri Family Court Order taking both the victim and the victim's infant child into "Protective Custody."

On 5/13/2014, [REDACTED], adoptive mother of the victim, reported to the Blue Springs Missouri Police Department that she had learned that the victim had disclosed to a therapist that Victor Libeer had been sexually assaulting the victim for years and the victim's child who was born in February 2013, was Victor Libeer's child.

On 5/27/2014, the victim was interviewed by Blue Springs Missouri Police Detective Martin Kreissler. The victim told Detective Kreissler from the time the victim was 4 1/2 years old until the victim was 13 years old, the victim, the victim's father, Victor Libeer, and the victim's adoptive mother, [REDACTED] lived at 2 [REDACTED] N.W. Camelot Place in Blue Springs, Jackson County, Missouri. The victim said when the victim was 10 years old, in late November, the victim's father Victor Libeer brought out a "little green rubber vibrator that fits on your finger" and told the victim to put it on the victim's "index finger." Victor Libeer told the victim to take victim's panties off and put the vibrator on the victim's "clitoris" which the victim did. The victim said another name for the clitoris was "private" which the victim uses for "sex" and to "pee" with. The victim continued to use the vibrator until Victor Libeer told the victim to "stop."

The victim told Detective Kreissler when the victim was 11 years old in the "summer time" and still living on Camelot in Blue Springs, the victim's father Victor Libeer took the victim upstairs to the spare bedroom where he told the victim to take off the victim's clothes. Victor Libeer then played a video in a VCR via a TV of "girls and guys having sex" which the victim watched. Once the victim's clothes were off, the victim's father pulled out a condom and put it on his penis which the victim described as "long, hard, and standing up." Victor Libeer told the victim to lie down on the bed and spread the victim's legs. The victim said the victim's father "slammed into me" with his "penis" going "in and out" for about 2 minutes. When the victim's father pulled his penis out of the victim the condom was "bloody" and had "white liquid" in the tip of the condom. The victim's father gave the victim a "woman's douche" and told the victim to "stick" it in the victim's "hole and squeeze the bottle." The victim went to the bathroom and followed the victim's father's instruction.

The victim told Detective Kreissler a couple of weeks later Victor Libeer "raped" the victim again telling the victim if the victim "loved him" the victim "would do it for him." The victim said the victim's father would say the same thing every time this happened. The victim said while living at the Camelot address in Blue Springs, Missouri between the ages of 12-13 years old, the victim's father Victor Libeer raped the victim 12 times.

The facts contained herein are true. False statements made herein are punishable by law.
