The facts supporting this belief are as follows:

This case is being submitted for the following: 15-61297 - Sodomy, Kidnapping, Robbery, Sexual Assault 15-67866 — Rape, Sodomy, Kidnapping, Robbery

On 08/29/2015 at approximately 0338 hours, a twenty-two year old female victim reported to Kansas City, Missouri police officers that she had been sodomized by an unknown black male suspect. The victims advised officers that at approximately 0130 hours she was in Westport. The victim and one of her friends went to Town Topic located at 2021 Broadway St., Kansas City, Jackson County, Missouri, and the victim decided to walk home. She stated the suspect approached her in a vehicle and asked her if she knew where a hookah bar was located. The victim stated she told him no and kept walking. As she walked some more, the suspect reappeared in the same vehicle, and he kept asking her if she needed a ride. After several offers she finally accepted a ride from the suspect in the vehicle. The victim stated the suspect drove her to the Liberty Memorial 100 W. 26th St., Kansas City, Jackson County, Missouri and told her that he was not going to rape her but that he just wanted some "head" (referring to oral sex). The victim stated she ran away and the suspect came behind her on foot and tackled her. The victim stated the suspect told her that he had a gun and out of fear she went back to the vehicle with the suspect and performed oral sex on him at his request. The victim stated the suspect made her remove her bra and shirt so he could fondle her breasts while she gave him oral sex. The victim stated she told the suspect that she dropped something out of the car and the suspect gave her the "ok" to retrieve it. The victim stated when she opened the door, she got out and ran. The victim stated as she was running away she fell and got back up and continued to run for help. The victim stated she observed a cab driver in the area and that is who she flagged down for help. The victim stated a cab driver gave her a ride to a nearby location where the police were contacted. The victim described the suspect vehicle as an orange or red newer Suzuki SUV. The victim later advised that she believed the suspect may have recorded the offense on his cell phone. The victim left her purse behind in the suspect's vehicle which contained her debit card with the last four digits being 4253. She reported that her debit card had been used on 08/29/2015 at 0347 hours for \$40 at a Quik Trip in Roeland Park, KS and on 08/29/2015 at 0411 hours for \$70.62 at a Walmart in Overland Park, Kansas.

On 09/09/2015 detectives responded to the Quik Trip where the victim's debit card was fraudulently used. Surveillance video was obtained from Quik Trip as well as the transaction report for that debit card use. The video showed a younger black or Hispanic male matching the description given by the victim driving a red or orange SUV.

Detectives also reviewed the video obtained from the Walmart which showed the same male attempting to buy a dark in color BB gun pistol and an LG headset. The male was unable to purchase the BB gun.

On 09/22/2015 at approximately 0035 hours, a twenty-five year old female victim reported to Kansas City, Missouri police officers that she had just been raped and robbed by an unknown black male suspect. During the victim's formal statement, she stated she had gotten off of work on 9/21/2015 from Port Fonda located at 4141 Pennsylvania. Kansas City, Jackson County, Missouri at approximately 2330 hours and responded to her vehicle. The suspect, whom the victim has never seen before, was at her driver's side window as she was getting ready to leave. She rolled her window down because the suspect was gesturing to talk to her. He told her he was not familiar with the area and had gotten separated from a group of friends he had been with earlier in the night. The suspect asked the victim for a ride to his vehicle which he stated was parked off of 39th Street. The victim agreed, and the suspect got into the victim's vehicle. He directed the victim to where his car was allegedly parked but then told her he believed his friends were at another location so she drove him there, and eventually to Ali Baba Hookah Lounge at 3421 Broadway Kansas City, Jackson County, Missouri. The victim took the suspect to the back side of Ali Baba which was just south of 34th St. & Central St., Kansas City, Jackson County, Missouri, and she parked the vehicle facing south. The victim wanted the suspect to exit her vehicle so that she could be on her way to meet her friends, and the suspect leaned in to hug her. She asked him to let go, but he asked her to give him "head" (referring to performing oral sex on him). The victim told him no and asked him to get out of her vehicle repeatedly. The victim stated the suspect would not release his grip from hugging her and she began trying to push him away. The suspect then pulled out a gun and put it to the victim's head. She told the suspect he could take her money, credit cards, or car but to leave her alone. The suspect held the gun in the victim's face and said. "Don't make me hurt you....Just do what I say....Don't try anything stupid....Take off your shirt". She took off her shirt, and he told her to take off her top, so she took her bra off. He told the victim to perform oral on him, and he pulled his pants down. He was grabbing her head, forcing it down, while he still had the gun in his other hand. The suspect then told the victim he was going to have sex with her and told her to take off the rest of her clothing which complied. The suspect had the victim drive where there were less people and directed her into an area that led to what the victim believed was a parking garage which was later identified as 336 W. 36th St., Kansas City, Jackson County, Missouri. She stated she refused to drive her vehicle into there, so the suspect put the gun to her head and told her to do what he said. She drove her vehicle into that area where the suspect had her park, turn her lights off, and told her to get out of the vehicle. The suspect led the victim to an area he leaned against the wall and had the victim perform oral sex on him. He asked her to get his phone out of his pocket for him which she did. He then began videotaping the victim as she performed oral sex on him, and the victim believed he used an iPhone 6. The suspect then had the victim get up, turn around, and he vaginally penetrated her from behind with his penis. He then had the victim turn around and perform oral sex on him again until he ejaculated. The victim stated the suspect had the gun in his hand the entire time except briefly during vaginal penetration. He told her to get back into the car so she could drop him off. The suspect directed the victim to the east parking lot area of the Sun Fresh located at 4001 Mill St., Kansas City, Jackson County, Missouri. Once in the parking lot, the suspect took the victim's money (approximately \$259). The suspect then left the victim's vehicle towards Pennsylvania Ave. The victim called 911. The victim advised officers of the suspect's description and stated the suspect had blood in the right side of his right eye as if it had been recently injured.

On 09/22/2015 an informational bulletin was electronically disseminated to Kansas City, Missouri police officers with the detailed suspect description to include the bloody right eye regarding the incident from 09/22/2015. On 09/23/2015 an informational bulletin was electronically disseminated to Kansas City, Missouri police officers with the snapshot from the Quik Trip surveillance showing the suspect's face and vehicle regarding the incident from 08/29/2015. The purpose of both bulletins was an attempt to identify the suspect from the offenses. The detectives investigating both of the aforementioned cases believed the suspect to possibly be the same due to the suspect descriptions given by the victims.

On 09/25/2015 officers working in an "off-duty" role in the Westport Entertainment District had received the information from the bulletins and an attempt to identify the suspect. On 09/26/2015 at approximately 0100 hours, an officer working a gated area at Westport and Broadway checked a patron's ID card in order to make sure that he was of legal drinking age. That officer observed the patron to look like the subject from the information given regarding the possible suspect. The patron was later identified as Damonte Likins-Osbey, B/M, 09/08/1994. He was denied entry due to his license being expired. Officers noted that Likins-Osbey also had blood settled in his right eye on the right side of his pupil. Likins-Osbey gave officers the number of 913-593-7050 as being his phone number. A Facebook search of 913-593-7050 resulted with a Facebook profile for "Damonte Osbey". Officers followed Likins-Osbey to a vehicle where he was observed driving a Maroon Suzuki Vitara (SUV) with tinted windows and bearing a Kansas temporary tag of A910846. The profile picture for "Damonte Osbey" appears to that of Likins-Osbey.

On 09/28/2015 detectives met with each aforementioned victim separately to show a photo lineup which contained six black males all similar in appearance with Likins-Osbey in the #5 position. Each victim positively identified the suspect as being Likins-Osbey.

On 10/02/2015 a court order was signed by Jackson County Judge Dale Youngs. The court order authorized the cellular phone company to provide subscriber information and historical data on 913-593-7050 cellular records from Sprint. After reviewing the records, Sprint Subscriber Information showed 913-593-7050 to belong to Demonte Likins-Osbey with the equipment history showing a iPhone 6P. It was further discovered in the Call Records for 913-593-7050 that on 09/21/2015 at 23:40:01, 913-593-7050 received a phone call from the victim's cell phone as the victim had described.

Laboratory analysis is pending in both investigations.
