"Yes, you did." could not provide additional detail in regard to what On 02-05-2013, participated in a forensic interview at the Child Protection Center. disclosed told him that Minor called her into the bedroom and kissed her on the mouth. Minor touched her butt on the skin. On 08-18-2013, I responded to 1300 Cherry in regard to the captioned incident. At Jackson County Detention, I made contact with the suspect, Daviune C. Minor. Minor read aloud the Miranda Warning and Waiver Form 340 PD. Minor advised he understood his rights, agreed to talk with me, and signed the Waiver. I then completed the Detective Investigation Report on Minor. Minor advised he met in March of 2012 at church. Minor advised he and than 90 days. Minor advised if the children were in the residence, he was never alone with them. Minor denied being sexually inappropriate or physically abusive towards or Minor believed he had a good



was on the floor and Minor had put his private part in her butt, and that he "started to do it really hard". Another
incident occurred where said Minor was "wild" and that "he did it even harder". When Minor put his private
part in her butt "pee came out" and it was "orange yellow". wiped the "pee" off of her butt with a tissue, and
then she "threw up". said when Minor puts his "d-i-k-e" in her butt it makes her cry. was scared to tell
anybody because Minor told her if she told, he was going to hurt her.

On 07-14-14, I responded to Jackson County Detention Center and contacted Minor. Minor was read his Miranda Rights out loud, acknowledged he understood these rights and wished to speak to a lawyer at approximately 1555 hours.

On 06-04-2014 at 0238 hours, a twenty-five year old female victim reported to Kansas City Missouri Police that she was raped/physically assaulted by an acquaintance, Daviune C. Minor B/M 05/12/1985, at 4510 Lister Avenue, Kansas City, Jackson County, Missouri.

The victim stated she had met Minor (who she knew as "Luchi") on a social website "Plenty of Fish.com" several weeks prior. The victim stated on 06-03-2014 she drove with her children and niece to Independence, Missouri to pick up Minor. The victim stated she drove her children, niece and Minor back to the listed address of 4510 Lister to have consensual sex with Minor about 1830 hours. The victim stated after sex with Minor, she left the children at the listed residence to go with Minor to purchase more alcohol. The victim stated she returned and that her eleven-year old niece stated that Minor had rubbed her vagina and buttocks over her clothing earlier in the day. The victim stated Minor became extremely intoxicated about 2100 hours and she told him to leave her residence. The victim stated Minor "snapped" and drug her by her hair to the bedroom. The victim stated Minor forced his penis inside her vagina two separate times possibly between 2200 hours and 0000 hours. The victim stated Minor did not wear a condom and was unsure if he ejaculated. The victim stated she and the kids ran out of the residence to call police. The victim responded to Research Medical Center to have a Sane Exam completed. The victim declined entry into her residence by law enforcement for the collection of evidence.

On 07-11-2014 the victim was shown a photographic line-up of Minor and five males similar in appearance. The victim positively identified Minor as the suspect that assaulted her.

On 07-14-2014, Minor was contacted in the Jackson County Missouri Detention Center. Minor was read his Miranda Rights out loud, understood his right and wished to speak an attorney at 1555 hours. Minor was released back to Detention Unit Personnel.

On 06-04-2014, officers with the Kansas City Missouri Police Department responded to Research Medical
Center in regard to the rape of a 25-year-old female. stated she had met a male named "Devon", whom
she had brought back to her residence, located at 4510 LISTER, KANSAS CITY, JACKSON COUNTY,
MISSOURI, and they had consensual sex. Afterwards, she observed "Devon" in the living room playing with
her three children and her cousin, an 11-year-old female. It stated at later disclosed that "Devon" had
touched her "butt" and vagina, over the clothes. stated she confronted "Devon" and he then beat and raped
her. The rape was documented on CRN #14-038269. stated "Devon" also goes by the name of "Lucci."
