I have probable cause to believe that on 3/2009 - 3/2010, at 10500 E. 42nd St in (Date) (Address)

Kansas City, Jackson Missouri James P. Dodd (County) (Name of Offender(s))

B/M 12/28/82; committed one or more criminal offense(s). (Description of Identity)

The facts supporting this belief are as follows:

Child Molestation
Furnishing pornography to a minor

On 03/23/16 members of the Kansas City Police Department were dispatched to a Kansas City, MO residence where contact was made with KJK, the mother of the 13-year-old female victim, [redacted] The victim disclosed to her that during 2009 while at 10500 E. 42nd ST, Kansas City, Jackson County, MO, the suspect, James P. Dodd B/M 12/28/82, sexually molested the victim on numerous occasions. At the time of the offense Dodd had been in a relationship with the victim's aunt. KJK was presented a photographic line-up which included a photo of Dodd, and she positively identified Dodd as the offender.

Through the Jackson County Children's Division a possible secondary sexual assault victim of Dodd, [redacted] a 15-year-old male and cousin of [redacted] was identified.

Both [redacted] and [redacted] were forensically interviewed by the Child Protection Center. During [redacted] interview she stated that when she was 7-years-old Dodd, the father of her cousin, molested her on three separate occasions. The first occasion occurred when her cousin went into the bathroom at which time Dodd began to touch her chest and her "private part", and then attempted to put his hand inside her pants though he was unsuccessful. The second occasion occurred while her cousins were watching TV. Dodd made her sit on his lap while both their pants were down. There was no penetration; however, when [redacted] got up she felt something wet. On the last occasion she asked Dodd for something to eat and was told by him that she could not have anything unless she "stroked (his) penis". Dodd showed her what he wanted her to do and then put her hand on his exposed penis.

[redacted] stated that Dodd is the father of his brothers and that his cousin, [redacted] disclosed having been sexually molested by Dodd. [redacted] then disclosed that Dodd made him and [redacted] do "adult type stuff". Dodd made [redacted] pull [redacted] pants down and touch her private part and butt with his hands. Dodd continued to make them touch each other until they were caught in 2013 by [redacted]. [redacted] also indicated that Dodd showed him pictures of [redacted] vagina and has shown him pornographic movies.

On 06/09/16 Dodd was taken into custody. He was advised of his Miranda Rights which he waived and agreed to provide a statement. Dodd denied the allegations.
