The facts supporting this belief are as fol	llows:				

On 03/11/2017, officers of the Kansas City, Missouri Police Department responded to 2401 Gillham Rd, Children's Mercy Hospital, to contact a five year old victim of an alleged Sodomy. The victim disclosed that the suspect, "Forty", had touched her "coon," the term she uses to describe her vagina.

On 05/18/2017, the victim participated in a forensic interview where she disclosed "Forty" touched her. "Forty" took her clothes off and used his "pee thing" to touch her "coon". She stated his "pee thing" touched inside her "coon" and it hurt. On an anatomically correct drawing of a boy, the victim identified "pee thing" as the penis. On an anatomically correct drawing of a girl, the victim identified "coon" as the vagina. The victim further disclosed that when she was four years old the suspect put his "pee thing" inside her butt and it hurt. She disclosed the suspect also kissed her on her lips, stomach, back and nipples. These incidents occurred at her aunt's house, 6 Chestnut Ave, Kansas City, Jackson County, Missouri, when she was four and/or five years old.

The victim's aunt, Witness #1 was interviewed by detectives and stated in early March of 2017, the victim disclosed to her that she and "Forty" do "nasty stuff". The witness requested clarification from the victim and she stated, "You know like adult nasty stuff; 'Forty' put his 'thing thing' in my coon and it hurt". The witness then phoned the victim's parents who responded to her address and took her to the hospital. Witness #1 identified the suspect, "Forty", as Eric V. McMillon B/M 12-02-1975, her fiancée and cohabitant of three years.

On 08/18/2017, detectives were received a phone call from MCMILLON who stated he was transporting vehicles to Georgia, refused to give an address where he was living, and stated he was moving to Georgia. He advised he would "work his way back to Kansas City" to contact detectives but declined to provide a date and time this might occur. Detectives have not heard from MCMILLON since this contact.
