# COMPLAINT WARRANT REQUESTED

# Count I. Statutory Sodomy 2nd Degree (566.064-001Y19951199.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with the legislation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with the county of Jackson and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

### Count II. Attempted Statutory Rape 2nd Degree (566.034-001Y19951198.1)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 564.011, RSMo, committed the class D felony of attempted statutory rape in the second degree, punishable

upon conviction under Sections 564.011,558.011 and 560.011, RSMo, in that on or between November 1, 2003, and May 13, 2004, in the County of Jackson, State of Missouri, the defendant placed his genitals agains genitals, and such conduct was a substantial step toward the commission of the crime of the statutory rape of genitals, who was less than seventeen years old and the defendant was twenty-one years of age or older, and was done for the purpose of committing such statutory rape in the second degree.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

# **Count III. Child Molestation 2nd Degree (566.068-002Y19953601.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.068, RSMo, committed the class A misdemeanor of child molestation in the second degree punishable upon conviction under Sections 558.011 and 560.016, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant subjected who was then less than seventeen years old to sexual contact by touching the breasts with the defendant's hands.

The range of punishment for a class A misdemeanor is imprisonment in the county jail or other authorized penal institution for a term not to exceed one (1) year; by a fine not to exceed one thousand dollars (\$1,000); or by both imprisonment and a fine.

### Count IV. Statutory Sodomy 2nd Degree (566.064-001Y19951199.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with \_\_\_\_\_\_. by placing the defendant's mouth on \_\_\_\_\_\_\_genitals and at that time \_\_\_\_\_\_\_. was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

# Count V. Statutory Sodomy 2nd Degree (566.064-001Y19951199.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with the county of Jackson, State of Missouri, and at that time was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

# Count VI. Statutory Rape 2nd Degree (566.034-001Y19951198.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.034, RSMo, committed the class C felony of statutory rape in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had sexual intercourse with at that time was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

#### Count VII. Statutory Sodomy 2nd Degree (566.064-001Y19951199.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with by placing the defendant's mouth on genitals and at that time was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to

exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

# **Count VIII. Statutory Sodomy 2nd Degree (566.064-001Y19951199.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.064, RSMo, committed the class C felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or between November 1, 2003 and May 13, 2004, in the County of Jackson, State of Missouri, the defendant had deviate sexual intercourse with the by inserting his finger intercourse and at that time that was less than seventeen years old and the defendant was twenty-one years of age or older.

The range punishment for a class C felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years not to exceed seven (7) years; by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

J. Crump, knowing that false statements on this form are punishable by law, state that the facts contained herein are true. 1. I have probable cause to believe that Joshua D. Hood, on 2003-2004, at Various locations within Jackson County, Missouri, committed the offense(s) listed below: 566.064 Statutory Sodomy, Second Degree Felony Statutory Rape, Second Degree Felony 566.034 Child Molestation, Second Degree Misdemeanor 566.068 2. State the facts that support a finding of probable cause to believe crime(s) was/were committed and that the accused committed the crime(s): 1) On April 21, 2020, I was directed to conduct an investigation pertaining to sex offenses that occurred at various locations in Jackson County, Missouri, between the fall of 2003 and the spring of 2004. 2) alleged Joshua D. Hood engaged in sexual intercourse and deviate sexual intercourse with her from the fall of 2003, until the spring of 2004, when was less than seventeen (17) years of age. Hood was twentysix (26) and twenty-seven (27) during that timeframe. During that timeframe, Hood was a teacher and coach at Holden High School, located in Holden, Missouri, and Land. was a student at Holden High School. Hood taught in the Holden School District during the 2003 - 2004 school year. He subsequently acquired a teaching position at another school district the next year. 3) Investigation into \_\_\_\_\_.'s claims revealed on several occasions Hood and \_\_\_\_\_. met at multiple locations in Lee's Summit, Missouri, for sexual intercourse and sexual acts. Because of the amount of elapsed time since the relationship. I. stated she could not recall specific dates; however, but she was certain they occurred before her 17th birthday, which was in May 2004. stated her sexual relationship with Hood ended shortly after the end of the 2003-2004 school year. The sexual encounters occurred at the following identified locations: a) A residence located at 1200 Northeast Bryant Circle, Lee's Summit, Missouri and alleged she and Hood were in a hot tub inside the residence in December 2003. stated this was the first occurance of her sexual relations with Hood. She stated Hood began kissing her and fondling her breasts. the hot tub, Hood began using his hands and fingers to rub her vagina and stated he wished to "teach her how to orgasm.' I. stated Hood had her lie on the floor and he attempted to insert his fully-erect penis into her vagina several times, but it was too large for her vagina at that time and the experience was very painful. She stated, "It didn't go in, but he was pushing, trying to get it in." A later conversation with Hood's father revealed he did have a hot tub inside his residence at 1200 Northeast Bryant Circle around that time period.

Hood's penetration of her anus was always painful and unwelcomed, but she did not tell him to stop because she was scared to.				
c) A residence located at 1226 Southeast 8th Street, Lee's Summit, Missouri stated this was Hood's apartment where they had vaginal sex on multiple occasions. She stated Hood also performed cunnilingus on her and digitally-penetrated her anus at this location.				
4) Corroborating information was gathered through interviews of multiple sources familiar with Hood. On August 10, 2020, investigators interviewed Hood at the Kansas City, Missouri, Police Department's North Patrol Division Headquarters. Hood admitted he knew during his employment at Holden High School, while she was a student, and she had been to his residence in Lee's Summit. He repeatedly stated his life and career were over if he admitted to having sex with a student. However, Hood admitted kissing and digitally-penetrating either her vagina or anus.				
5) When investigators asked Hood if it was a lie he had a sexual encounter with, he replied, "No." Hood stated he could not recall how old
