COMPLAINT
WARRANT REQUESTED

Count I. Rape Or Attempted Rape - 1st Degree - Aggravated Sexual Offense (566.030-002Y20201101.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.030, RSMo, committed the **offense of rape in the first degree**, punishable upon conviction under Section 566.030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about January 9, 2021, in the County of Jackson, State of Missouri, the defendant knowingly had sexual intercourse with ██████. by the use of forcible compulsion and in the course of the offense, the defendant displayed a deadly weapon in a threatening manner.

The offense of rape in the first degree or an attempt to commit rape in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years, unless the offense is an aggravated sexual offense, in which case the authorized term of imprisonment is life imprisonment or a term of years not less than fifteen years. An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

State vs. Jamen L. Jackson

Count II. Armed Criminal Action (571.015-001Y20205203.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of armed criminal action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about January 9, 2021, in the County of Jackson, State of Missouri, the defendant committed the felony of Rape in the First Degree charged in Count I, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Rape in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.1, RSMo. is imprisonment by the department of corrections for a term of not less than three years and not to exceed fifteen years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term of not less than five years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three calendar years. Any punishment imposed pursuant to section 571.015 RSMo. shall be in addition to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. The punishment imposed pursuant to Section 571.015, RSMo shall be in addition to and consecutive to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon.

Count III. Possession Of Child Pornography - 1st Offense (573.037-002Y20203704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable under Sections 573.037 and 558.011 RSMo, in that on or about January 15, 2021, in the County of Jackson, State of Missouri, the defendant, knowingly possessed child pornography of a person less than eighteen years of age, consisting of an image of a male placing his penis in the genitals of an infant female child who appears to be wearing a diaper, in a file named zhwQhQAA, and the child pornography consisted of a single image.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

State vs. Jamen L. Jackson

Count IV. Possession Of Child Pornography - 1st Offense (573.037-002Y20203704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable under Sections 573.037 and 558.011 RSMo, in that on or about January 15, 2021, in the County of Jackson, State of Missouri, the defendant, knowingly possessed child pornography of a person less than eighteen years of age, consisting of an image of a male placing his penis in the genitals of an infant female child, in a file named y5oUICLT, and the child pornography consisted of a single image.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count V. Possession Of Child Pornography - 1st Offense (573.037-002Y20203704.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 573.037, RSMo, committed the class D felony of possession of child pornography, punishable under Sections 573.037 and 558.011 RSMo, in that on or about January 15, 2021, in the County of Jackson, State of Missouri, the defendant, knowingly possessed child pornography of a person less than eighteen years of age, consisting of an image of a male placing his penis in the mouth of a prepubescent female child, in a file named ys5iQKTR, and the child pornography consisted of a single image.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

PROBABLE CAUSE STATEMENT

Date: 1/15/2021

I, Steve Breshears, a Detective with the Independence, Missouri, Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on 1/9/2021, at 2100 Hours, JAMEN L. JACKSON, (Race- B, Sex- M, DOB- 10/15/1997, Address-5121 NW Kalivas Dr Riverside, MO 64150, [REDACTED], committed one or more criminal offenses in Jackson County, Missouri.

2. The facts supporting this belief are as follows:

On 01/10/21 at 0211 hours, Officer Ford responded to [REDACTED] regarding a sexual offense that had just occurred.

Upon arrival, Officer Ford contacted the victim, [REDACTED] reported two months prior she had met online and been communicating with Facebook and SnapChat a male subject she thought was named "Jaymen Myyear Johnson", later identified as defendant JAMEN L. JACKSON. [REDACTED] reported she only ever communicated with Mr. Jackson online and had not met him in person prior to 1/9/21. [REDACTED] said she invited Mr. Jackson to her home, and he arrived around 2100 hours on 01/09/21. [REDACTED] reported Mr. Jackson sent her photos of the outside of her apartment complex before coming to contact her. She also reported Mr. Jackson had asked her if she lived alone. [REDACTED] said her intention was for the visit with Mr. Jackson to be strictly platonic. When Mr. Jackson arrived, [REDACTED] opened the door and allowed him inside. This was the first time [REDACTED] had seen Mr. Jackson in person.

Once inside, [REDACTED] said Mr. Jackson immediately displayed a handgun. [REDACTED] reported the handgun appeared to have a silver top and a black bottom. [REDACTED] reported the gun was a Glock-style gun. [REDACTED] said Mr. Jackson pointed the gun at her head and told her to perform oral sex on him. While she did so, he recorded her with his phone. When asked if she remembered any specific things Mr. Jackson said, [REDACTED] reported he had told her to moan, suck on him, and look at the camera. [REDACTED] reported Mr. Jackson had pulled aggressively on her hair and said, "You are gonna do this." [REDACTED] reported she repeatedly asked Mr. Jackson why he was doing this to her, telling him that she had done nothing wrong to him. [REDACTED] reported that at one point, Mr. Jackson removed the magazine from the handgun to show her that it was loaded. After performing oral sex, Mr. Jackson instructed [REDACTED] to engage in vaginal sex with him. She reported he did penetrate her, but she did not believe Mr. Jackson ejaculated.

[REDACTED] reported Mr. Jackson then got into her purse, opened her wallet, and stole \$250 cash. Mr. Jackson then left the apartment and [REDACTED] immediately called 911. [REDACTED] identified a cup of water that Mr. Jackson had while in the apartment. She also pointed out a wallet she said Mr. Jackson had left at the apartment. The wallet did not have anything in it to identify Mr. Jackson. [REDACTED] reported she had gone to the bathroom since the assault took place. She said the clothing on the floor at the foot of her bed is what she was wearing when Mr. Jackson arrived, and she had put on the clothes she had now since the assault. [REDACTED] identified her bed as where the assault took place, stating it occurred on top of the top blanket.

On 1/10/21 Detective Breshears contacted [REDACTED] in the emergency room at Centerpoint Hospital. [REDACTED] reiterated the rape and sexual assault she previously reported to Officer Ford. [REDACTED] showed Detective Breshears the Facebook page of "Jaymen Myyear Johnson" which contained several high-quality color images all the same person. [REDACTED] said the person in the photographs was indeed the person that had raped her at gunpoint inside her residence. She said the gun he held during the sexual assault was solid black and he hid a second gun with a silver slide and a black frame on her desk. She found the second gun when he used the bathroom after the assault. She said she didn't know anything about guns and left it there and he took it when he left.

[REDACTED] said Mr. Jackson used his iPhone to video record the sex acts and gave her directions regarding how to act during the recordings such as moaning and smiling. [REDACTED] said she was scared Mr. Jackson was going to kill her if she did not comply.

Detective Breshears used the Facebook images along with investigative resources that revealed Department of Revenue photographs and pedigree information to identify JAMEN L. JACKSON. Mr. Jackson was the person depicted in the "Jaymen Myyear Johnson" Facebook profile.

On 1/14/21 Detective Breshears read aloud and Mr. Jackson followed along and read his Miranda warning of rights. Mr. Jackson signed the rights waiver and said he wanted to discuss the case.

Mr. Jackson said he had consensual oral sex and vaginal sex with [REDACTED] on 1/9/21 after they both agreed to meet at her apartment using their Snap Chat applications. Mr. Jackson said [REDACTED] wanted his help starting an Only Fans pornography website and asked him to video record the sex acts. He said he did, in fact, video the sex acts on his personal iPhone XR SN: FFWZJ2RGKXKR. Mr. Jackson said he did not pull a gun or point a gun at [REDACTED]

On 01/15/21, Detective Burris conducted a consent search of Mr. Jackson's iPhone XR after he signed a consent to search form. The search of the iPhone XR was conducted via Cellebrite UFED4PC. Upon initial review, Detective Burris located more than five videos which depict [REDACTED] performing oral sex in some and in others engaged in vaginal sex with a male light complexion black male or Hispanic male. Detectives Breshears and Burris reviewed the videos, specifically one of [REDACTED] in the process of performing oral sex on the male subject in the video, [REDACTED] appears scared in her facial expression and her left eye can be seen watering and a tear falling, when the male whose voice was consistent with Mr. Jackson's asked her to look up so he could see her tongue. In a review of all the videos that apparently involve [REDACTED], no firearm is seen, however [REDACTED]'s mannerism and response on video do not appear through the investigators training or experience to be that of someone engaged in consensual sex acts.

Detective Burris also located several images of child pornography on Mr. Jackson's iPhone XR. While this is not an all-encompassing, more than 10 images of children (boys and girls) under the age of 18 years old, some appearing to be prepubescent females were in various sexual acts to include oral sex and vaginal sex. In one image, a male's penis can be seen inserting into a girl's vagina, who appears to have a diaper around her waist. In that image the female also appears to be a prepubescent female. Three thumbnail images were also located describing the content with the below written titles:
