# AMENDED COMPLAINT WARRANT REQUESTED

## Count I. Tampering With A Judicial Officer (575.095-001Y20205006.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 575.095, RSMo, committed the class D felony of tampering with a judicial officer, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about April 25, 2021, in the County of Jackson, State of Missouri, with the purpose to harass, intimidate or influence a judicial officer in the performance of such official duties the defendant, threatened to cause harm to a Judge of the 16th Judicial Circuit Court of Jackson County Missouri.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.
