

PROBABLE CAUSE STATEMENT

I, Scott McKee, a Detective with the Independence, Missouri, Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on past dates prior to 2016, at several unknown times, Jesus Torres, (Race- White, Sex- Male, DOB- 11/14/1969, Address-3815 Euclid, Kansas City, MO, [REDACTED] committed one or more criminal offenses in Jackson County, Missouri.

2. The facts supporting this belief are as follows:

On 10/11/2016 the reporting party contacted Independence Missouri Police Officer Paul Campbell and reported a past Sex Offense that occurred at 11507 E 14th St, Independence, MO, 64050. The reporting party stated that 13 year old victim #1, [REDACTED] born 09/12/2003 disclosed being sexually abused by Jesus "Chuy" Torres, W/M, 11/14/1969 (the Defendant). During the investigation Detective McKee determined that there were three more victims that were alleging that the defendant had sexually assaulted them as well; Victim #2 [REDACTED] born 05/26/2006, Victim #3 [REDACTED] born 12/17/2008 and Victim #4 [REDACTED] born 11/17/2007. All four of the victim's were referred to the Child Protection Center where forensic interviews were completed.

Victim #1 disclosed being inappropriately touched more than one time by the defendant. Victim #1 said every night the defendant would come into victim #1's bedroom and make a pallet on the floor next to the bed and sleep. Victim #1 recalled the first time something inappropriate occurred was when victim #1 was seven (7) years old. The defendant took victim #1 to the bed and took his pants off. He pulled victim #1's pants down and touched victim #1's "area." The victim disclosed that the defendant forced victim #1's legs open and touched victim #1's "area." Victim #1 disclosed being 11 years old when another incident occurred. The defendant came into victim #1's room and made a pallet on the floor with an "eagle blanket". Victim #1 was asleep when the defendant woke victim #1 up as he was putting his finger in victim #1's "area." Victim #1 disclosed being 12 years old when the defendant came into the room and made a pallet on the floor with the "eagle blanket" next to the bed. The defendant stuck his finger in victim #1's "area" and moved it up and down. Victim #1 disclosed that the last time this happened the defendant made a pallet next to the bed with a red sheet. The victim remembered wearing "Eeyore" pajama shorts and a shirt. Victim #1 disclosed that the defendant pulled victim #1's shorts down and underwear to the side. He had inserted his finger in victim #1's "area" and moved it back and forth. Victim #1 said the defendant had also touched and grabbed victim #1's "boobs" and put his mouth on victim #1's "boobs" more than one time. Victim #1 also disclosed seeing the defendant touch victim #2 inappropriately. Victim #1 saw the defendant drinking alcohol and then he picked up victim #1 and victim #2 and carried them into victim #1's bedroom. After the defendant covered all three of them with the "eagle blanket" the defendant used his thumb to touch victim #1's "area." Victim #1 looked under the blanket and saw the defendant touching victim #2's "area" with his thumb. Victim #1 disclosed that on one occasion the defendant took his "area" out of his pants and started to rub it up and down after calling for victim #1. He continued rubbing his "area" until "white stuff" came out. The victim disclosed that the defendant made victim #1 watch "Porn Hub" which was grownups doing "the nasty." While watching "Porn Hub" the defendant would touch and rub victim #1's "stuff."

Victim #2 disclosed staying the night with victim #1 in 2016. Victim #2 disclosed that the defendant put a blanket over himself, victim #1 and victim #2. The blanket was described as being black or brown with lion with hair on it. Victim #2 said the defendant took them to victim #1's room. The defendant grabbed the both of them "right here." On an anatomically correct drawing victim #2 identified "right here" as the genitals. Victim #2 said the defendant then took them back to the living room couch. The defendant sat in the middle of them and told them he would give them some "dollars." The defendant then put his hand inside victim #2's pants and touched victim #2 "right here" or the part victim #2 uses to "pee." Victim #2 said the defendant used his hand to touch the inside of victim #2's "right here." Victim #2 said the defendant's other hand was on victim #1's

“right here” area. Victim #2 said the defendant put his hands inside their shirts and touched the skin of their “boobies.” On an anatomically correct drawing victim #2 identified the “boobies” as breasts. Victim #2 also disclosed the defendant made both victims go back to the living room couch where he made them watch a “nasty movie.” The movie was described as pornography. The defendant was completely naked and got on top of victim #2 and put his “ding dong” on victim #2’s “stuff”. Victim #2’s legs were spread apart but victim #2 was wearing clothes. The defendant stopped and then did the same thing to victim #1.

Victim #3 denied being touched by the defendant. Victim #3 disclosed witnessing the defendant touching victim #1 and victim #2 under and over the clothes.

Victim #4 disclosed that the defendant has touched victim #4’s “area” more than once and does it every night that victim #4 spends the night over there. Victim #4 disclosed being 8 years old the first time it happened and that it happened at victim #1’s house. Victim #4 disclosed being woke up to the defendant putting his hands in victim #4’s pants touching victim #4’s “area.” Victim #4 disclosed seeing the defendant touch victim #1’s body more than one time including witnessing the defendant touching victim #1 while victim #1 was asleep.

On 03/30/2017 a formal statement was obtained from the defendant after he was advised of his Miranda Rights. The defendant denied all the allegations that have been made against him. He stated the families involved had made up the allegations and brainwashed the victim’s telling them what to say because none of them liked him. The defendant stated he did drink alcohol and has used marijuana and methamphetamines in the past. The defendant also admitted to masturbating and if one of the victims’s witnessed it, it was not done intentionally.
