Aggravated Assault

The facts supporting this belief are as follows:

On 03/30/2020 at approximately 1020 hours, Officers of the Kansas City Missouri Police Department were notified by the KCATA that a shooting occurred on a metro bus at **Independence Avenue and Olive Avenue, Kansas City, Jackson County, Missouri**. Officers responded to the scene and located the victim, [REDACTED] on metro bus #4003 suffering from a gunshot wound to the right side of his back, near the shoulder blade. The male was transported to a local hospital for treatment with life threatening injuries.

[REDACTED] stated the following: He was at the bus stop near the Price Chopper on Independence Avenue. [REDACTED] clarified the area as around Hardesty Avenue, near a gas station and car wash. He observed a male, whom he knows as **LARRY HARRIS**, walk up to the bus stop and the two began to have a verbal altercation. [REDACTED] got onto a metro bus and left the area to avoid further confrontation. As the bus stopped at Independence Avenue and Olive Street, [REDACTED] stated he was shot by **HARRIS**, whom was outside of the bus on the sidewalk.

[REDACTED] stated the following: [REDACTED] was waiting for the bus at the bus stop located at Independence Avenue and Wilson Road. She observed [REDACTED] and the suspect, who she later identified as **LARRY J. HARRIS B/M 02/02/1969**, arguing at the bus stop. She identified **HARRIS** from a photographic line-up that was developed after obtaining the physical description of the suspect from victim and witnesses. As the bus arrived at the bus stop at Independence Avenue and Olive Street, she observed **HARRIS** shoot through an open window on the bus, striking [REDACTED] in the back.

On 04/07/2020 hours, detectives and officers were conducting surveillance on HARRIS's residence of 305 Barat Avenue. Harris exited the residence and entered a silver Honda Accord at the location. Officers contacted Harris and took him into custody. Harris was then transported to a police facility for questioning, detectives read Harris his Miranda Rights in which he declined to speak to detectives.

On or around 12-22-1992 he was found guilty of Assault in the 1st Degree through the Jackson County Circuit Court CRN# 49200299400. On or around 05-23-2001 he was found guilty of a Domestic Assault Misdemeanor through the Jackson County Circuit Court CRN# 16CR01002455. On or around 03-05-2007 he was found guilty of Assault in the 1st Degree and Armed Criminal Action through the Jackson County Circuit Court CRN# 0516CR0228501.
