The facts supporting this belief are as follows:

Victim 1 (V1) reported to officers she and Victim 2 (V2) had been repeatedly raped and sodomized by Turner, Stephen D., w/m, 09-02-65. V1 disclosed offenses that occurred throughout her childhood, while living at [redacted] Kansas City, [redacted] Independence, [redacted] Independence. All three addresses are in Jackson County, Missouri. V1 stated Turner began having sexual contact with her when she was approximately 4 years old. Over the course of the following 14 years, Turner had oral, anal and vaginal sex with V1. V1 further stated she remembered Turner showing her pornographic photos, providing her alcohol and taking nude pictures of her.

V1 stated the first incident she could recall was at the age of 4. V1 stated Turner had put her and V2 to bed and he began caressing V1's stomach, chest and her vaginal area under her pants, but over her underwear. V1 pretended to be asleep. This incident occurred while the family was living in Springfield, Missouri. V1 next recalled a time when she was in kindergarten, while living in the house at [redacted] when Turner was alone with V1 and took her to his room. Turner pulled a "dirty magazine" from a briefcase, showed it to V1 and asked her to do what was in the picture. V1 described the picture as "someone doing oral things". On this occasion, Turner exposed his penis to V1 and forced her to touch it. V1 performed oral sex on Turner at that time. Turner repeated this behavior on several occasions, always showing V1 the same page of the same magazine. On one occasion, around this same time period, Turner performed oral sex on V1, but V1 "freaked out and started crying and kicking" so he stopped. V1 recalled an incident, around Christmas of an unknown year, when Turner sat on the couch by the Christmas tree, opened his robe and had V1 perform oral sex on him.

V1 stated she moved to [REDACTED] when she was approximately in the 3rd grade. **Turner** regularly took her to the basement where she performed oral sex on him. It was at this location, when V1 was approximately 9-10 years old, **Turner** first asked had anal sex with V1. **Turner** bent V1 over a desk, held on to her back and penetrated her anus. **Turner** then used a vibrator on V1 to make her "feel sensations" and make it "easier to penetrate". V1 recalled occasions in the basement when she held on to the basement stairs, **Turner** used baby oil to aid with anal penetration, he kissed on her ears and breasts to attempt to arouse her, and digitally penetrated her vagina.

V1 recalled a time when she was in 4th or 5th grade, still on [REDACTED] when **Turner** sent the other kids outside and locked the door. They were in the living room and V1 observed **Turner** to have vaginal intercourse with V2, then had vaginal intercourse with V1, and then had V1 perform sexual acts on V2. V1 observed **Turner** having vaginal sex with V2 on several occasions. Around this time frame **Turner** began providing V1 with alcohol, which she described as Jack Daniels shots.

When V1 was approximately in the 6th grade, she moved to [REDACTED] V1 recalled the first night in the house and Victim 3 (V3) stayed the night. V1, W1 and **Turner** were in the hot tub and **Turner** gave V1 and W1 alcohol. **Turner** dared W1 to kiss him with her tongue. W1 refused and got out of the hot tub.

W1 was interviewed and stated she and V1 were playing truth or dare in the hot tub. **Turner** provided the girls with a bottle of wine or champagne and he started to play truth or dare. **Turner** dared W1 to sit on his lap, which she did. **Turner** dared W1 to kiss him and she kissed him on the cheek. **Turner** said "no I want you to kiss me on the lips" at which time W1 got up and walked out the hot tub. W1 stated she was approximately fourteen or fifteen at the time. V1 stated beginning around 7th grade **Turner** began giving her alcohol on a regular basis. On one occasion **Turner** provided V1 with marijuana, that he hid in the film compartment of an old camera. That was a onetime occurrence.

In the 7th grade, V1 was helping **Turner** do work in the basement of the [REDACTED] address. **Turner** forced her onto a futon and had forceful vaginal intercourse with her. V1 stated it was very painful and she bled in the underwear she was wearing. V1 said she hid the underwear because she did not want anyone to find them and later held on to them as possible proof. The panties were sent to the Kansas City, Missouri Regional Crime Lab for analysis. Semen and blood was identified in the crotch of the panties. V1 provided a buccal swab DNA standard which matched the blood DNA found in the crotch of the panties. Forensic Specialists stated the blood DNA from the panties appeared to be "breaking down", which was consistent with the sample being old. The sample was sent to the Missouri State Highway Patrol Crime Lab for additional analysis. A partial Y haplotype was developed. It was determined neither **Turner** nor males from a common paternal lineage could be eliminated as the source of the haplotype.

A few days later, **Turner** sex with V1 again in the basement of the house.

The first time V1 recalls **Turner** fully inserting his penis into her anus was in the shed located in the backyard of the [REDACTED] house. **Turner** bent her over the weight bench, used his own spit to lubricate his penis and forcefully inserted it into her anus. V1 said it was very painful and she fought, trying to get him to stop. **Turner** did this several times over the next month.

At the age of 16, V1 became pregnant with **Turner's** baby and **Turner** took her to have an abortion. Approximately 1-1 ½ weeks after the abortion, **Turner** began having vaginal sex is V1 again and she recalled bleeding more than usual. After the sexual abuse resumed, **Turner** began being physically violent toward V1.

V1 recalled one event when **Turner** was choking her, around the neck, so hard a cross pendant she was wearing left an imprint on her neck. On one occasion V1 called **Turner** a rapist. **Turner** locked the door and wouldn't let her leave. **Turner** held a sword to V1's throat. V1 said the handle of the knife (referring to the previously mentioned sword) broke trying to keep it from her throat. On several occasions **Turner** held a gun to his own head and threatened to shoot himself in order to get V1 to comply with his sexual demands.

One evening when **Turner** came to V1's basement bedroom, he tried to have intercourse with her. She attempted to resist and he grabbed her by the throat and face, leaving cuts on the inside of her mouth, finger bruises on her face and threw her onto the bed hard enough to cause the frame to bend. V1 stated variations of this event occurred on an almost nightly basis. One occasion occurred in back in the shed. She was intoxicated and attempted to climb the ladder to the second story and jump out the window. **Turner** was able to grab her leg and pull her back down before having vaginal sex with her. During this incident, V1 obtained a wound to her inner leg during the struggle to get out the window. V1 recalled 2-3 occasions when **Turner** choked her to the point of passing out. V1 stated **Turner** would often use razorblades on her and tell her she needed to have a stronger mind, what he called "mind power".

V1 stated **Turner** took photos of her "all the time", calling them "photo shoots". The first occasion he took sexual pictures of V1 was taken while living at the [REDACTED] address, between 3rd and 6th grade. The picture was of V1, nude, sitting on a desk in the basement. V1 stated the photo shoots would begin with her fully clothed, changing clothes, taking her shirt off, then the rest of her clothing. As she got older and was living at the [REDACTED] address, it was common for **Turner** to provide her alcohol during these photo shoots to help her relax.

V1 stated on one occasion, while living at the [REDACTED] address, **Turner** took a video of V1 performing oral sex on him. V1 went on to detail small scars located on the underside of **Turner's** penis and stated he almost always shaves his pubic hair. A search warrant was executed on **Turner's** person which revealed **Turner's** pubic hair to be shaved and a scar similar in appearance as described by V1.

V2 was interviewed and stated **Turner** began living with her family when she was age two and continued until 2007. V2 has no memory of a time when she was not having sexual contact with **Turner** and has no memory of every "being a virgin". When asked about specific times or incident, she stated it was unclear because it was just normal for her. She grew up thinking it was normal to have sex with **Turner** because that was what she had always done and she had always known V1 was doing it also. She described it as "routine".

She said her first memory was at the [REDACTED] address. V2 was asleep when **Turner** woke her up, took her to the couch and taught her to perform oral sex.

V2 lived on [REDACTED] from approximately 1st-5th grade. It was while living on [REDACTED] **Turner** first started showing her pornography. V2 stated it was often still photos on the computer and they were used as examples of what she was supposed to do with him. She remembers there being lots of oral sex while living on [REDACTED] and being taken to the basement approximately once a week to perform oral sex on **Turner**. It was while living here **Turner** first asked V2 if she wanted to try penetration. It became a regular occurrence for **Turner** to have vaginal sex with V2 in the living room while her mother was away at work. He would often take her to the basement to have vaginal sex with her and this occurred on a weekly basis. V2 remembered sometime between the 1st-3rd grade **Turner** made her wear only a robe, sit on the couch in the living room and **Turner** performed oral sex on V2.

V2 lived on Stayton from approximately 5th-9th grade and said most abuse occurred at this address. It was at this address he began providing her shots of Crown Royal and at this address was the first time he had anal sex with her. He would regularly make her go to the shed in the back yard of the address to give him oral sex or make her bend over the desk for vaginal sex. She was often made to perform oral sex on **Turner** in the basement bedroom. V2 recalled an incident in an upstairs bedroom where **Turner** laid on his back, on the floor while V2 was on top of him having vaginal sex. He was lying in a way his head was slightly protruding into the hallway so he could see if anyone was coming. On one occasion, **Turner** took V2 to the garage of the residence and made her bend over a workbench for the purpose of having vaginal sex with her.

She recalled him putting a live-feed camera in the downstairs bathroom so he could watch V1 and V2. V2 recalled a time shortly after moving in when he came to her downstairs bedroom to perform anal sex on her, but when he began she screamed in pain. He clamped his hand over her mouth and he stopped. On another occasion she witnessed **Turner** perform oral sex on V1 at the same time V1 performed oral sex on **Turner**. V2 recalled an incident where V1 and V2 performed oral sex on **Turner** while in the "Jacuzzi" behind the Stayton house. V2 recalled having to hold her breath while being underwater performing oral sex so she would not be seen. At one point, when V2 was in 5th-7th grade, V1, V2 and **Turner** were in V1's bedroom together. V1 was performing oral sex on **Turner** while V2 was performing oral sex on V1.

V2 talked of an occasion when she was in the 6th or 7th grade when **Turner** asked V3 to take a nap with him and V2. **Turner** had previously instructed V2 to show V3 how to do a "hand job". When they went to bed **Turner** pretended to be asleep and V2 showed V3 what to do. V2 stated V3 gave **Turner** "hand jobs" on multiple occasions. If V3 got bored or walked away, **Turner** would make V2 "finish him" with her hands or with oral sex. V2 said **Turner** would often bribe V3 with alcohol to keep her coming back over. V2 noted alcohol was very common with **Turner** and he often provided it to her and her friends. This event was repeated on a regular basis on the floor of the shed or at **Turner's** "shop" located at [REDACTED] **Blue Springs, Jackson County.**

V2 stated **Turner** often took "modeling" photos of her. He had made her diet and would take photos of her in a brown, two-piece swimsuit to "track" her progress. V2 stated **Turner** showed her pornographic material "all the time", most commonly as an example of an act he would then ask her to perform with him.

V2 described a scar on the underside of **Turner's** penis. She said it was used as a "point of reference" on how far he would penetrate her or where she was supposed to perform oral sex.

V3 was interviewed and stated the first sexual contact with **Turner** was in 2005, when she was about 13 years old. It occurred on the floor of the shed at 4300 Stayton or on the floor of **Turner's** business office located at, an unknown address in Blue Springs, Jackson County, Missouri. It was at 4300 Stayton **Turner** first suggested V3 take a nap with him and V2. After **Turner** "fell asleep" V3 witnessed V2 perform oral sex on **Turner**. Taking naps with **Turner** and V2 became a weekly event. **Turner** would always pretend to be sleeping, but would begin touching V2 and V4's bodies. She stated he touched her breast and vaginal area, initially above the clothes, but progressed to under the clothes and underwear. At one time **Turner** tried to digitally penetrate her vagina, but it was uncomfortable so he stopped. Over the many naps they had, she began manually masturbating **Turner** and V3 and V2 both performed oral sex on him several times. They would take turns performing oral sex when the other one would get tired. Several times she saw **Turner** ejaculate during the process. V3 recalled one instance in which **Turner** positioned her vagina over his face and **Turner** performed oral sex on her. Many times after one of these events, **Turner** would provide the girls

\$100 each or take them shopping. It was never specifically stated that it was for the sexual acts, but she said she began to wonder if she was a prostitute.

V3 remembered a time when the lights were out looking up and seeing a camera, which she described as a handheld video camera, sitting nearby with a red light on. She believed it was recording. It was dark so she was unsure what it could see them, but could definitely hear what was going on.

Around the same time the sexual contact began between V3 and **Turner**, **Turner** began providing V2 and V3 with alcohol and showing them pornography on a regular basis. She recalled times when **Turner** would be in just his robe with no clothes underneath. He would turn on pornography and sit on the couch. He would sometimes position his legs in a way his genitals were partially exposed and then appear to fall asleep. **Turner** never threatened V4, but did tell her not to tell anyone and "nothing leaves this circle". She said she knows **Turner** always carries a gun on his person and owns many others.

V4 recalled multiple incidents that occurred during the summer of 2003, when she would have been 14-15 years old. She would regularly visit V1 at the home on Stayton. On one evening, **Turner** gave V1 and V4 "Zima" and they played Truth or Dare. **Turner** dared V1 and V4 to kiss. When they just "pecked", he told the girls he wanted "tongue action" and did not want to play "baby Truth or Dare". He wanted to play Adult Truth or Dare or they could go back down with the little kids. V1 dared **Turner** to lick V5's "boob". V4 lifted up her shirt and **Turner** began sucking on V5's left boob. V4 said she wanted to "get back" at V1 and dared **Turner** to do the same thing to V1. V1 lifted up her shirt and **Turner** licked V1's nipple.

She recalled a different evening when **Turner** had provided them alcohol. V4 and V1 became very intoxicated so **Turner** was trying to sober them up by making them sandwiches. V4 recalls several occasions when they had been drinking alcohol and **Turner** would kiss her and "shoved his tongue down her throat." **Turner** would make V4 promise not to tell anyone or he would get in trouble and they wouldn't be able to have fun anymore.

On a different evening V5, V1 and **Turner** were all in the hot tub, smoking and drinking. **Turner** was rubbing V5's leg when a younger sibling of V1 came out to get in the hot tub. The pre-arranged deal was if anyone ever came outside or downstairs, they were to quickly hand their drinks and cigarettes to **Turner**. When the younger sibling saw **Turner** with multiple cigarettes and questioned it, **Turner** said he was trying to show the girls he could smoke 3 cigarettes at one time.
