
## Probable Cause Statement Form



not 100% sure, "it looks like him" and did not look like the other 5 subjects in the photo line-up. added she has seen photographs of Andre Williams, however, never saw him in person prior to witnessing him stab Latoya Brown.

stated she was not a witness, however, was a friend of Latoya Brown's and said Latoya Brown's ex-boyfriend was named Andre Williams.

Friday showed Officer Vanbibber Andre Williams' Facebook profile "Andre Williams" (profile ID# 100057319201392) and believed he resided in Grandview, Missouri. Kesha Friday said the Facebook profile picture of "Andre Williams" which was posted 07-25-2022 was in fact a picture of Latoya Brown's ex-boyfriend Andre Williams. Comparison with the Facebook profile picture and Andre Williams Missouri Department of Revenue state identification photo showed them to be the same Andre Williams.

also provided Detective Speakman with Andre Williams' phone number, 816-490-9740. Additionally, a records check of the phone number 816-490-9740 through the T.L.O. database revealed it belonged to Andre Williams.

While performing an area canvass of the crime scene, Detective Speakman and Detective Jeffery located 3 fixed blade knives: 1 large wide silver metal knife with a black handle and blood spots on the handle next to scattered items around the gray 2012 Mitsubishi Outlander and blood spatters on the ground, 1 shorter thinner "Ambrosi" brand silver metal knife with a black handle next to that knife with blood spots on the blade, and 1 other "Ambrosi" brand silver metal knife with a black handle nearby across the street in a construction site ditch.

Sergeant Wise reviewed recorded video surveillance from the nearby Minit Mart; it showed a dark blue GMC S.U.V equipped with a large chrome and black aftermarket front push bumper occupied by a black male driver in a gray shirt at the Minit Mart on 08-04-2022 at approximately 1852 hours.

After examining Facebook profile "Andre Williams" (profile ID# 100057319201392), that Facebook profile was on the Facebook friends list of "Andre Williams" (profile ID# 100051492875601), whose profile picture which was posted 10-27-2020 also showed to be the same Andre Williams. Additionally, both "Andre Williams" Facebook profiles were on the Facebook friends list of another "Andre Williams" (profile ID# 100057307321980), whose profile picture which was posted 07-25-2022 also showed to be the same Andre Williams. This "Andre Williams" Facebook profile also had a picture dated 11-02-2020 showing Andre Williams standing in front of what appeared to be a dark blue GMC S.U.V. with a large aftermarket black and chrome push bumper covering the vehicle's grill.

After reviewing recorded video surveillance from the nearby Minit Mart and comparing it to the dark blue GMC S.U.V. on "Andre Williams" Facebook (profile ID# 100057307321980), it appeared to be the same vehicle with the same aftermarket bumper.

On 08-05-2022, Captain Beitling was informed Andre Williams jumped off a bridge in Kansas City, Missouri. Detectives Jackson and Nelson responded to Truman Hospital located at 2301 Holmes Street, Kansas City, Missouri 64108 where Andre Williams was on suicide watch and receiving treatment for pneumonia after having jumped from the Broadway Bridge located at

Broadway and I35 in Kansas City, Jackson County Missouri, just shortly after the stabbing; he was taken into Police custody at 1203 hours.

Kansas City Police Department's report #KC22052327 was obtained; it stated on 08-04-2022 at approximately 1942 hours, Andre Williams parked unknown vehicle that was supposedly registered to him on the shoulder of the bridge at interstate 35 and Broadway in Kansas City, Missouri. Officer Kelloff observed Andre Williams unresponsive in a body of water near the bridge. Kansas City Fire Department performed a boat rescue of Andre Williams and transported him to Truman Hospital.

A records check of Andre Williams through the Department of Revenue revealed he had a 1997 GMC S.U.V. (VIN#3GKFK16R2VG525116) bearing Missouri license VF6 W7C actively registered to him.

On 08-05-2022, Jackson County Medical Examiner's Officer performed an autopsy of Latoya Brown; a preliminary diagnoses revealed Latoya Brown died as a result of multiple stab wounds, 2 in particular to her left lung and liver.

On 08-05-2022, a dark blue GMC S.U.V., registered to Andre Williams, with a Missouri license of VF6 W7C, was located where Andre Williams had jumped off the Broadway Bridge in Kansas City. The vehicle was located on the shoulder of the Bridge. A search warrant was obtained for the GMC S.U.V. While executing the search warrant, Detective Jeffery located apparent blood on the GMC's interior center console and on the left arm rest of the front passenger seat.

A records check of Andre Williams criminal history revealed he was on federal supervised release for distribution of cocaine and illegal possession of firearm(s) in connection with drug trafficking, as well as federal weapons offenses, distribution of controlled substance, unlawful use of a weapon, and domestic assault.
