He used his tongue to lick inside and outside of her vagina and anus. When she told him no, he ball up his fists like he was going to punch her. She thought he was going to kill her.	
was transported from the scene to CMH via ambulance, and during the ambulance ride, she gave addition information. Stated the following: She was alone with (Suspect), <b>Bomani Madu</b> , who gather alcohol and marijuana, which was laced with something. She was in her bedroom when <b>Bomani</b> came in with his "thing" out. She yelled at him and he left. He came back in with his "thing" put away. He demanded that she take her clothes off, and when she said no, he raised his fist as if he was going to hit her. He pulled his shirt off over her head and began licking her nipples. She was on the phone with her friends so she yelled for help and to have someone call her grandmother. She further stated that <b>Bomani</b> licked her vagina and butt.	ave ed
