On 2/17/2021 at approximately 1354 hours, members of the Kansas City Missouri Police Department were dispatched on a shooting at 1900 W. Pennway Terrace, Kansas City, Jackson County, Missouri, 64108. Upon arrival, officers located two deceased adults inside the single family home (**Khasheme Strother B/F 10-27-1985 and Raymon Hill B/M 10-01-01**). Officers contacted an adult who had been shot in the leg. The living adult male with apparent gunshot wounds reportedly called 911 and advised he had shot the individuals within the residence. The reporting injured male also reportedly resides at the property with the two deceased adults. The injured male was transported to an area hospital for medical treatment. The 911 audio recording indicates the injured male is claiming he shot the adult male (son of the deceased adult female) in self- defense and stated he shot his girlfriend (deceased) in the chest accidentally after they "jumped" him.

An officer who was traveling with the injured male (**Dmarius M Bozeman B/M**, **06-24-1988**) to the hospital communicated with the officer (captured on the officer body camera) the event was captured on surveillance video at the residence and the video footage is accessible via his cell phone, and his cell phone is still within the residence. **Bozeman** was observed to have trauma to his body; however was able to exit the reisdence under his own power and while being escorted from the front of the residence after being taken into custody to a KCFD-EMS ambulance parked approximately 4-5 townhouses from the residence.

Several juveniles were identified as living at and being inside the residence prior to, during, and after the events (KT 06-14-2008, JS 01-30-2006, KS 07-26-2004). While the statements slightly vary they had the following facts in regard to this investigation. The juveniles stated the female victim Khasheme Strother and Bozeman were in the downstairs area of the townhouse while they were all upstairs between the bathroom, and the two juveniles bedrooms. The juveniles advised they all went downstairs to check on Khasheme Strother and observed Bozeman on top of the victim in the laundry room adjacent to the kitchen area. The juveniles advised Khasheme Strother was telling Bozeman to get off of her and let her go. The juveniles stated they attempted to intervene on Khasheme Strother behalf and one advised Bozeman has had incidents of violence

in the past with Khasheme Strother and the police have been at the residence and have arrested Bozeman in regard. The juveniles advised Bozeman got off Khasheme Strother and advised he would "fight" or "kill all of them" and they all began to physically fight one another in the kitchen area. They stated no one was armed with anything and no weapons were used during the physical altercation with Bozeman. The juveniles advised Bozeman told them he was done and wanted to get his belongings and his keys from upstairs so he could leave. Bozeman went upstairs and Khasheme Strother began to follow him upstairs, Two (one juvenile and the male victim-Raymon Hill B/M, 10-01-2001) went back upstairs to the room located south of the master bedroom and the others began to climb the stairwell to the upstairs when they heard gunshots from the area of the master bedroom. The juveniles on the stairwell ran down the stairs to the first level and exited the residence through the west rear door. RH and the juvenile, who were upstairs, exited their room and observed Khasheme Strother lying on the floor near the bannister outside the master bedoom. The two carried Khasheme Strother down the stairs and placed her in the floor inside the front door and when they looked back toward the upstairs observed Bozeman waving a gun around pointing it in their direction. The two then ran outside the west rear door and met with the other juveniles. Raymon Hill had his firearm and went back into the residence with one of the juveniles following. Raymon Hill walked into the living room and out of sight of the juvenile who was following Raymon Hill. The juvenile stated he observed Bozeman standing near Khasheme Strother and then heard "too many shots" back and forth inside the residence. This juvenile advised the shooting stopped and he did not observe where Bozeman went inside the residence. This juvenile stated as he went into the living room where the second shots occurred he observed Raymon Hill lying on the floor on the south side of the living room. This juvenile observed Raymon Hill's firearm lying next to his head and he was still unable to locate Bozeman in the residence. This juvenile stated he walked back outside the west rear door and dropped Raymon Hill's firearm on the ground. All the juveniles ran to 1800 W Pennway Terrace and 911 was contacted.

On 02/18/2021 Detectives responded to Truman medical Center and contacted Bozeman. Bozeman was read his Miranda Rights and he agreed to speak with detectives. Bozeman stated he got into a physical altercation with his girlfriend who he identified as Khasheme Strother. Bozeman stated Strother had shoved him and he attempted to restrain her against the wall. According to Bozeman, Strother continued to scratch at his face and kick him. Bozeman stated he proceeded to take Strother to the ground trying to restrain her from striking him. Bozeman stated Strother continued to try and kick him and he attempted to strike Strother but he missed. Bozeman let Strother up and she tried to assault to him again, and bit his arm. Bozeman stated he grabbed Strother and poked her in the eye with his thumb. **Bozeman** stated the other family members in the residence then proceeded to strike Bozeman and their altercation ended. According to Bozeman, he went upstairs to change clothes that had been ripped and to leave when he stated everyone attempted to go after him in the bedroom. Bozeman stated he grabbed his Glock .40 caliber in his right hand and fired what he believed was two warning shots. Bozeman stated he proceeded to his son's bedroom and he observed his two sons (Raymon and Keandre) hiding in the closet. Bozeman believed his oldest son had a firearm since he had previously found ammunition. Bozeman stated as he entered the room he was struck with a mirror that was on the dresser by Raymon. Bozeman left the room and observed Strother on the ground. Bozeman stated he saw that Strother had a hole in her chest and tried to call the Police. Bozeman stated he observed Strother now down the stairs, and he went downstairs and tried to render aid to Strother. Bozeman stated he told Raymon to call the police, and Bozeman observed Raymon run out of the back of the residence. According to Bozeman, Raymon came back inside the residence through the back door and he started shooting at Bozeman while he was on the ground with Strother. Bozeman stated he fired back and proceeded to do so while going back upstairs.

**Bozeman** stated he went into the master bedroom and attempted to find more ammunition and call the Police **Bozeman** took his gun apart and left the gun on the bed.

According to the Jackson County Medical Examiner's findings Khasheme Strother had a graze wound to the lower abdomen and a perforating gunshot wound of her right upper arm. She also had a perforating gunshot wound to the left breast, and two other perforating gunshot wounds to the chest. The Cause of Death listed is Multiple Gunshot Wounds and the Manner listed is Homicide.
