The facts supporting this belief are as follows:

On 07/15/2020, responded to the Metro Patrol Division station to report sexual abuse of her 5 year old
disclosed to that Gustavo Ramos had been taking to the back room at his residence at
1 Hardesty Ave, Kansas City, Jackson County, Missouri and touching also
disclosed he put his penis on and under clothing. stated didn't say anything because
"didn't want to get in trouble."

On 07/29/2020, participated in a forensic interview and disclosed touches
private parts. sleeps downstairs on the big bed that is bouncy with and he touches
private parts. said private part is used to pee and pointed to area. said other private
part is used for going poop. disclosed he touches private part with his private part. demonstrated
what happens when he touches private part with his private part by moving pelvic area back and forth.
said it hurts and feels good when touches it with his private parts. said sometimes lays
down and sometimes lays on s tummy when he touches private part. said he takes off all
clothes and underwear. said, "Whenever I say that's enough, he stops and puts my clothes back
on," and "my heart doesn't really like it and I say stop."

On 11/09/2020, grandmother, provided a statement. She said on 07/03/2020, she was babysitting
and noticed was touching after a bath. asked why was touching and
said because it made feel good. then disclosed to that would touch "part" and would
put his "part" on "part." asked if had talked to mother about it and said hadn't
because didn't want to get in trouble.

On 11/09/2020, s mother, provided a statement. She said she was informed by that had
disclosed being touched on "part" by Gustavo Ramos. later asked if was touching
private parts. told her that he would touch private parts and demonstrated on y touching

herself on [redacted] and rubbed back and forth. [redacted] asked [redacted] what else happened and [redacted] said he would put his private on [redacted] private and move back and forth. [redacted] demonstrated by moving [redacted] hips back and forth. [redacted] said it happened in the basement where [redacted] lived. [redacted] said she noticed Gustavo Ramos wanting to spend more time with [redacted] and wanted [redacted] to spend the night more often. She also noticed he was buying [redacted] more things than usual. [redacted] stated she noticed sexualized behavior from [redacted] during showers and at bedtime. [redacted] stated Gustavo Ramos received visitation on 07/19/2017 through Wyandotte County. Gustavo Ramos had visitation on Wednesdays, every other Friday and weekends. [redacted] stated she had concerns for sexual abuse and made a call to KS DFS on 11/17/2017. [redacted] said when [redacted] returned from a visit with Gustavo Ramos, [redacted] wouldn't "open [redacted] legs" to allow [redacted] to change [redacted], which [redacted] hadn't done before. [redacted] stated Gustavo Ramos told her started living at 10 [redacted] Ave in December of 2019. It should be noted Gustavo Ramos listed 1 [redacted] Ave as his address in a police report on 09/22/2019.

[redacted] responded to an area hospital for a SANE exam. It should be noted, male DNA was detected on [redacted] anal verge swab.

Gustavo Ramos was unable to be located for a statement or to provide a DNA sample for comparison to the male DNA detected on [redacted] anal verge swab.
