WARRANT REQUESTED

Count I. Rape Or Attempted Rape - 1st Degree (566.030-001Y20201198.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.030, RSMo, committed the offense of rape in the first degree, punishable upon conviction under Section 566.030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about January 9, 2023, in the County of Jackson, State of Missouri, the defendant knowingly had sexual intercourse with [REDACTED] by the use of forcible compulsion.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served. The offense of rape in the first degree or an attempt to commit rape in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years.

Count II. Sodomy Or Attempted Sodomy - 1st Degree (566.060-001Y20201113.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.060, RSMo, committed the felony of sodomy in the first degree, punishable upon conviction under Section 566.060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about January 9, 2023, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant knowingly had

deviate sexual intercourse with [REDACTED] by touching [REDACTED]'s mouth with defendant's penis, by the use of forcible compulsion

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served. The offense of sodomy in the first degree or an attempt to commit sodomy in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

I, Detective Mark Hermelink, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

I have probable cause to believe that on 01-09-23 at 6518 E. 128th Ter. Grandview, Jackson County, Missouri, Deonte' T. Watson b/m 04-07-1991 committed one or more criminal offenses.

On 01/09/23 at 1407 hours, Officer Anderson was dispatched to [REDACTED] Grandview, Jackson County, MO. in regard to a rape.

Upon arrival Officer Anderson contacted [REDACTED] b/f [REDACTED] who was standing in the living room of [REDACTED] residence crying. [REDACTED] was holding a pole in [REDACTED] hands and [REDACTED] appeared scared. Officer Anderson asked [REDACTED] if the suspect was still inside the residence and [REDACTED] stated that [REDACTED] last seen him driving away in a copper color unknown pick-up truck. [REDACTED] advised that Deonte' Watson b/m 04/07/91 lived at 5520 Michigan in KCMO and [REDACTED] was not sure if he was in route to the address.

[REDACTED] stated that on 01/09/23 at approximately 1300 hours, Watson arrived at [REDACTED] residence to take his portable A/C unit that [REDACTED] borrowed from him. [REDACTED] stated that he took the A/C unit and carried it back down and loaded it into the rear of his pick-up truck. [REDACTED] stated that after loading the A/C unit into his truck he came back in and asked [REDACTED] if he could use [REDACTED] restroom and that he wanted to talk about their friendship. [REDACTED] stated that [REDACTED] had known Watson since [REDACTED] was 14 years old and that they were good friends.

[REDACTED] stated that they went upstairs to the second floor of the residence so that he could use the restroom and [REDACTED] was in the living room. [REDACTED] stated that Watson came out of the restroom and into the living room where [REDACTED] was sitting down on the sofa. [REDACTED] stated that Watson appeared calm at first and then nervous. [REDACTED] stated that he started talking about the current relationship that [REDACTED] was in with [REDACTED] new boyfriend and that he even told [REDACTED] that he was happy for [REDACTED]. After that he told [REDACTED] that he was about to leave, but he wanted a hug. [REDACTED] did agree to giving him a hug and [REDACTED] hugged him. While hugging [REDACTED] advised that Watson picked [REDACTED] up, [REDACTED] thought that Watson was playing, Watson forced [REDACTED] face down on to the sofa pinning [REDACTED] onto the sofa. [REDACTED] stated "You're hurting me." "Get off of me." [REDACTED] even stated that at one point when Watson was pushing [REDACTED] face down into the sofa [REDACTED] started not to be able to breath. [REDACTED] stated that Watson let off just enough so [REDACTED] was able to turn [REDACTED] face sideways so that [REDACTED] was able to breath and [REDACTED] screamed for Watson to get off of [REDACTED]. Watson yelled a [REDACTED] "Shut Up!" and pulled a zip tie out, [REDACTED] believed the zip tie came out of Watson's pocket and put is around [REDACTED] wrist. Watson commented how strong [REDACTED] was and placed a second set of zip ties around [REDACTED] wrist and put both arms behind [REDACTED] back.

█ asked Watson if he was going to kill █ and he told █ that he was suicidal and he told █ that he was in love with █ started screaming for help and Watson told █ that every time that █ screamed he would push █'s face down into the sofa harder. █ felt like Watson was going to kill █ and █ cried to him " I'll do whatever you want.

Watson then pulled a black unknown caliber Glock from a holster on his waist and pointed it at █. Watson told █ that he had a dream about how this was going to go all down for the past month. █ stated that Watson took █ to the bottom level of the residence and made █ sit on the sofa down there. He blindfolded █ and while █ eyes were covered █ stated that █ could see a flashing light as if he was taking picture or recording what was taking place. Watson then started talking more about him loving █ and about him being upset about █ not wanting to be with him. Watson then started asking █ y what time █ got home from school. █ told him what time █ be home and he asked █ where was █ garage door opener, because he wanted to disable the garage door so that no one would come into the residence.

Watson then asked █ where █ cell phone was at and he demanded █ to give it to him. While he had █ phone he asked █ how to unlocked █ phone screen and █ stated that █ purposely gave him the wrong numbers, so that he could not unlock █ phone. Watson told █ that he's going to ask █ one more time for the correct password and he was not going to ask again.

█ begged for Watson to loosen the zip ties while still crying. He then laid █ down onto the sofa and took off █ glasses. █ stated that Watson knew that █ was completely blind without █ glasses on. █ then stated that he cut off the zip ties and he put on black restraints around █ wrist and put the blindfold back over █ eyes. █ stated that █ was so scared that █ felt as if █ had to use the restroom and █ told Watson that █ had to use the restroom. Watson walked █ up to the 2nd floor of the residence and stood outside the door and let █ use the toilet and shortly after took █ back to the lower level.

Watson stated " This is what I've always envisioned." "Why didn't you just give it to me." █ started crying "Don't do this to me." Watson then started taking off █ clothing starting with █ and then █ pants. █ told him to stop and he told █ "If you say another word I'm going to smother you." Watson then told █ to open up █ mouth and he started to pull █ closer to the edge of the sofa and closer to him. Watson stated " I don't want to hear you say anything except that you are sorry for not choosing me." Watson kissed █ on the lips.

█ was told to open █ mouth again by Watson, █ could tell that Watson was pulling his pants down by the sound Watson was making, when █ did he stuck his penis in █ mouth and said " Say you're sorry." While his penis was in █'s mouth, Watson got upset, because he felt like █ teeth was scraping the shaft

of his penis. He told [REDACTED] "Stop using your teeth and suck my balls." [REDACTED] stated that when his scrotum was in [REDACTED] mouth he started instructing [REDACTED] on how to pleasure him.

[REDACTED] then stated that Watson pulled his scrotum out of [REDACTED] mouth and started to rub his hands in and around [REDACTED] trying to get [REDACTED] lubricated. He then bent [REDACTED] over and stated "I've been waiting for this for a long time." and inserted his penis into [REDACTED] without a condom on. Watson began instructing [REDACTED] "Say sorry for not loving me." He then sat [REDACTED] back up onto [REDACTED] butt where [REDACTED] was facing him and started sucking and licking [REDACTED]. Watson then told [REDACTED] to open [REDACTED] mouth again and stop crying. He then put his penis into [REDACTED] mouth and forced [REDACTED] to suck Watson's penis. Watson then pushed [REDACTED] back and inserted his penis into [REDACTED] in a [REDACTED]. While Watson was on top of [REDACTED], Watson started telling [REDACTED] "You're going to suck my dick till I cum and then I'm going to fuck you till I cum again." [REDACTED] then stated that while he was raping [REDACTED] he pulled out his phone and started playing music from his play list. Watson then told [REDACTED] that he was about to ejaculate and told [REDACTED] he was going to ejaculate inside [REDACTED]. [REDACTED] cried for him to stop and begged "Please don't" Watson pulled his [REDACTED] f [REDACTED] and ejaculated on [REDACTED] face and chest.

Watson took a towel and started cleaning his seaman off of [REDACTED] face and chest and told [REDACTED] to take a shower. [REDACTED] that [REDACTED] remembered from television that [REDACTED] should not take a shower after a rape and [REDACTED] told him that [REDACTED] was not going to take the shower. Watson then told [REDACTED] that if [REDACTED] won't take the shower then he was going to take [REDACTED] to the shower and clean [REDACTED] off himself. He untied [REDACTED] and started placing [REDACTED] clothing that he took off, the zip ties, and towel into a duffel bag that he brought to [REDACTED] residence.

Watson then took [REDACTED] to the top floor of the residence and told [REDACTED] take a shower and clean all the evidence off of [REDACTED] face and chest. [REDACTED] stated that Watson stood outside the door with it closed until [REDACTED] was done. Watson also told [REDACTED] to take toilet paper and [REDACTED] and then flush the toilet paper down the toilet. [REDACTED] did what Watson told [REDACTED] to do. [REDACTED] then asked Watson if he was going to hurt [REDACTED] and he told [REDACTED] that he was not going to hurt [REDACTED] because he didn't want [REDACTED] to grow up without [REDACTED].

[REDACTED] stated that Watson told [REDACTED] to walk him down to the bottom floor and Watson disabled [REDACTED] cellphone to the point that it was locked and could not be open for up to 4 minutes [REDACTED] raised the garage door and he walked out and then [REDACTED] pushed the button to lower the door [REDACTED] stated that he turned around and looked at [REDACTED] one more time shaking and said "Sorry for doing that." [REDACTED] pushed the button on the garage opener and lowered it. [REDACTED] stated that [REDACTED] was so scared that [REDACTED] ran upstairs before the door even closed all the way went into [REDACTED] office and called [REDACTED] from [REDACTED] tablet and told him to call the police, because [REDACTED] was raped.

Officer Anderson noticed a knife that was lying on the kitchen floor and asked ██████ if the knife belonged to Watson and ██████ stated that it was ██████ knife and that when he cut the zip ties off of ██████ wrist, Watson then whipped the knife off and threw it up to the kitchen to keep it away from ██████.

Det. Hermelink responded to the scene while Officer Anderson was interviewing ██████, Det. Hermelink explained to ██████ that if ██████ was willing to go to the hospital and have sane exam conducted, to make sure not only was ██████ alright, but to collect any evidence that Watson may have left on ██████ body.

Upon arrival to research, the sane exam was conducted and Det. Hermelink collected the examination kit from the sane nurse.

Det. Larkey canvassed the area of 128th Ter. for any cameras, to include doorbell cameras. Det. Larkey located one, the video showed that Watson was leaving the area at around 1401 hours, in a bronze colored Dodge 4 door pick-up truck bearing MO registration 2CA L57.
