Count I. Rape Or Attempted Rape - 1st Degree (566.030-001Y20201198.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.030, RSMo, committed the offense of rape in the first degree, punishable upon conviction under Section 566.030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about January 9, 2023, in the County of Jackson, State of Missouri, the defendant knowingly had sexual intercourse with the section of Jackson in the compulsion.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served. The offense of rape in the first degree or an attempt to commit rape in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years.

Count II. Sodomy Or Attempted Sodomy - 1st Degree (566.060-001Y20201113.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.060, RSMo, committed the felony of sodomy in the first degree, punishable upon conviction under Section 566.060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about January 9, 2023, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant knowingly had

deviate sexual intercourse with by touching s mouth with defendant's penis, by the use of forcible compulsion

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served. The offense of sodomy in the first degree or an attempt to commit sodomy in the first degree is a felony for which the authorized term of imprisonment is life imprisonment or a term of years not less than five years.





Watson appeared calm at first and then nervous. stated that he started talking about the currant relationship that as in with l new boyfriend and that he even told After that he told l that he was about to leave, but he wanted that he was happy for did agree to giving him a hug and hugged him. While hugging advised thought that Watson was playing. Watson forced that Watson picked up, face down on to the sofa pinning onto the sofa. stated "You're hurting me." "Get off of me." even stated that at one point when Watson was pushing started not to be able to breath. down into the sofa stated that Watson let off was able to turn r face sideways so that was able to breath and just enough so screamed for Watson to get off of . Watson yelled a "Shut Up!" and pulled a zip tie out, believed the zip tie came out of Watson's pocket and put is around wrist. Watson commented how strong was and placed a second set of zip ties around wrist and put both arms behind r back.





Officer Anderson noticed a knife that was lying on the kitchen floor and asked if the knife belonged to Watson and stated that it was knife and that when he cut the zip ties off of wrist, Watson then whipped the knife off and threw it up to the kitchen to keep it away from
