

Probable Cause Statement Form

I, Detective B. Jeffery, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

I have probable cause to believe that on or about 10-19-2019, at 10616 E 70th Street, Raytown Missouri, 64133, Jeremy S. Callihan, W/M, 10-03-1986, [REDACTED], committed one or more criminal offense(s).

The facts supporting this belief are as follows:

On 10-19-2019 at approximately 1712 hours, Officer Dustin Christina responded to Raytown Police Headquarters, 10000 E 59th Street, Raytown Missouri, 64133 in regard to a sexual assault.

Upon Officer Christina's arrival, he contacted [REDACTED] who is the mother of the alleged [REDACTED] year old victim, [REDACTED]

[REDACTED] explained that on or about 10-19-2019 at approximately 1200 hours, [REDACTED] informed [REDACTED] grandmother, [REDACTED] that [REDACTED] mother's boyfriend, who was identified by [REDACTED] as, Jeremy S. Callihan, a white male born 10-03-1986, had been teaching [REDACTED] about "private parts." While speaking to [REDACTED] explained that Jeremy Callihan showed [REDACTED] how the "white stuff" comes out, while demonstrating the motion of a male masturbating.

[REDACTED] stated that sometimes the white stuff would dry and that it was ok to eat, advising that [REDACTED] would sometimes put [REDACTED] mouth on Jeremy Callihan's private parts to eat the white stuff. [REDACTED] then explained that Jeremy Callihan puts the white stuff in mom and that he had showed [REDACTED] what [REDACTED] mother's private part looks like, so that [REDACTED] would know [REDACTED]

[REDACTED] stated that on or about 10-19-2019 at approximately 1900 hours, [REDACTED] spoke with Jeremy Callihan inside [REDACTED] Raytown Missouri, 64133 in regard to the [REDACTED] s disclosures. While speaking with Jeremy Callihan, [REDACTED] said that he said "I only talked to [REDACTED] about that earlier in the week, nothing more."

On 12-09-2019 at approximately 1300 hours, I responded to the Child Protection Center, to observe the forensic interview involving [REDACTED]. During the interview, [REDACTED] described an incident that occurred inside [REDACTED] Raytown Missouri, 64133) with who [REDACTED] refers to as [REDACTED] dad, "Spencer," (Jeremy Callihan) although [REDACTED] no longer resides with him because "he showed me a thing he's not supposed to."

While inside Jeremy Callihan's bedroom, [REDACTED] stated that Jeremy Callihan made [REDACTED] take off her clothes, informing her that it was "me and his time because mommy was at work." [REDACTED] stated that [REDACTED] got onto the bed and Jeremy Callihan began rubbing [REDACTED] private part with his finger(s), while he was standing next to the bed with his clothes off [REDACTED] described Jeremy Callihan's finger as "kind of big and the nail was kind of big." It should be noted that [REDACTED] pointed to [REDACTED] area when asked where Jeremy Callihan rubbed [REDACTED] body [REDACTED]. [REDACTED] also advised that she "goes potty" from that area.

While Jeremy Callihan rubbed [REDACTED] private part with his finger, [REDACTED] stated that he "rubbed it almost all the way in," which [REDACTED] described as being "in and in and in." [REDACTED] then stated that Jeremy Callihan hurt [REDACTED] while he was touching [REDACTED] privates, which resulted in [REDACTED] screaming. [REDACTED] described that "he had big nails, so it kind of hurt and he had to clip them." [REDACTED] then explained that Jeremy Callihan went and trimmed his finger nails before returning to the bedroom.

After returning to the bedroom, [REDACTED] stated that Jeremy Callihan informed [REDACTED] that "we won't do anything that you don't want to do." [REDACTED] then stated that Jeremy Callihan showed [REDACTED] his private part which she described as his "skin being a peach color and he has hair on it." It should be noted that [REDACTED] pointed to [REDACTED] area when explaining where Jeremy Callihan's private part was located on his body.

[REDACTED] said that [REDACTED] observed Jeremy Callihan watching a video (pornographic) which displayed people trying to "make the white stuff come out." [REDACTED] stated that while Jeremy Callihan was watching the video, he used his hand to pull his private part.

[REDACTED] then described the "white stuff" which [REDACTED] stated came from Jeremy Callihan's private part. [REDACTED] said that [REDACTED] saw the white stuff coming out from Jeremy Callihan's private part when he was pulling up (masturbating), which ultimately was located on his lower stomach when he was finished. [REDACTED] advised that when the white stuff came out, "it was the good stuff." [REDACTED] ultimately demonstrated an "up and down" motion with [REDACTED] hand when [REDACTED] was describing Jeremy Callihan's actions during the incident.

[REDACTED] described that people (girls) in the video, some of which [REDACTED] said needed help, were "pulling their private part up and down until the white stuff comes out." [REDACTED] also described that the girls in the video had to "pull their legs tight and pull it up and down." [REDACTED] said that she observed Jeremy Callihan, with one hand pulling his private part, doing the things that the people in the video were doing.

[REDACTED] also advised that Jeremy Callihan provided [REDACTED] with his cellular phone, stating "here, you go watch it." [REDACTED] further stated that the white stuff is not too bad for you and some people can drink it. She also stated that Jeremy Callihan told her that she can drink it just like milk. [REDACTED] denied that Jeremy Callihan made [REDACTED] drink the white stuff.

On 08-24-2020 at approximately 1300 hours, I contacted [REDACTED], via phone. While speaking with [REDACTED], she explained that during the incident, she and Jeremy Callihan were [REDACTED] and that [REDACTED]. During their [REDACTED] stated that she and [REDACTED] resided with Jeremy Callihan at 10616 E 70th Street, Raytown, Missouri, 64133. She also advised that Jeremy Callihan would watch [REDACTED] while she was not at the residence, due to her working evenings/overnights.

On 08-24-2020 at approximately 1600 hours, I was contacted at Raytown Police Headquarters by [REDACTED]. [REDACTED] provided me with "Screen shots" that [REDACTED] obtained from [REDACTED] neighbor, "Kendra Chapman," in regard to a "text message thread" between Jeremy Callihan and Kendra Chapman. The name "Spence" and phone number "816-328-4145" was displayed on top of every text message. The phone number is the contact number displayed for Jeremy Callihan in Global Records.

The text message thread displayed a question, which was highlighted in yellow, asking Jeremy Callihan if that was the first time that he has spoken to [REDACTED] about that stuff. Jeremy Callihan admitted through text message that it was the first time he spoke with [REDACTED] about that stuff and that he made a game out of it. Jeremy Callihan described the game as them "watching a movie, kissing face, not really kissing and I

would move my hand up [REDACTED] part but not touch it and I would say ok, slap me that's what you do with someone and then I did it with [REDACTED] chest and [REDACTED] butt and taught [REDACTED] how to slap if anyone touched those arwasm." Jeremy Callihan also admitted that he told P.M. how babies are made, advising that "I don't remember much of anything else, just those. I was pretty lit."

On 12-11-2019 at approximately 1625 hours, Jeremy Callihan agreed to an interview with me on 12-19-2019 at approximately 1100 hours at Raytown Police Headquarters. On 12-18-2019 at approximately 1646 hours, I was contacted by Jeremy Callihan, who advised that his attorney instructed him not to make a statement.
