The facts supporting this belief are as follows:

On 05/25/2021, officers of the Kansas City, Missouri Police Department were dispatched to Children's Mercy Hospital in regard to juvenile information. The victim ( ) disclosed Rosendo Palma W/M 03/01/1967 touched "parts" under underwear with his hand "really hard."

On 06/07/2021, the victim participated in a forensic interview. The victim stated "Chendo" takes and ( ) upstairs and puts them on the bed to play with his phone. He puts his hand in s and does it "really hard." "Chendo" made put mouth on his penis. stated he opens legs and starts "doing it like this." demonstrated with anatomically correct dolls the boy doll on top of the girl doll, moving his hips up and down. stated he touches and butt with his hand. stated he does it every day, he did it many times and he didn't stop doing it. stated it hurt when peed and there was red coming out of . stated was four years old when the incidents occurred. used anatomically correct drawings to identify and butt as places he touched with his hand and also identified the as a place he touched with his penis.

On 07/29/2021, (mother of the victim) provided a statement. stated told it hurt when urinated. disclosed "Chendo" touched with his fingers and it stated "Chendo" is Rosendo Palma W/M 03/01/1967.

On 07/29/2021 ( ) provided a statement. stated told that Rosendo touched vagina. stated "me, no, before yes" indicating Rosendo had touched previously. The next day told was lying did not want to participate in a forensic interview.

On 09/06/2021, JL (wife of Rosendo) provided a statement. stated she has watched for approximately one year. She stated love Rosendo and love to play with him. He would let them play with his phone and occasionally go upstairs. Rosendo denied touching but stated he may have touched accidentally while playing.

On 09/06/2021, Rosendo Palma provided a voluntary statement. Rosendo stated he does play with the and lets them use his phone. He denied touching the in a sexual way but stated he may have touched their accidentally while playing with them.
