The facts supporting this belief are as follows:

On 10/26/2023 at approximately 2005 hours officers of the Kansas City Missouri Police Department were dispatched to 4747 Flora Avenue Kansas City, Jackson County, Missouri in regard to a Strongarm Street Robbery.

Upon arrival, officers contacted Victim 1 who had a large amount of blood coming from the top of her head. Victim 1 stated the following: An unknown skinny black female wearing a gray sweater with a brown jacket had approached her vehicle (White 2008 Saturn VUE) and attempted to force entry into it. Victim 1 attempted to lock her vehicle doors but she was unable to and the suspect entered her vehicle. Victim 1 confronted the suspect (later identified REID, Trenise) who got into the driver's seat and drove off with her one year old great granddaughter (Victim 2, [REDACTED] still inside. Victim 1 recalled being dragged by her vehicle during the struggle with the suspect. While speaking with officers, Victim 1 would repeatedly go in and out of consciousness due to a possible head injury she sustained from the suspect. Officers observed a laceration to the rear of her head that was bleeding profusely.

Officers contacted Witness 1 who stated the following: she observed a black female with a, "Short afro" (suspect) walk around the parking lot. The suspect walked down the hill toward their vehicle before she asked them how they were doing. She could immediately tell the suspect was high on drugs as she started pulling at her shirt and acting weird. Witness 1 observed the suspect circle the parking lot before walking up the stairs towards the school. A short time later she observed the white Saturn speed out of the parking lot northbound before turning northbound on Flora Avenue. The witness said she walked up the hill toward the school and observed what appeared to be an unresponsive person laying near the front of white SUV. The witness called the Police.

While on scene, officers gained access to security footage and observed the following: At approximately 1929 hours, an unknown female (suspect) wearing dark clothing is observed walking northbound through the parking lot on the west side of the building before leaving camera view. At approximately 1930 hours, the suspect comes back into camera view and is observed walking east up the stairs towards the west side of the building approaching a white SUV (victim's vehicle) that is facing north. The suspect is observed opening the front passenger door of the vehicle at approximately 1931 hours. The suspect shortly afterwards shuts the door and walks around the backside of the victim's vehicle to the driver side. Moments later the front driver side door opens and the driver appears to exit the vehicle. At approximately 1932 hours, the vehicle drives off and Victim 1 is observed laying on the ground not moving.

Detectives later responded to Truman Medical Center to contact the victim and get a formal statement. Victim 1 was initially found to be conscious and alert, however would periodically fall asleep. Victim 1 stated on 10/26/2023, she parked in front of Paseo High School with her great granddaughter (victim 2) in the back seat. Victim 1 was waiting to pick up her granddaughter from the play that was being performed. While she was waiting, she observed a black female wandering the parking lot. The woman then approached her car and started yelling "my baby is dead!" The woman then began trying to get into her car. She attempted to roll the windows closed and lock the doors, but the suspect got in. Once inside the vehicle, she remembered a struggle with the suspect, however suddenly she has no memory. Her next memory was waking up with blood on the pavement, and seeing blood on a vehicle nearby. She stated she was unaware how long she was unconscious, but when she came to, she went to look for help and was eventually able to locate a KCPS Security Guard. Victim 1 stated she was not sure if she would be able to identify the suspect, but was willing to try. Following the interview, Victim 1's nurse was contacted and advised she had a brain bleed and would be admitted.

On 10/26/2023 at approximately 2124 hours Lee Summit Police officers responded to the intersection of NE Woods Chapel Road and NE I-470 Highway. The officers observed the Victim 1's vehicle, a white Saturn Vue bearing Missouri license plate [REDACTED] blocking the westbound lane of NE Woods Chapel Road above NE I-470 Highway abandoned. Officers cleared the vehicle and located Victim 2 in a car seat in the rear passenger side of the vehicle. Victim 2 was transported to Children's Mercy Hospital where she was examined by medical personnel and found to be uninjured and in good health.

On 10/26/2023 at 2141 hours, Lee Summit Police Officers were dispatched to 917 NE Woods Chapel Rd Lee Summit, Jackson County, Missouri (El Sazon Mexican Restaurant) in regard to an armed disturbance (LSPD 23-8053). REID entered the restaurant and stated "it's a stick up!" and had her hands held in the form of a gun. REID also told the Victims that someone was trying to kill her, there was a dead body, and she just wanted her kid back. REID then grabbed some knives kept in the food window, turned around and told everyone to get out and stated, "Yo bitch get out of here, I am going to kill you all!" The suspect was later determined to be the same suspect involved in the Robbery and Kidnapping from 4747 Flora Avenue Kansas City, Jackson County, Missouri. REID barricaded herself inside the restaurant and armed herself with knives and a fire extinguisher. An operation 100 was initiated where REID was later taken into custody at 0140 hours by members of the Kansas City Police Department. REID was transported to Lee Summit Police Department Detention Unit.

On 10/27/2023 at 1100 hours Detectives responded to Truman Medical Center. The victim was shown a photo lineup of REID (in the #3 position) along with 5 other subjects similar in appearance. The victim viewed the lineup and was unable to positively identify anyone from the lineup.

On 10/27/2023 Detectives responded to Lee Summit Police Department to interview REID regarding her arrest. At 1327 hours, REID was read her Miranda Rights aloud and obtained a verbal response from REID on each of her rights that she understood them and agreed to speak with the Detective.

REID stated throughout the day she felt like she was being followed by people. She said earlier she was on a bus and people were taking videos of her which made her uncomfortable. After REID got off the bus and made her way to the school, she admitted she observed the victim in her vehicle and attempted to get a ride from the victim. REID admitted that she entered the victim's vehicle and drove it away not knowing at first that the child was in the back seat. REID stated that she observed the adult victim in her mirror laying on the ground and believed that she had drug the adult victim with the car. REID stated she observed the child in the back seat of the vehicle as she was exiting the parking lot however did not stop and continued to flee the area in the vehicle. REID stated as she was driving the vehicle, the 1 year old infant in the back seat was telling her to "go go go." REID added she drove towards Lee Summit for no reason other than to seek shelter and stated that the vehicle ran out of gas on the highway at which time she exited the vehicle and abandoned the child. REID stated that she entered the restaurant and told everyone to get out at which time she grabbed a knife from inside of the restaurant as everyone was exiting. REID stated she was scared and therefore refused to exit the business after she observed law enforcement outside of the business. REID admitted to using narcotics, however was not under the influence of a narcotic at the time of this incident. REID has seen a doctor for mental health issues in the past however does not regularly see a doctor and is not prescribed any medication.
