

GRANDVIEW STATEMENT OF PROBABLE CAUSE

I, Detective Stefany Jones, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

I have probable cause to believe that on 05-02-2021 at 6100 MO 150 Hwy, Grandview, Jackson County, Missouri, Briscoe, Stacy T. b/m 04-06-1969 SSN XXX-XX-27514 committed one or more criminal offenses.

On 5-2-21 at approximately 1952 hours, Grandview Officers were dispatched to the area of 13100 Spring St, Grandview, Jackson County, MO 64030 (Discount Smokes and Liquor), in regards to a shooting.

Upon arrival, Officers located the victim, J.S. b/m 09-10-1979, lying unresponsive in the parking lot of 5907 High Grove Rd which was just west of 13100 Spring St. Officers were advised by a witness that a black male with a blue t-shirt and cargo shorts ran south from the 5907 High Grove parking lot. Officers conducted an area canvass for the suspect utilizing a K9 and a drone but were met with negative results. J.S. was transported to the hospital by medics.

Video surveillance from the business at 13100 Spring St showed J.S. and Briscoe arrive together in a silver in color four door hatchback. Upon arriving at the store, both J.S. and Briscoe enter the store, appear to have an argument as J.S. is shown shoving Briscoe a few times. Briscoe leaves the store alone and drives away in the silver vehicle. Approximately ten minutes later, Briscoe is observed walking back to the store from the east. He enters the store, then walks out and motions J.S. to walk with him. The two walk west to the parking lot of 5907 High Grove Rd. J.S. appears to stop. Briscoe then turns towards J.S., runs towards him, then runs south after J.S. appeared to have fallen to the ground.

On 5-3-21 at approximately 1227 hours, Detective Jones responded to the jail at 1200 Main St and escorted Briscoe to an interview room. Detective Jones ensured she had all of Briscoe's correct pedigree information. At 1231 hours, Detective Jones advised Briscoe of his Miranda Rights. Briscoe stated he understood the rights and signed the rights form. Detective Jones asked Briscoe to tell her why he was there. Briscoe stated all he knew was that he got out of jail from KCPD for a DUI. When he arrived back at his girlfriend's residence, R.W., she began asking him how he got home from the jail. Briscoe asked her why she cared how he got home and an argument ensued. He went outside to smoke a cigarette, then came back inside and the Police showed up. Detective Jones then asked him what happened before he got into a crash earlier in the day. Briscoe advised that in the morning, his grandkids called him and told him that they wanted to have a barbeque. Briscoe called his mom and asked if he could borrow her car to get a grill. His mom told him that she would send J.S. to his place with a small grill rather than having to bring the whole family out. After the plans fell through for the barbeque, J.S. arrived at R.W.'s residence to pick Briscoe up to take him out to Swope Park. Briscoe stated he could tell that J.S. was drunk. J.S. drove him out to Swope Park where Briscoe hung out for a while. Briscoe stated he called J.S. to pick him back up and take him back home to Grandview. When J.S. showed up, Briscoe told him that he was going to drive. As they were driving back to Grandview, J.S. began getting physical with Briscoe and was hitting him. Once arriving in Grandview, at one point, J.S. got out of the vehicle and dropped his gun. Briscoe drove up the road and pulled over until J.S. got back into the vehicle. Briscoe then drove to the discount smokes and liquor store at 13100 Spring St. While they were at the store, Briscoe stated that J.S. started causing a disturbance inside of the business. When

Briscoe could not get J.S. to leave, Briscoe drove away. Briscoe went to R.W.'s residence and told her to go with him to get J.S. so they could take the car back to his mother. R.W. told him she didn't want to go. Briscoe drove back to the store and drove around the block a couple of times and after not being able to find J.S. he left and drove the car up to his sister's house and that was when he got in a crash. Detective Jones told Briscoe that he was lying and she knew that he did go back to the liquor store and parked on the side of the business. When he found J.S. and told him to go with him, he said J.S. looked at him with red in his eyes. Briscoe also stated that while they were fighting in the car prior, J.S. pulled his gun on him. Briscoe said he knew he couldn't take J.S. back to the family because of how he was acting. Briscoe said he knew that J.S. would try to go to his house and try to shoot his family. Detective Jones asked if that was why Briscoe shot him. Briscoe stated no, it was self-defense. Briscoe stated they were 'tussling' in the car in the parking lot and that was how Briscoe got J.S.'s gun. Briscoe stated he began to start thinking in a criminal way rather than a responsible way. Briscoe stated he was first trying to get J.S. back to the car and then said he just told J.S. that they were going to fight. When Briscoe said that to J.S., J.S. stated "I'm going to kill you", "me and my cousins about to kill you and your girlfriend". After J.S. said that Briscoe stated he turned and walked up to him. Detective Jones asked Briscoe why he went back to J.S. when he knew that J.S. was acting the way he was. Briscoe stated Briscoe stated that he believed the devil had sent J.S. into his life to cause problems. Detective Jones asked Briscoe where he shot J.S. Briscoe first stated when he pulled the gun out he hit J.S. in the face with the gun and the gun may have gone off. Briscoe then stated he didn't know because his eyes were closed. Detective Jones asked Briscoe why he ran after he shot J.S. Briscoe stated he was scared of the situation. Detective Jones asked Briscoe if he was sorry for shooting J.S. Briscoe first stated he was sorry that his mom asked J.S. to go get him. The he stated yes that he felt bad.

During the end of the interview, Briscoe would put his head in his hands and say that he was going to jail for the rest of his life. Detective Jones ended the interview and escorted Briscoe back to the cell.

A criminal history check of Briscoe showed him to currently be on supervised release through U.S. Probation for felon in possession of ammunition. In 1991 Briscoe was charged with murder 2nd degree in Jackson Co Cir Crt; 1994 he was charged and convicted for robbery 1st degree through Jackson Co Cir Crt.
