The facts supporting this belief are as follows:

On 04/01/2020 at 1502 hours, Officers of the Kansas City Missouri Police Department were notified of an armed robbery that occurred at 1700 Truman Rd (Ebenezer Auto).

Upon officers arrival they contacted several employees who were victims of the incident, **OMA, VAE, ERH, MAM, and PP**.

**OMA (the owner of the business)** stated the suspect, **Tomorren D. Garrett B/M 11/08/1979**, brought them a vehicle to repair approximately two and a half weeks ago. **Garrett** brought them parts for the vehicle and they agreed on a labor price of \$700.00. **Garrett** gave them a \$350.00 deposit to complete the work. On 04/01/2020, Garrett came in the store to check the status of his vehicle. **Garrett** was talking with **PP** and told him his vehicle heads don't have compression. **Garrett** got upset, asked for his parts back, and left the business. Approximately 5 minutes later, **Garrett** came back armed with a handgun and put the gun in his right pant pocket. **Garrett** stated, "No you will listen, I'm going to kill you mother fuckers and I want my money". **OMA** gave **Garrett** \$110.00 but **Garrett** demanded that she gives him all the money that she has. **Garrett** then pushed **PP** and told him to give more money. **PP** gave **Garrett** \$300.00. **Garrett** then produced a handgun and hit **PP** in the face with the handgun. **ERH** approached **Garrett** when **Garrett's** girlfriend warned **Garrett** that **ERH** was approaching him. **Garrett** hit **ERH** in the face with the handgun. **Garrett** then left the scene but came back a short time later and was yelling at **PP** to come outside.

The other listed victim's statements were consistent with **OMA's** statement. **ERH** or **PP** had no visible injuries and they both refused medical treatment.

**Garrett** remained on scene when the officers arrived and was arrested. **Garrett** was transported to East Patrol for questioning. **Garrett** was advised of his Miranda rights. **Garrett** stated he understood his rights and spoke with detectives. **Garrett** admitted going to Ebenezer Auto today and confronting employees about his vehicle. **Garrett** stated that **PP** wanted to put a new engine in his vehicle. He checked on his vehicle and saw a there was different engine inside his vehicle. **Garrett** admitted he became upset and went outside. He then came back to the store and demanded his money back from **PP** and **OMA**. He added **PP** gave him \$200.00 and

**OMA** gave him \$130.00. **Garrett** admitted punching **PP** and **ERH** in the face but he denied using a gun. **Garrett** informed detectives that he owns a handgun which it is kept in his vehicle, a 2018 gray Nissan Rogue.

The underlying offense is related to a serious felony currently being investigated by Kansas City Missouri Police Department which is punishable by significant penalties that incentivize the defendant to fail to appear.
