The facts supporting this belief are as follows:

Date: 03-16-2022

On 08-25-2020 at 1951 hours, Officer of the Kansas City Missouri Police Department were dispatched to the area of 2701 Guinotte Ave, Kansas City, Jackson County, Missouri regarding a reported shooting.

Upon arrival Officers located two deceased males inside of a gold colored Honda. The Victims were identified as Jahmiere Green, B/M, 12-01-01 and Brandon Rainey, B/M, 10-27-97.

Video surveillance footage was located of the Victims vehicle being followed by a white SUV traveling east bound on Guinotte. The SUV pulls up to the driver's side of the Victim's vehicle and the victims vehicle slowly rolls to a stop. No movement is observed on the video after the SUV leaves east bound. The white SUV returns west bound and leaves the same way it arrived.

The Jackson County Medical Examiner's Office advised they would be ruling the deaths a homicide.

Detective's located surveillance footage at 500 East 3rd and shortly before the murder the Green (Victim) shows up at the location in the gold Honda. Green goes inside the building and upon exiting is contacted by a Black Male, muscular build, shorts and a white tee shirt wearing a ball cap backwards. The two speak for a minute or so and the two separate, a short time later Rainey arrives at the vehicle and enters the passenger seat of the gold Honda and leaves the location. Detectives are able to follow the Victims vehicle via surveillance footage to the scene of the murder. The vehicle is followed from the area of 500 East 3rd by the white SUV. After the murder the white SUV returns to 500 East 3rd and enters the parking garage for residents utilizing a key fob #349. After the white SUV parks a person can be seen taking items from the SUV and throwing them into a dumpster. The person coming from the SUV appears to match the build and clothing of the male seen in the video with Green prior to the murder.

Detective's learned key fob's are numbered and assigned to specific tennants. Key fob #349 is assigned to Anjeanette White in apartment #523.

On 09-04-2020 the reporting detective was informed by Special Agent Kyle Heitman that a different vehicle was using the same key fob #349 and was parking in the parking garage, later determined to be a Hyundai Veracruz.

On 09-09-2020, detectives were in the office at 500 East 3rd collecting video footage from the business. Detectives observed the Hyundai Veracruz enter the parking garage and they responded to the area of the garage to see who was driving the vehicle based on the lack of video coverage.

Detectives contacted Cleon White, B/M, 06-11-1987. White's build is a match with the male seen in the video with the murder. After contacting White in the parking garage he changes clothing and departs in the Hyundai Veracruz.
White was stopped by Officers and transported him to Police Headquarters for an unrelated warrant for his arrest. An attempt to interview White was made but after advising him of his Miranda rights he declined to make a statement. White had two phones in his possession, which were siezed and search warrants were applied for.
On 05-27-2021, was interviewed by detectives and provided her cellular phone number as 816-756-4276. She also advised she and her sister Mary White stayed at the apartment, she advised her nephew would come by sometimes. She was shown surveillance footage from the Cold Storage lofts. She advised she had seen the kids around the apartments but didn't know them. She viewed a video of the suspect holding a young girl and advised she didn't know him or the girl.
Content from Cleon White's phones was obtained subsequent to the search warrant which revealed a video showing a bill addressed to at 500 East 3 <sup>rd</sup> #523. Additionally located was a video created on 8/25/2020 at 5:44:24 PM. A sunroof can be seen as well as writing on the rear driver side window reading "ADESA Assurance" and an "S" type line drawn next to it. The suspect vehicle is a white Acura SUV, appears to be a MDX, and has a sunroof. Writing on the rear driver side window similar to the layout of this wording can be seen from surveillance video of the suspect vehicle on the day of the murder, 8/25/20. Also during review of the phones, an image was found created on 8/25/20 at 2:22:43 PM. The photograph is taken from the driver seat of an Acura in which the steering wheel can be seen and outside a menu for Harold's Drive-In. On the windshield of this Acura, was observed to be a "target" type drawing located in the middle of the driver portion of the windshield.
On 8/18/21, detectives responded to ADESA Kansas City located at 15511 E 155th Street, Belton, Missouri and contacted the General Manager. Who stated ADESA sold a white Acura MDX which was seen pulling out of the secured lot on 7/24/20 with a driver and front seat passenger seen inside the vehicle. On the windshield of the vehicle, was observed a white in color "target" type circle similar to the one observed earlier in the photograph in the phone download. The Manager advised when they inspect their vehicles, if the glass has an imperfection or chip of some kind, they circle said imperfection on the windows in this manner.
A SMS message was located in the download of Cleon White's phone from a contact saved as "Auntie Angie" the number 816-756-4276 is the same number provided to the detective by
On 08-25-2020 at 05:55 PM a video is located on the phone download appearing to be the same Acura. The driver is visible and is a black male with a beard, muscular build, wearing a ball cap backwards and a white tee shirt. This appears to be the same male as seen on the surveillance video.
