# COMPLAINT WARRANT REQUESTED

# Count I. Assault 1st Degree Or Attempt - Serious Physical Injury Or Special Victim (565.050-001Y20201399.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.050, RSMo., committed the **class A felony assault in the first degree**, punishable upon conviction under Sections 558.011, RSMo., in that on or about on or about August 5, 2024, in the County of Jackson, State of Missouri, the defendant, either acting alone or purposefully in concert with another, attempted to cause serious physical injury to by stabbing him, and in the course thereof defendant inflicted serious physical injury on

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

#### **Count II. Armed Criminal Action (571.015-001Y20205299.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo., committed the **felony of armed criminal action**, punishable upon conviction under Section 571.015.1, RSMo., in that on or about on or about August 5, 2024, in the County of Jackson, State of Missouri, the defendant committed the felony of assault in the first degree charged in Count I, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of assault in the first degree by, with and through, the knowing use, assistance and aid of a dangerous instrument.

The punishment imposed pursuant to Section 571.015, RSMo. shall be in addition to and consecutive to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.1, RSMo. is imprisonment by the department of corrections for a term of not less than three years and not to exceed fifteen years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term of not less than five years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three calendar years.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

The facts supporting this belief are as fol	lows:	

On 08/05/2024 at 1305 hours, Officers with the Kansas City Missouri Police Department were dispatched to the area of on a reported disturbance. Upon the officer's arrival, a security officer for the Kansas City Area Transport Authority (KCATA), WIT 2 had **WASHINGTON** handcuffed to a pole inside the bus and had SUS 2 confined to the rear of the bus. The Victim was seated outside on a bench bleeding from his legs. **WASHINGTON** and SUS 2 were then taken into custody. The Victim was taken to an area hospital for his injuries and is in stable condition. The Victim suffered a puncture wound to both thighs, striking a femoral artery, and a cut to the rear of his right arm.

The Victim was interviewed at the hospital and provided a statement. He was riding the bus when **WASHINGTON** got on and became loud and cussing. **WASHINGTON** and another female got into verbal argument and he intervened by telling **WASHINGTON** that she was not going to assault the other female. SUS 2, who was in the rear of the bus, confronted Victim telling him that he was not going to allow Victim to hit **WASHINGTON**. The Victim and SUS 2 began arguing and **WASHINGTON** and the other female began arguing with them as well. Eventually **WASHINGTON** pulled out a knife and made a threat to kill this female. The Victim pulled out his baton when he observed **WASHINGTON** armed with a knife. At that time, SUS 2 began fighting with Victim by striking him with closed fists. While being struck by SUS 2, **WASHINGTON** began stabbing Victim repeatedly with her knife.

WIT 1 stated the following: **WASHINGTON** got onto the bus and began talking to herself and being loud. The Victim told her to "shut up, sit down, or get off the bus." **WASHINGTON** then got into a verbal argument with another female. Then, SUS 2 began yelling at the Victim for how he was treating **WASHINGTON**. The Victim pulled out his baton and confronted WASHGINTON so SUS 2 began fighting with the Victim. **WASHINGTON** then starting stabbing the Victim several times. The Victim dropped the baton so

**WASHINGTON** then starting stabbing the Victim several times. The Victim dropped the baton so **WASHINGTON** picked it up and started hitting the Victim with it while continuing to stab at him. WIT 2

arrived and gave **WASHINGTON** verbal commands to drop the knife and batons. **WASHINGTON** dropped the baton and put the knife back into her bra. **WASHINGTON** then resisted WIT 2 while he was trying to detain her.

WIT 2 stated the following: He arrived on scene and observed the Victim fighting with SUS 2, and saw that **WASHINGTON** was armed with a knife and baton that appeared to have blood on them. WIT 2 drew his duty weapon and gave the **WASHINGTON** verbal commands to drop the weapons but she only dropped the baton and placed the knife in her bra. WIT 2 attempted to place **WASHINGTON** into handcuffs but she resisted. This upset SUS 2 and he began yelling at WIT 2. WIT 2 stated he was only able to place one handcuff on **WASHINGTON** so he placed the other on a nearby railing. SUS 2 began getting more aggressive but he was able to take him into custody.

Wit 3 stated the following: she saw **WASHINGTON** who was aggressively started arguing with another female on the bus. WIT 3 told **WASHINGTON** that she needed to exit the bus but then **WASHINGTON** began cussing at her. **WASHINGTON** pulled a knife while arguing with the female. The Victim started arguing with **WASHINGTON**. SUS 2 got upset with the Victim and they began arguing and that lead to a fight. **WASHINGTON** then started stabbing the Victim and hitting him with a baton. WIT 3 then arrive and took the parties into custody.

Officers were able to identify the female that got into an argument with WASHGTON, but she would not respond or return detectives calls. Detectives reviewed surveillance video from interior cameras within the bus. Video has audio and shows the following: WASHINGTON is yelling at a female and is stating "you gunna catch these hands." The Victim was then observed talking to WASHINGTON and she walks towards the back of the bus. The Victim and SUS 2 then begin arguing. WASHINGTON and the female then argue.

WASHINGTON then pulls out a knife from her bra and multiple people on the bus started yelling that WASHINGTON has a knife. WASHINGTON raises the knife to her ear and make several stabbing motions toward the female. WASHINGTON then makes a stabbing motion towards the Victim. The Victim pulls out his baton. WASHINGTON steps toward the Victim and, in response, the Victim strikes WASHINGTON with the baton. SUS 2 then starting striking the Victim with closed fists while WASHINGTON stabs the Victim serval times and strikes him with the baton that fell to the ground. A short time later, WIT 2 arrives on scene and draws his firearm on WASHINGTON while the Victim and SUS 2 are still fighting. WASHINGTON drops the knife but puts the knife back in her bra. WIT 2 separates the Victim and SUS 2. WASHINGTON resists WIT 2 but eventually is handcuffed to a rail.

**WASHINGTON** was read her Miranda Warning and she agreed to provide a statement. **WASHINGTON** stated she was rapping out loud and got into a verbal argument with the victim and a female. **WASHINGTON** stated SUS 2 was defending her while she argued with the female. **WASHINGTON**'s statement then began to become inconsistent with the video surveillance footage. **WASHINGTON** stated SUS 2 asked for a knife so she gave it to him and he began stabbing the Victim. She advised SUS 2 had his cousin with him and they were both fighting with the Victim and the female produced a firearm and pointed it at her.

Due to the above noted facts it is believed that **WASHINGTON** represents a danger to the community.



Due to the above noted facts it is believed that **BAKER** represents a danger to the community.
