# Count I. Assault 1st Degree Or Attempt (565.050-002Y20201304.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.050, RSMo, committed the **class B felony of Assault in the First Degree**, punishable upon conviction under Section 558.011, RSMo, in that on or about September 28, 2024, in the County of Jackson, State of Missouri, the defendant knowingly caused serious physical injury to by shooting

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

The range of punishment for a class B felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than five (5) years and not to exceed fifteen (15) years.


### **Count II. Armed Criminal Action (571.015-001Y20205299.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about on or about September 28, 2024, in the County

of Jackson, State of Missouri, the defendant committed the felony of Assault in the First Degree charged in Count 1, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Assault in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

The punishment imposed pursuant to Section 571.015, RSMo shall be in addition to and consecutive to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.1, RSMo. is imprisonment by the department of corrections for a term of not less than three years and not to exceed fifteen years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term of not less than five years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.2, RSMo. as a second offense is imprisonment by the department of corrections for a term of not less than five years and not to exceed thirty years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term not less than fifteen years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of five calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.3, RSMo. as a third offense is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years without eligibility for parole, probation, conditional release or suspended imposition or execution of sentence for a period of ten (10) calendar years.

# Count III. Kidnapping - Facilitating A Felony - Inflicting Injury - Terrorizing - 1st Degree (565.110-002Y20201006.0)



An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

The range of punishment for a class B felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than five (5) years and not to exceed fifteen (15) years.

#### **Count IV. Armed Criminal Action (571.015-001Y20205212.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about on or about September 28, 2024, in the County of Jackson, State of Missouri, the defendant committed the felony of Kidnapping in the First Degree charged in Count 3, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Kidnapping in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

The punishment imposed pursuant to Section 571.015, RSMo shall be in addition to and consecutive to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.1, RSMo. is imprisonment by the department of corrections for a term of not less than three years and not to exceed fifteen years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term of not less than five years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.2, RSMo. as a second offense is imprisonment by the department of corrections for a term of not less than five years and not to exceed thirty years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term not less than fifteen years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of five calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.3, RSMo. as a third offense is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years without eligibility for parole, probation, conditional release or suspended imposition or execution of sentence for a period of ten (10) calendar years.

# Count V. Kidnapping - Facilitating A Felony - Inflicting Injury - Terrorizing - 1st Degree (565.110-002Y20201005.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.110, RSMo, committed the class B felony of Kidnapping in the First Degree, punishable upon conviction under Section 558.011, RSMo, in that on or about September 28, 2024, defendant unlawfully confined for a substantial period, without consent because such confinement was the result of forcible compulsion and for the purpose of terrorizing

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

The range of punishment for a class B felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than five (5) years and not to exceed fifteen (15) years.

### **Count VI. Armed Criminal Action (571.015-001Y20205212.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about on or about September 28, 2024, in the County of Jackson, State of Missouri, the defendant committed the felony of Kidnapping in the First Degree charged in Count 5, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Kidnapping in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

The punishment imposed pursuant to Section 571.015, RSMo shall be in addition to and consecutive to any punishment provided by law for the crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.1, RSMo. is imprisonment by the department of corrections for a term of not less than three years and not to exceed fifteen years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term of not less than five years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.2, RSMo. as a second offense is imprisonment by the department of corrections for a term of not less than five years and not to exceed thirty years, unless the person is unlawfully possessing a firearm, in which case the term of imprisonment shall be for a term not less than fifteen years. No person convicted under this subsection shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of five calendar years. The range of punishment for the offense of Armed Criminal Action in violation of section 571.015.3, RSMo. as a third offense is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years without eligibility for parole, probation, conditional release or suspended imposition or execution of sentence for a period of ten (10) calendar years.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

I have probable cause to believe that <b>September 28th, 2024</b> , in the area of the suspect, <b>HOLMES, KODY MICHAEL</b> committed one or more
criminal offenses.
The facts supporting this belief are as follows:
On 9-28-2024 at about 1721hrs the Lee's Summit Police Department began receiving information concerning a possible homicide and kidnapping. Victim #2 was currently speaking with members of the Kansas City Missouri Police Department. Victim #2 reported she resides at and stated a homicide was committed at her residence and she was kidnapped.

Between 0400hrs and 0500hrs HOLMES and Victim #1 began to argue, which led to a short physical fight. Soon after Victim #1 told Victim #2 that HOLMES "pulled a gun". Between 0500hrs and 0600hrs Victim #2 said Victim #1 was going down the stairs when HOLMES, who was at the bottom of the stairs, fired two shots with one striking Victim #1 in the leg. Victim #1 retreats into a bedroom with the help of Victim #2. HOLMES proceeds up the stairs and fires another shot and Victim #1 further retreats to the bedroom bath. HOLMES next enters the bedroom and fires a shot through the bathroom door where Victim #1 is.
HOLMES turns to Victim #2 and tells her "don't be a hero" or he will kill Victim #3. Victim #2 leaves the bedroom and soon hears another shot and hears Victim #1 screaming. She also heard HOLMES taunting Victim #1 telling him he was going to die slow.
HOLMES ordered Victim #2, Victim #3 and Victim #4 into the bedroom. Victim #2 said Victim #1 continuously

Over the next few hours Victim #2 and Victim #3 were held at gunpoint. HOLMES at times held a gun to the head of Victim's #2 and #3. HOLMES also fired a shot past Victim #2's head/ear before doing the same to Victim

with Victim #2's description of where shots were fired from. The bathroom door also showed several bullets holes that traveled trough and struck the bathtub. Suspected blood was observed in the bedroom and the adjacent bathroom.

An alert was issued for the vehicle along with a person of interest for HOLMES. At about 2230hrs the vehicle was located in Johnson County, Missouri. Law Enforcement agencies in that area attempted to stop the vehicle which fled. After a lengthy pursuit the vehicle came to a stop after stop sticks were used along with a grappling

device. During the pursuit HOLMES struck several of the pursing vehicles. After coming to a stopped Victim #3 was found to still have been in the vehicle and soon exited alone. HOLMES remained in the vehicle alone for some time before being taken into custody.

HOLMES' vehicle was towed to the Lee's Summit Police Department where a search warrant was obtained. Found in the vehicle were two firearms which matched the description of those given by Victim #2. Both firearms were loaded with chambered rounds. Also found in the vehicle was Victim's #2's wallet that contained her identification along with credit cards belonging to Victim #1.

Soon after HOLMES was transported to the Lee's Summit Detectives attempted an interview. He was very lethargic and would not acknowledge the Detectives. Later, on 3-29-2024 at about 1300hrs an interview was again attempted. HOLMES became verbally aggressive and requested a lawyer.
