On 02-03-2025 at 2002 hours, members of the Kansas City Missouri Police Department were dispatched to 11th Street and Grand Blvd. Kansas City, Jackson County, Missouri on a reported injury crash involving a pedestrian. The pedestrian/victim was transported to an area hospital where he died as a result of his injuries from the crash. The victim was identified as Officer T. White of the Accident Investigation Section responded as lead Investigator due to the fatality. an Official Court Document Assean Official Court Document Not an Official Court D

Upon the officer's arrival, they determined an unknown gold four door vehicle possibly a Toyota, struck who was walking west to east in the crosswalk on the north side of 12th Street and Grand Blvd., Kansas City, Jackson County, Missouri. Video surveillance from a nearby apartment complex shows to be carrying two white plastic grocery sacks one in each hand. As approached the northbound lanes of Grand Blvd, the traffic signal had turned red for north and south traffic. A gold four door sedan is seen traveling at a high rate of speed and striking crossing Grand Blvd. in the crosswalk. Video surveillance from a nearby apartment complex shows carrying two white plastic grocery sacks one in each hand. After the gold sedan strikes are the vehicle is seen going northbound in the southbound lanes of Grand Blvd. The vehicle is seen fleeing the scene northbound on Grand Blvd. without stopping to check on the pedestrian. A short time later, a 911 call was received regarding a gold four door vehicle, which appeared to have been in a crash, parked and abandoned in the area of 9th and Jefferson Street, Kansas City, Jackson County, Missouri. Officers responded to the location and observed a parked along the north curb of 9th Street just east of Jefferson Street. The vehicle was found to be abandoned and had major damage consistent with the crash involving the pedestrian. The damage consisted of damage to the front driver's side headlight, the hood of the vehicle was heavily dented, the windshield was broken and caved in, and the roof and trunk area were also damaged, which was all consistent with the crash observed on surveillance video. The two plastic sacks the pedestrian was carrying were located embedded in the vehicle to include one in the area of the front driver's side bumper and one in the windshield area. There were also fresh engine fluids on the ground under the vehicle flowing downhill from the vehicle. Upon visual inspection of the vehicle apparent blood was observed inside of the vehicle to include apparent blood on the steering wheel, driver's dash, driver's side door and on the center console of the vehicle. The vehicle was recovered and towed to the city tow lot located at 7760 E. Front Street Kansas City, Jackson County, Missouriurt Document Not an Official Court Document Not an Official Court Document

On 02-04-2025 Detectives with the Traffic Investigations Section responded to the registered owners address in Shawnee Kansas. It was determined the registered owner was in a care facility and had sold the vehicle. Detectives contacted who stated she sold the car to the Offender/Driver Tyler J. Macias, Detectives responded to Macias' address on 02-04-2025 and got no response. It was later learned officers from the Lenexa Police Department had responded to Macias' address, he had been attacked and his car had been stolen in Kansas City Missouri. hours. Macias had told his wife She advised the police her husband came home with blood all over him and he had a cut to his lip. When the police arrived on scene Macias, was very vague with the police and only said he was attacked and his car was stolen, but could not give a location. Macias stated he did not need the assistance of the Lenexa Police Department.

On 02-05-2025 I was contacted by Macias after leaving messages with his wife. He stated he wished for detectives to come to his residence so he could make a statement. Det. Burgess and I responded to

and contacted Macias. Macias and his wife let us into their home to provide a statement. Prior to interviewing Macias, I

and contacted Macias. Macias and his wife let us into their home to provide a statement. Prior to interviewing Macias, I explained to him he was not under arrest. I then advised Macias of his rights, per Miranda by reading them aloud. Macias stated he understood his rights and agreed to be interviewed.

Macias stated he suffers from bad dreams and often drives around Kansas City Missouri to clear his head listening to classical music while he drives. It was determined Macias left his residence at 1912 hours, and returned at 2100 hours, on 02-03-2025, per the Ring Doorbell Camera on his residence. Macias stated while driving around Kansas City in his gold he was in the area of Power and Light just south of 12th Street and Grand Blvd. when he saw a vehicle behind him that may cause a problem. He stated he tried to speed away from the vehicle and drove approximately 50 to 60 MPH north on Grand Blvd. towards 12th Street. Macias then stated he observed a man in the crosswalk, but stated, "I had the green light". As he passed through 12th Street and Grand Blvd. Macias struck with the front of his Toyota. Macias stated he got scared and drove north on Grand Blvd. to the area of a dog park he frequents where he parked the car and left it. It was later determined this was at 9th and Jefferson Kansas City, Jackson County, Missouri. Macias stated he ran to a nearby parking garage where he threw his phone and keys down and thought about getting on a Greyhound Bus. He then flagged down a party driving in the parking garage to take him home to Kansas. Macias denied using any drugs or alcohol prior to the crash, but did admit to consuming a shot of brandy at his residence earlier in the day prior to a nap. provided me with photographs she took of Macias when he arrived home with blood on his clothes and face. Macias stated he had a cut upper lip with swelling and a bloody nose. He also stated he got whiplash from the crash and stated he was not wearing his seatbelt. Document Notan One Section Document

City cameras in the area show Macias driving in a careless and imprudent manner prior to the crash, failing to stop for numerous red traffic control signals in the area just south of the crash without any due regard for public safety. Camera views also show the gold Toyota striking a vehicle from behind at Pershing and Main Street Kansas City, Jackson County, Missouri on 02-03-2025 at 0758 hours (CRN 25006827), just prior to crash at 12<sup>th</sup> Street and Grand Blvd. then fleeing the scene east on Pershing and north on Broadway Blvd. When I asked Macias about this crash, he acted like he was unaware he had been involved in another crash, but did not deny it being involved.

A computer check of Macias showed him to be suspended/revoked through California DOR
