COMPLAINT
WARRANT REQUESTED

Count I. Unlawful Use Of Weapon - Subsection 4 - Exhibiting (571.030-010Y20205212.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.030, RSMo, committed the class E felony of unlawful use of a weapon, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about February 27, 2025, in the County of Jackson, State of Missouri, the defendant knowingly exhibited, in the presence of one or more persons a firearm, a weapon readily capable of lethal use, in an angry or threatening manner.

The range punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

Count II. Unlawful Possession Of A Firearm - Dangerous Felon/Prior Conviction (571.070-003Y20245212.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.070, RSMo, committed the **class B felony of unlawful possession of a firearm**, punishable under Section 558.011, RSMo, in that on or about February 27, 2025, in the County of Jackson, State of Missouri, the defendant knowingly possessed a handgun, a firearm, and on February 1, 2013, the defendant was convicted of the felony of Assault in the Second Degree on a Special Victim, and Armed Criminal Action, dangerous felonies as defined in Section 556.061, RSMo, in the 16th Circuit Court of Jackson County, Missouri.

The range of punishment for a class B felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than five (5) years and not to exceed fifteen (15) years.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.
