I, Ian Storey, a Detective with the Independence, Missouri Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on 3/19/2025, Austin Meyer, committed one or more criminal offenses in Jackson County, Missouri.
2. The facts supporting this belief are as follows:

On 03/19/2025 at approximately 1110 hours, [REDACTED] responded to, [REDACTED] in reference to a sex offense.

Upon arrival, [REDACTED] contacted [REDACTED] public safety director Involved 2 who advised their Information Technology department had discovered explicit pornographic images of nude underage females on a staff employee's computer. [REDACTED] then contacted Involved 1, [REDACTED] Involved 1 advised they had received a malware virus notification on one of their issued devices, identified as a laptop computer assigned to Austin Meyer who is [REDACTED] Involved 1 advised when they began looking for the virus to mitigate the problem, they discovered approximately 11 gigabytes of pornography downloaded to the device. He stated some of the explicit pictures and videos appeared to be that of an unidentified underage white female.

[REDACTED] then observed the discovered evidence and located a video clip of an obvious underage female, approximately 9 or 10 years old with the lower portion of her body completely nude and focused on her vaginal area. [REDACTED] then stopped the review and contacted Independence Police [REDACTED] who advised to arrest and place Austin Meyer on an investigative hold for possession of Child Pornography.

[REDACTED] responded to an [REDACTED] and arrested Austin Meyer. Austin Meyer's school laptop was recovered as evidence from the school theater and later transported to the [REDACTED]

A subpoena was completed and forwarded to [REDACTED] for the data dump of Austin Meyer's school computer. [REDACTED] then provided the dump which was reviewed by Detective Storey who located the following images and videos:

Image Named: A_Oxi_nude_full_frontal

- The image depicts a nude female under the approximate age of 14.

Image Named: Katya_y111_Baby_Oil__4_

- Image depicts a female approximately 14 or under posing in a sexual manner with see through underwear and shirt exposing her vagina and breasts.

Video Named: A_FFM_CP

- Video depicts a male under the approximate age of 8 pulling down the pants of a female under the approximate age of 8, exposing her vagina. The boy then puts his face onto her vagina in what appears to be performing oral sex. At the same time the female has what appears to be an adult male penis (the camera operator's) placed in her mouth and is performing oral sex.

Video Named: A_jenny

- The video starts with displaying approximately 4 still images of a female under the age of 14 tied to a bed with her vagina and breasts exposed. In some of the still images the female is blindfolded. After the still images a video begins with the same female bound by rope performing oral sex on what appears to be the camera operator's penis and who appears to be an adult male.

Video Named: Ajb_More_Similar_Videos_Please

- The video depicts an underage female who vagina becomes exposed and appears to be having intercourse with a dog.

Video Named:

ajb_show_blondie__i_will_see__there_is_lota_AJB....a_few_girls_did_just_one_vid__other_girls_did_lota_vids.

- Video depicts a female under the age of 14 exposing and touching her vagina.

Video Named: Daddy Please Stroke Your Cock For Me

- The video depicts what appears to be an underage female touching her exposed vagina.

Video Named: Katya_y111_Vladmodels_pd20m-Bernt__full__

- Video depicts a female approximately 14 year of age or under dancing in a sexually suggestive manner and removing clothing leaving a see-through shirt exposes her breasts. The female also simulates oral sex with a foreign object.

Video Named: katya-y111-lalistars-photo-compilation

- Video depicts a slide show of approximately 84 images of under aged females positioned and posed in sexually suggestive positions. The females are wearing the majority of the time only bras and thongs and at times see through shirts that expose their breasts.

Video Named: Is-mag_08-07__happy_birthday_party_01_full

- Video depicts two females under the approximate age of 14 who expose their breast and vagina and simulate sex acts.

Video Named: Maid

- Video depicts what appears to be an underage female dressed in a maid's outfit exposing her vagina and masturbating.

Upon review of the evidence [REDACTED] attempted an interview with Austin Meyer who requested a lawyer.
