White Male, committed one or more criminal offense(s).			
2 nd Degree Burglary			
The facts supporting this belief are as follows:			
On 03/30/2025, at approximately 0928 hours, Kansas City Missouri Police Officers were dispatched to Kansas City, Jackson County, Missouri in regard to a non-residential burglary.			
Upon arrival, Officers contacted the business owner (Victim) who stated the following: On 03/29/2025, at approximately 2359 hours, he locked and secured the business and received a phone call from his alarm company as he was leaving. Since he was leaving at the time he believed the alarm was tripped accidentally by him. On 03/30/2025, at approximately 0928 hours, he returned to the business and realized a window in the front door was broken.			
He reviewed video footage which revealed on 03/30/2025, at approximately 0024 hours, a white male wearing a grey Chief's hoody, black sweatpants and a backpack attempt to kick in the rear door of the business but was unsuccessful. The male was then seen entering the building through the front door at 0150 hours on and exiting at approximately 0154 hours on 03/30/2025 reported two bottles of wine (\$200), one bottle of whiskey (\$100), and cash from the register (\$485) as missing from the business.			
estimated the cost to replace the window and to repair the rear door to be approximately (\$2,000). No one had permission to be in the business after hours, and he does wish to press charges.			
On 03/31/2025, photographs of the suspect were shared on a Facebook page "Stolen KC" by received multiple messages via Facebook from individuals who alleged they recognized the suspect as "Evan Werts".			

Kansas City Center Property Crimes Detectives contacted the Kansas City Metro Property Crimes Section in regard to the suspect photos Sciara posted on "Stolen KC".
