On 05/17/2025, Detectives again contacted to show her a photo lineup of Hoskin-Ellis. During this interview with she positively identified Zechariah Hoskins-Ellis B/M .
Detectives also interviewed who stated, he was inside his residence when he heard a few "bangs" and then a female scream. He stated he then looked outside and observed a black Dodge Truck with a trailer attached to it parked in the driveway of He observed a female running and screaming asking him to call 911. He observed the Dodge truck to leave the scene north bound on Benton Avenue. He stated he also observed a younger black male standing outside of a black vehicle and the female was asking him to call 911 and he got into the black vehicle and then leave the scene.
During the investigation Detectives recovered doorbell camera video which shows a silver Dodge Truck with a trailer attached to it, carrying ATVs as described by and a Red Camera pulls up behind it which was described by exhicle got out of. The video did not show the shooting or the vehicles leaving.
On 05/22/2025, the Jackson County Courts granted search warrants for Hoskins-Ellis' phone numbers, and Information from the search warrants are still pending from Verizon Wireless.
On 06/06/2025, Hoskins-Ellis was taken into custody at the downtown probation and parole office and transported to Police Headquarters.
The vehicle that Hoskins-Ellis arrived in and was the sole occupant of, was towed from the State Building Parking lot at the request of State Building Security. During an inventory prior to tow, approximately two pounds of Marijuana was recovered, a baggie of white powdered substance which tested positive for Cocaine, baggie of unknown pills, and multiple THC Lollypops and chocolates.
On 06/06/2025 Hoskins-Ellis was advised of his Miranda Rights and stated that he wanted an attorney.
