The facts supporting this belief are as follows:

Date: 06/08/2016

On 06/07/2016 at 2200 hours Officers of the Kansas City Missouri Police Department were dispatched to 3545 Flora Ave, Kansas City, Jackson County Missouri on a reported Shot Spotter Sound of Shots. Upon arrival Officers located Victim #1 on the front porch deceased at the scene. Officers were advised by Victim #2 and Witness #1 that **Dedrick D. Pickens** was inside 3545 Flora Ave and he was the suspect who shot Victim #1. **Dedrick D. Pickens** refused to follow verbal commands and refused to come out of the residence for approximately 5 minutes. **Dedrick D. Pickens** was tased by Officers and taken into custody at 3545 Flora Ave. **Dedrick Pickens** was searched by Officers incident to Arrest. In his front right small pocket Officers located a small brown paper bag which contained 13 clear plastic bags with a white powdery substance in them. Officers tested the white powdery substance with the Scott Reagent System which tested positive for cocaine.

Victim #2 stated he and witness #1 were in bed watching a movie when he heard 6 gunshots. Victim #2 stated he jumped up out of bed and saw **Dedrick Pickens** standing at the front door at 3545 Flora Ave "looking crazy"/with a gun. Victim #2 observed Victim #1 was slumped over and was shot. Victim #2 stated he went back in his room to call the Police. Witness #1 told Victim #2 to go take the gun away from **Dedrick Pickens**. Victim #2 stated he went back into the dining room and thought he could talk **Dedrick Pickens** into giving up the gun. **Dedrick Pickens** mumbled something to Victim #2, pointed the gun at Victim #2's chest, and pulled the trigger three times but the gun was empty. Victim #2 stated **Dedrick Pickens** started looking for more bullets so he ran out the front door of the house. Victim #2 ran north bound on Flora and **Dedrick Pickens** followed after him chasing him with the gun. Victim #2 stated **Dedrick Pickens** had been using PCP for the past three weeks. Victim #2 believed **Dedrick Pickens** shot Victim #1 because he was high on PCP. Victim #2 stated there was no other reason for the shooting to occur. Victim #2 stated he did not hear any arguing or a disturbance prior to the shooting. Victim #2 stated the gun used by **Dedrick Pickens** was a revolver.

Witness #1 stated she and Victim #2 were in their bedroom at 3545 Flora watching television when they heard gunshots. Witness #1 stated they jumped up, went to the door and saw Victim #2's son (**Dedrick Pickens**) with a gun. Witness #1 told Victim #2 to get the gun from **Dedrick Pickens** because she thought he was just shooting in the air. She stated she went back to the bedroom and waited, however Victim #2 was taking too

long to return so she went to check on him. She went to the front door and saw **Dedrick Pickens** on the front steps with the gun, but Victim #2 was nowhere in sight. She stated she saw the victim slumped over so she turned on the porch light and saw a puddle of blood. Witness #1 stated **Dedrick Pickens** walked into his room and sat on the bed with the gun still in his hand. She then exited the residence and walked up the street where she found Victim #2.

A search warrant was obtained for 3545 Flora Ave. A black .357 caliber revolver was located in **Dedrick Pickens** bedroom between the mattresses. The gun was loaded with 6 spent shell casings.

On 06/08/2016 at 0948 hours **Dedrick Pickens** was transported from the Jackson County Detention Center to Police Headquarters for a formal statement. **Dedrick** was read the miranda warning waiver and advised he understood his rights and began speaking with us. **Dedrick Pickens** admitted to smoking 3 sticks of PCP on 06/07/2016. **Dedrick** admitted to owning a .357 revolver which he kept in his bedroom fully loaded. **Dedrick** initially stated he did not remember what happened during the evening of 06/07/2016. **Dedrick** stated he had a good relationship with Victim #1 and they did not have any conflict. **Dedrick** stated he did not know Victim #1 had been shot and did not remember shooting Victim #1. After further questioning **Dedrick** stated he remembered chasing Lawanda out of the house with a gun. **Dedrick** stated the gun accidentally went off while he was chasing Lawanda with the gun. **Dedrick** stated he only remembered firing the gun one time. **Dedrick** stated after the gun went off he put the gun in his bedroom between the mattresses.

**Dedrick Pickens** was convicted in Jackson County Missouri with the felony of Possession of Controlled Substance on 02/15/2012 court case #1216CR0055201.
