Count I. Assault/attempt Assault 1st Degree On Law Enforcement Officer, Corrections Officer, Emergency Personnel, Highway Worker, Utility Worker, Cable Worker, Or Probation And Parole Officer (565.081-001Y19891310.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.083, RSMo, committed the class A felony of assault of a law enforcement officer in the first degree, punishable upon conviction under Section 558.011, RSMo, in that on or about July 3, 2016, in the county of Jackson, State of Missouri, the defendant attempted to cause serious physical injury to a law enforcement officer, by grabbing and point a handgun at him.

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

Count II. Burglary 2nd Degree (569.170-001Y19792202.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 569.170, RSMo, committed the class C felony of Burglary in the Second Degree, punishable upon conviction under Sections

558.011 and 560.011, RSMo, in that on or about July 3, 2016, in the County of Jackson, State of Missouri, the defendant knowingly entered unlawfully in an inhabitable structure, located at 6245 Ralston Ave., Raytown MO and owned by for the purpose of committing stealing therein.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

STATEMENT OF PROBABLE CAUSE

I, Nancy Willis, an Investigator with the Raytown, Missouri Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

- I have probable cause to believe that on 07-03-2016 at 6243 Ralston Ave., Jackson County, Missouri, Arnett Waymon McNeal Jr. a black male, born 06-06-1971, committed one or more criminal offenses in Jackson County, Missouri.
- 2. The facts supporting this belief are as follows:

On 07-03-2016 at 2141 hours, Raytown Police were dispatched to 6245 Ralston Avenue on a residential burglar alarm. Police Officer and Officer arrived at the residence. Officer went to the rear of the house while Officer checked the front of the house.
Officer advised he heard Officer yell and then heard a single gunshot. Officer ran to the back of the residence and entered a back door. Officer saw broken glass on the floor inside the entry way. Officer saw Officer standing over two black males who were lying on the kitchen floor wearing blue latex gloves. Officer saw a handgun lying on the kitchen table. Officer said the house was in disarray with papers and coins lying all over the kitchen floor. Officer placed one of the males, later identified as Saintino Garner a black male born, 03-18-1996, in handcuffs and then searched him. Officer located coins (US Currency) in his sweatshirt.
Officer contacted the resident at 6243 Ralston Ave., who said he saw a maroon car earlier in the day (07-03-2016) around 1700 hours parked in the driveway of 6245 Ralston Ave. saw a black male walk up to the front door of 6245 Ralston then walk back to the maroon car and leave. later saw the same car drive by 6245 Ralston Ave. around 2100 hours the same day (07-03-2016). said later when the ambulance was taking the injured suspect identified as Arnett Waymon McNeal Jr. (McNeal) to the ambulance he thought McNeal was the same person that walked up to the front door earlier in the day.

Sergeant Ed Freese conducted an area canvas and located a maroon colored Honda Accord 4-door bearing the license plate of HL3N9T parked in the driveway of 6301 Hedges Avenue. The residence was vacant. Officers were able to see inside the home through the windows and see it was vacant.

Sergeant Freese saw a path (trail) leading from the bottom of the deck steps of 6245 Ralston Ave. diagonally to the southeast corner of the back yard then went to the area of 63rd and Hedges. Sergeant Freese looked inside the maroon colored Honda Accord and latex gloves in plain view.

Detective Nancy Willis applied for a search warrant of 6245 Ralston Ave. and was granted the search warrant from Jackson County Circuit Court Judge Jeffrey Busher. Kansas City Missouri Police Crime Scene Technicians responded to 6245 Ralston and processed the scene.

A 40 cal. Smith and Wesson semi-automatic handgun was found in the kitchen.

Detective Willis applied for a search warrant for the Honda and was granted the search from Judge Jeffrey Busher. Kansas City Missouri Police Crime Scene Technicians had the Honda towed to their

He was in the table holding a change jar when he heard someone come in. He said he turned around and saw someone at the door. He did not know the person was a Police Officer at first but then did. He said he panicked and picked up the gun that was on the table. He said he tried to slide the gun off the table so the Police Officer would not see it. Det. Willis advised him that the body camera worn by Officer showed him (Arnett) grabbing the gun off the table, raising it up and pointing it at Officer Arnett denied wanting to shoot Officer.
