**COMPLAINT**

**Count I. Murder 1st Degree (565.020-001Y19840901.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.020, RSMo, committed the **Class A Felony of Murder in the First Degree** punishable upon conviction under Section 565.020, RSMo, in that on or about March 21, 2016, in the County of Jackson, State of Missouri, the defendant after deliberation, knowingly caused the death of Daizsa Bausby by asphyxia by smothering her.

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

**Count II. Sodomy Or Attempted Sodomy - 1st Degree (566.060-001Y20131114.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.060, RSMo, committed the **Felony of Sodomy in the First Degree**, punishable upon conviction under Section 566.030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about March 21, 2016, in the County of Jackson, State of Missouri, the defendant knowingly had deviate sexual intercourse with D.B., by the use of forcible compulsion.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

### **Count III. Incest (568.020-001Y19003607.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 568.020, RSMo, committed the **Class D Felony of Incest**, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about March 21, 2016, in the County of Jackson, State of Missouri, the defendant engaged in deviate sexual intercourse by having D.B. make contact with defendant's penis whom the defendant knew to be his descendant by blood.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed five thousand dollars (\$5,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime up to a maximum of twenty thousand dollars (\$20,000).

### **Count IV. Sexual Abuse - 1st Degree (566.100-003Y20131114.0)**

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.100, RSMo, committed the **Class C Felony of Sexual Abuse in the First Degree** punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about March 21, 2016, in the County of Jackson, State of Missouri, the defendant knowingly subjected D.B. to sexual contact by the use of forcible compulsion.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

The facts supporting this belief are as follows:

- Murder
- Incest

On 3-21-2016, at 1214 hours, Kansas City Missouri Police officers, were dispatched on a dead body, at the 4 Acres Motel, Room #253, located at 8220 Hickman Mills Drive, Kansas City, Jackson County, Missouri. Staff at the motel had gone to clean the room and found the victim inside.

Upon entry they found a deceased black female Daizsa L. Bausby, BF, 9-28-1997 lying on the only bed in the room. The victim was observed to be face up on the bed. The buttons were missing from her blouse and were found lying beside her on the bed. She appeared to have been redressed with, her pants partially pulled up. Jackson County Medical Examiner ruled her manner of death on 5/5/2016 as a Homicide with the cause being Asphyxia, Smothering. The body examination of Daizsia Bausby revealed that she had been anally sodomized.

Family members of the victim were contacted and advised that they had last seen her on 3/20/2016 at 2030 hours when she had left the home. A few minutes prior to leaving the home, the victim had received a phone call from her father, **Jerry Bausby**.

The room was rented on 3-20-2016 at approximately 2130 hours by her **Jerry K. Bausby**. Surveillance video captures **Jerry Bausby** entering the lobby to rent the room. He is then seen walking to a vehicle which is observed driving toward the rented room. This vehicle is parked in front of the room at the time the victim was discovered. At 0331 hours, a person that matches the description of **Jerry Bausby** wearing a black jacket and grey looking trousers is seen walking from the direction of the motel room across the parking lot and turning south on Hickman Mills Drive. A Fast Stop convenience store about 10 minutes south of the motel captures **Jerry Bausby** on its surveillance system, wearing a black jacket, yellow shirt, and grey colored trousers, purchasing cigarettes, he then walks out of the store and is not seen on the motel video to return to the motel room.

**Jerry Bausby** was arrested at 8215 Troost on 3-24-2016 at about 0930 hours and was wearing the same clothing as he appeared to be wearing in the surveillance video at the Fast Stop on 3-21-2016.

During his interrogation **Jerry Bausby** admitted that he picked Daizsa up at the family house on Sunday the 20th and rented the room at the motel for the victim and "some of her friends". He stated that he only stayed in the room for 20 to 30 minutes and then left and walked to a friend's house. When he left, no one was in the room



except the victim. **Jerry Bausby** stated that he left the vehicle there because it would not start. **Jerry Bausby** denied ever having a sexual relationship with the victim.

A search warrant was obtained through the Jackson County Courts to process **Jerry Bausby's** person.

On 9/19/16 the Kansas City Police Crime Laboratory reported DNA found on the penile swabs of **Jerry Bausby** matched the victims DNA with an expected frequency of 1 in 30 quintillion.
