(Description of Identity)

The facts supporting this belief are as follows:

On 09-18-2015 at 1024 hours officers of the Kansas City Missouri Police Department were dispatched to 6619 Monroe, Kansas City, Jackson County, Missouri, on a reported shooting.

Upon arrival officers observed the victim, Justin Williams B/M 3-4-93, laying in the street, near a Silver Dodge Neon 4 door license, K14Y5G/MO. The driver's door of the vehicle was shut and the passenger's door was standing open. There was heavy front end damage and the windshield was shattered. Officers observed a plastic sandwich bag containing a green leafy substance in the driver's side door pocket. 3 spent shell casings were located on the ground adjacent to the passenger side door of the vehicle. The shell casings were head stamped "WMA 15."

Williams was transported to an area hospital where he was later pronounced deceased.

Witness #1 stated she was walking westbound from 6621 Monroe, when she observed a grey car northbound on Monroe, occupied by two males. She observed the vehicle become involved in a traffic accident with a parked vehicle. The unknown black male and victim got out of the passenger side of the vehicle and began fighting. Witness #1 stated neither the victim nor the black male said anything to one another. Witness #1 stated at some point during the fight the victim got up and ran north. As the victim was running away, the black male pulled out a black handgun, got into a shooting stance and fired at the victim four or five times. The victim fell, at which time the black male pointed the gun at her.

Witness #1 stated she ran west and the black male ran east. Witness #1 stated the black male was wearing an orange hoodie and blue jeans.

Witness #2 was in his residence. He heard 3 gunshots come from the street in front of his apartment. Witness #2 looked out the window and observed an unknown black male running from the area where the gunshots had come from. The black male was dressed in a red hoodie. The black male ran eastbound behind 6619 Monroe Ave. Witness #2 did not see the front of the black male.

Witness #3 was located at the scene. She stated she heard approximately 4 gunshots and looked outside. She observed a young black male wearing an orange hooded sweatshirt and black shorts with white stripes running southbound behind 6619 Monroe Ave.

Witness #3 observed the suspect stop in the bushes behind her residence and throw an unknown item in the bushes, which she believed to be a gun. The suspect then removed his orange sweatshirt and threw the sweatshirt in the bushes as well. The suspect then walked eastbound to Cleveland Ave and began walking southbound from E 67 St/Cleveland Ave. Witness #3 did not lose sight of the suspect until he was stopped by police. Dispatchers broadcast suspect description information and officers observed a B/M matching the physical and clothing description in the area of 68th Cleveland Ave. Officers conducted a pedestrian check and identified him as **Marqiveon D. Washington B/M 7-16-98**. Washington was placed on an investigation arrest.

Officers conducted an article search in the area witness #3 indicated the suspect threw the items and located an orange hooded sweatshirt hanging in a row of bushes just to the south of 6636 Swope Pkwy. A Kansas City Police K-9 responded to the scene and located a black handgun in the bushes just north of where the orange sweatshirt was located. The handgun magazine contained 2 live rounds. The rounds were head stamped "WMA 15." The live rounds in the pistol head stamp matched the head stamp on the spent shell casings recovered from the crime scene.

Washington was transported to 1125 Locust where he was advised of his Miranda Rights and questioned about this case.

Washington initially stated he had been at a girl's house and at home. When advised that officers at the scene had located the hoodie and a handgun, **Washington** stated he called a guy he knew as "Cushin" so that he could buy marijuana from him. **Washington** identified a photograph of the victim, Justin Williams B/M 3-4-93 as "Cushin." The victim picked **Washington** up in the area of 67th and Cleveland. The victim was driving and **Washington** was the front seat passenger. **Washington** stated the victim had a bulge in his shirt as if he had a gun. **Washington** stated they began wrestling over the victim's gun. **Washington** stated as they were wrestling over his gun the vehicle they were occupying struck a parked vehicle. **Washington** opened the passenger door and pushed the victim out of the vehicle. The vehicle stopped and **Washington** got out. **Washington** turned and fired more than one round at the victim as the victim ran back to his car. **Washington** stated he ran from the scene threw a red hoodie and a black sig 9mm pistol in some bushes near the scene. **Washington** later stated the gun they wrestled over was his and not the victims. **Washington** stated he did not see the victim in possession of a firearm.
