I have probable cause to believe that on 4/2012-3/2014, at 3434 Morrell Ave. in (Date) (Address)

W/M 08-12-1972 6'02 165 Bro Blu committed one or more criminal offense(s). (Description of Identity)

The facts supporting this belief are as follows:

On 03-12-14, I was contacted by AG, the mother of [redacted], a 13 year old female, who stated she had been going through a room they were going to remodel at their address of 3434 Morrell Ave., Kansas City, Jackson County, Missouri, and located a diary page hidden in the wall. The diary page was dated 10-17-13, and stated "he sticks his hands in my pants and at night he comes in my room and dose stuff married people do to me." After reading the pages AG called [redacted] and asked if what she wrote was true. [redacted] began to cry and said it was true. FS said Bryan E. Gray, W/M, 08-12-1972 had also threatened that their family would fall apart, and he would kill their dog if she told. [redacted] said Gray would stick his hand down her pants and "play" with her "privates", and has also taken her shirt off and was fondling her. FS said this had occurred several times. [redacted] was able to tell AG that the last time this occurred was within the last month, but could not give a more exact date. This had occurred in [redacted]' bedroom, and a couple of times in the living room on the couch.

On 04-01-14, [redacted] responded to the Child Protection Center for a forensic interview. She stated there was more than one incident of Gray touching her. One incident occurred in AG's bedroom where Gray had taken off [redacted]' pants and underwear. Gray then began to lick [redacted] vagina with his tongue. [redacted] began to kick and cry, and Gray then stopped. [redacted] told Gray that she was angry, and he stated he was sorry, but Gray was laughing when he said it.

Another incident occurred in the summer of 2012 and [redacted] was downstairs watching a movie. Gray was behind FS with his arms around her. Gray then put his hands in her pants and "fondled" her by touching her vagina on the inside and the outside. Gray told [redacted] "there are some things your mom can't give me".

Another incident occurred in [redacted]' bedroom. [redacted] was asleep and Gray came into the room and lifted up her t-shirt. Gray then began to feel and suck on her breasts.

[redacted] stated that she did put the journal in the wall of her house that was located by AG.

On 07-08-14, I contacted Gray who stated he would not speak to me without an attorney.
