The facts supporting this belief are as follows:

Date: 01/24/2015

On 01/11/2015 at 1310 hours, Officers of the Kansas City Missouri Police Department were dispatched to The Bay Waterpark, 7101 Longview Road, Kansas City, Jackson County Missouri in regard to a party down. Upon arrival, Officers discovered the victim deceased from apparent gunshot wounds. Multiple 9mm caliber shell casings were observed at the scene by Officers.

Friends of the victim stated the victim had been communicating with a person referred to as "Malik Suckafree" through Facebook inbox prior to the homicide. The victim's friends further stated the victim arranged to meet someone at 7-11, 10615 Blue Ridge Blvd. The victim's friends drove the victim to 7-11 and observed the victim enter a white Chrysler, four-door vehicle with two unknown black males with dreadlock style hair. The victim's friends advised the victim not to get into the vehicle and began to follow the vehicle as the Chrysler left 7-11 with the victim inside. After losing sight of the white Chrysler, the victim's friends asked the victim to turn on her cell phone's location service in order to be located. Surveillance video from 7-11, 10615 Blue Ridge Blvd. revealed the victim enter a white Chrysler vehicle with a temporary tag at 0353 hours.

Surveillance footage from The Bay Waterpark, revealed a light colored vehicle, similar body style as the white Chrysler, stop in the parking lot where the victim was discovered on 01/11/2015 at 0451 hours. The surveillance footage further revealed the victim being physically assaulted and shot by unknown parties.

On 01/22/2015, a witness was interviewed in regard to the homicide. The witness stated the victim was picked up at 7-11 by "Malik" and "Nick" in a white Chrysler. The witness stated the victim responded to an apartment complex in Grandview with "Malik" and "Nick". While at the apartment "Malik, "Nick", and "Ceantonyo" had a conversation prior to leaving the apartment. The witness stated the victim was taken to the Bay Waterpark where Ceantonyo struck the victim in the face with a handgun and "Malik" shot the victim multiple times. The witness stated "Nick" said, "Face the bitch" as "Malik" was shooting the victim. The witness stated the victim was shot with a 9mm caliber handgun. The witness identified a photo of Issac M. Carter, B/M, 02/01/1997 as "Malik", the person who shot the victim. The witness identified a photo of Ceantonyo D. Kennedy, B/M, 08/16/1997 as the person who struck the victim in the face prior to the shooting. The witness identified Dominic McDaniel, B/M, 08/08/1996 as "Nick", the person who said, "Face the bitch."

On 01/23/2015, Ceantonyo Kennedy, B/M, 08/16/1997 was advised of his Miranda Rights and interviewed in regard to homicide. Kennedy denied involvement in the homicide and stated he was not around when the homicide occurred.

On 01/23/2015, **Dominic McDaniel**, **B/M**, **08/08/1996** was advised of his Miranda Rights and interviewed in regard to the homicide. **McDaniel** admitted to picking up the victim with "Malik" in the white Chrysler and being present when the homicide occurred. **McDaniel** stated **Kennedy** struck the victim with the gun, shot at her approximately five times before "Malik" grabbed the gun from **Kennedy** and shot the victim several more times.
