The facts supporting this belief are as follows:

On 04-05-2017 at approximately 1241 hours, Officers of the Kansas City Missouri Police Department responded to 8100 Blue River Road Kansas City, Jackson County, Missouri 64132 on a reported dead body discovered at that location. Detectives arrived on scene and observed the victim to be partially clothed and wrapped in a plastic tarp. Obvious signs of blunt force and sharp force trauma were observed on the victim’s body. The Jackson County Medical Examiner’s Office determined the cause of death to be multiple stab wounds and the manner of death to be Homicide. The victim was identified as Michael Luckey, w/m, 11/19/87, a resident of Osawatomie, KS. The body exam of Luckey was documented to have 20 sharp force wounds which were about his head, neck, and back.

The victim’s relative advised detectives Luckey had driven to Kansas City, Missouri alone from Osawatomie, KS on the evening of 4/4/17 at approximately 2250 hours to meet someone for sex.

On 04-05-2017 surveillance video was obtained which captured video images dated and time stamped 4/5/2017 at 0024 hours, of two black males wearing dark clothing over red clothing items that arrived at an area convenience store in Kansas City, Jackson County, Missouri operating a vehicle consistent with the color, make and model of the victim’s vehicle.

On 04-05-2017 at approximately 0303 hours, Officer of the Kansas City Missouri Police Department responded to 8420 Park Ave Kansas City, Jackson County, Missouri 64132, an abandoned house, on a reported vehicle fire in the driveway. The vehicle was determined to be the vehicle Luckey had driven to Kansas City, Missouri.

Additional surveillance video was obtained which was date and time stamped 4-05-2017 at approximately 0405 hours which captured three subjects of interest; a young black female, a white female, and a black male. The three individuals were captured shopping and ultimately making a purchase of miscellaneous items to include a cell phone, I-pod, and clothing, for a total purchase of \$700.61 using Luckey’s credit card.

During the course of the investigation several suspects were developed through phone orders, social media, and surveillance video.

On 04-24-2017, **Taylor R. Fitzpatrick, w/f, 5/30/96**, a subject of interest, was arrested and contacted by detectives of the Kansas City Missouri Police Department. **Fitzpatrick** waived the Miranda Waiver Rights and agreed to speak with detectives. **Fitzpatrick** initiated discussing specifically the course of events which included the assault and death of a w/m reported missing. **Fitzpatrick** identified a single color photo of Luckey, and confirmed this individual was the male who was robbed and murdered within 8119 Olive St. **Fitzpatrick** stated that she and a juvenile female posted a personal ad on the internet for the purpose of prostitution for money. The juvenile, posing as an adult, was the focus of the ad. The victim responded to the solicitation ad and agreed to meet her at 8119 Olive Street Kansas City, Jackson County, Missouri 64132 on the evening of 04-04-2017. The victim responded to the residence at 8119 Olive, a single family, one bedroom residence. After the juvenile let the victim inside the residence, the victim engaged in consensual sex in the bedroom of the residence with the black female juvenile. While engaged in sexual intercourse, two black males, "associates of the two females," suddenly entered the bedroom and threatened the victim with a handgun, which was later determined to be fake, during the course of the investigation. A physical altercation ensued between the two black males and the victim. During the course of the initial altercation in the bedroom, the victim could be heard pleading to the black males. After the altercation started, the juvenile female was observed leaving the bedroom wearing only a negligee and carrying the victim's jeans. The juvenile was observed rifling through the victim's jeans and removed the wallet in an attempt to count the cash it contained. **Fitzpatrick** also admitted to assisting in counting the cash which was in excess of \$100 dollars U.S. Currency, less than the agreed amount of money in exchange for cash. The wallet also contained credit cards and a driver's license bearing the victim's name and image. The physical altercation moved from the bedroom to the living room. **Fitzpatrick** described the victim on his knees on the living room floor, not fully clothed leaning forward, with his head on the floor with his arms splayed out to his sides. **Fitzpatrick** stated she believed the victim to be still breathing and alive, and she observed multiple injuries on the victim's back and described both black males as having stabbed the victim multiple times with a knife as the victim was in this position. **Fitzpatrick** described the knife as a 14" culinary knife which she recognized as belonging to her. The two black males were then observed dragging the victim's lifeless body from the residence to the victim's vehicle which was parked outside. Both black males loaded the victim's body in the victim's vehicle and were overheard remarking that there was already a shovel and a tarp in the victim's vehicle. The two black males were described as wearing black hoodies, and are members of a group which always wears red. The two black males were described as leaving the area in the victim's vehicle with the victim's body in the back seat. **Fitzpatrick** believed the victim was being removed from the area to be disposed of in an unknown manner. **Fitzpatrick** identified one of the aforementioned black males from a six person photographic line-up as, **Larry Wren B/M, 03-28-1999**. **Fitzpatrick** was shown an additional line-up on 4/25/17 and identified the second b/m from a six person photographic line-up as, **Micah Dozier B/M 04-24-1999**. Dozier was identified as having a social media account under "Ivo Montana." The image associated with the social media account was also identified by the **Fitzpatrick**. **Fitzpatrick** identified the juvenile female as a friend an associate of hers for several years. **Fitzpatrick** further confirmed to detectives that Wren and the juvenile female are the individuals captured in surveillance video shopping with the victim's credit card. **Fitzpatrick** confirmed she and the black female juvenile attempted to clean up the residence, and blood was described as being on the living room carpet and ceiling in the bedroom where the alteration occurred, which was consistent with evidence observed and obtained after a Search Warrant was served on 4/24/17. **Fitzpatrick**

confirmed the black female juvenile and Wren also were burning items of evidentiary value in the fire pit located in the rear of 8119 Olive St., also consistent with physical evidence documented under the Search Warrant.

On 04-24-2017 the aforementioned juvenile female was contacted by law enforcement. The b/f juvenile was transported to police headquarters with her mother where she was advised of her Miranda rights by a DJO. The juvenile female stated she was present at the time of the homicide. The juvenile admitted that she set up a personal ad for the purpose of solicitation of sex for money and further admitted that she purported herself as an adult in the personal ad. The juvenile stated that she communicated with the victim via e-mail and ultimately via text message during which she arranged for the victim to respond to 8119 Olive Street Kansas City, Jackson County, Missouri 64132. Prior to the victim's arrival the juvenile female stated that a black male she identified as "IVO" communicated his intention to rob the victim when he arrived at the residence. The juvenile further stated **Larry Wren B/M, 03-28-1999**, someone she was previously familiar with, was present at the residence prior to the victim's arrival. The juvenile stated that after "IVO" articulated his plan to rob the victim IVO and **Wren** left the residence. The juvenile stated that when the victim arrived at the residence, she and the **Fitzpatrick** engaged in consensual sexual activity with the victim in the bedroom of 8119 Olive Street. The juvenile stated that IVO and **Wren** re-entered the residence and assaulted the victim in the bedroom. The juvenile stated that the victim then fought back and ultimately ended up in the living room. The juvenile stated that she observed the individual that she identified as IVO stabbing the victim in the living room of 8119 Olive Street. The juvenile stated that she observed the victim to still be alive and stated she heard **Fitzpatrick** say, "Finish Him." The juvenile stated that the two aforementioned black males then departed the area with the victim's body in the victim's vehicle. The juvenile and **Fitzpatrick** then took the money they obtained from the victim and purchased cleaning supplies. The juvenile and **Fitzpatrick** used the supplies purchased to clean the residence in an effort to get rid of the blood and physical evidence left at the scene. The juvenile stated that **Wren**, while unclear of the exact location, stated they got rid of the body somewhere on Hillcrest Ave. Additionally, the juvenile was advised by IVO that he burned the vehicle victim's vehicle at an unknown location. The juvenile confirmed that all of the aforementioned parties were aware that a robbery was planned for the victim upon his arrival at the residence. The juvenile admitted to going shopping with **Wren** and **Fitzpatrick** at a local retail store with the victim's credit card after he was deceased.

On 04-24-2017 the suspect **Larry K. Wren B/M 03-28-1999** was contacted by law enforcement and transported to police headquarters. **Wren** was advised of his Miranda Rights which he waived and stated that he would speak with detectives about the incident. **Wren** admitted that he was aware of the personal ad placed by the juvenile female who he described as his girlfriend for sex in exchange for money. **Wren** stated that he was at the residence prior to the victim's arrival. **Wren** stated a friend and associate that he identified as **Micah Dozier B/M, 04-24-1999 A.K.A "IVO Montana"** from a single photograph arrived at the residence prior to the victim and planned to rob the victim when he arrived. **Wren** stated that he was aware of the plan to rob the victim and planned to, "*get whatever he could*" from the victim. **Wren** and **Dozier** waited outside of the residence, but were able to look in the bedroom window and observed the black female juvenile and **Fitzpatrick** having sexual intercourse with the victim. **Wren** stated that he and **Dozier** then entered the residence and **Dozier** assaulted the victim in the bedroom. **Wren** stated that physical altercation moved into the living room of 8119 Olive St. where the victim was stabbed multiple times by **Dozier** in the back and neck. **Wren** stated that he and **Dozier** loaded the victim's body into the victim's personal vehicle and drove around until they found a place to dump the body. **Wren** stated that after he and **Dozier** dumped the victim's body he returned to a residence on Olive

Street near 8119 Olive Street and then left from there and went shopping with the aforementioned juvenile and **Fitzpatrick** at a nearby retail store where they the victim’s credit card to purchase several items. **Wren** stated that the following day he returned to 8119 Olive where he, the juvenile, and **Fitzpatrick** burned clothing and other items of evidence in an effort to conceal evidence of the crime.

On 04-24-2017 a search warrant was served on 8119 Olive Street Kansas City, Jackson County, Missouri 64132 by officers and detectives of the Kansas City Missouri Police Department. During the course of the search detectives and crime scene technicians located presumptive positive results of blood in the bedroom of 8119 Olive as well as presumptive positive results for blood in the living room of 8119 Olive Street. Additional items of evidentiary value were discovered in the fire pit located behind 8119 Olive Street Kansas City, Missouri 64132.

On 04-26-2017 Officers made contact with **Micah Dozier B/M 04-24-1999** and transported him to police headquarters. **Dozier** was placed in an interview room and advised of his Miranda Rights. **Dozier** waived his Miranda Rights and stated that he would speak with detectives. During the course of the interview **Dozier** denied knowing any of the aforementioned parties. **Dozier** was shown a single photograph of the victim’s vehicle and a surveillance video image of a black male exiting the vehicle. The security image in question was time stamped and dated as 04-05-2017 at 0024 hours, which was confirmed by detectives. **Dozier** identified himself as the individual in the image and stated that he had been driving the victim’s vehicle with his “Bro” but, refused to identify the individual that he was referring to. **Dozier** stated that he stopped at a gas station to go to the bathroom but, would not provide the location of the gas station from which the video was obtained. When asked about the homicide **Dozier** admitted that it was a, “Fucked Up” situation and was going to claim self-defense because, “The Nigga had a 2X4.”
