The facts supporting this belief are as follows:

On 12/05/13 at 0408 hours Officers were dispatched to 2539 Quincy on a reported non- agg assault. Eric Harrell reported Monique Ransom had scratched him in the face and was high on PCP. Monique was arrested and transported to Police Headquarters. Monique was then sent to the hospital due to being high on PCP. On 12/05/13 at 0729 hours Monique was arrested again at 2539 Quincy for refusing to pay the cab fare for the ride from the hospital to her home. On 12/06/13 at 0450 hours Monique was being released from the Kansas City Missouri Police Department Detention Unit. While being released four Detention Officers heard Monique state, "you think this is funny, I'm going to kill this motherfucker Eric, I'm going to be back".

On 12/06/13 at 2301 hours Officers of the Kansas City Missouri Police Department were dispatched to 2539 Quincy Ave on a reported shooting. Upon arrival Officers found the victim (Eric Harrell) suffering from apparent gunshot wounds to his leg, stomach and head. Eric was inside the living room at 2539 Quincy, 9mm and .45 caliber spent shell casings were found near his body.

On 12-07-13 at 0547 hours, Officers observed Monique Ransom and witness #2 arrive at 2539 Quincy. Witness #2 stated on 12/06/13 between 2300 and 2400 hours Monique Ransom was dropped off at the witness #2's residence by Monique's boyfriend Rufus. Monique came inside and appeared to be intoxicated. Monique immediately wanted to take a shower and change her clothes. Monique put on the witnesses son's clothing and tried to hide her clothing in a closet. The witness told Monique she could not wear her sons clothing and provided her a shirt and pants.

Monique voluntarily responded to Police Headquarters, provided a statement and admitted to saying she was going to kill Eric Harrell while she was in the Detention Unit. Monique stated her boyfriend Rufus Antwine had picked her up at her residence on 12/06/13 at approximately 1845 hours. Monique stated she had been driving around with Rufus Antwine all night until he dropped her off at witness #2's house between 2100 -2200 hours. Monique was told she could leave several times during the interview. Monique had to be escorted out of the building several hours after the interview because she would not leave.

On 12/07/13 at 1640 hours Rufus Antwine voluntarily responded to Police Headquarters and initially denied all plyement in the Homicide. On 12/09/13 at 1244 hours Rufus voluntarily responded to Police Headquarters again and Monique and Eric had become involved in a dispute. Rufus stated that he went to 2539 Quincy Ave with Monique and her brother Omar Muhammad to make Eric leave and to just scare him. Rufus stated he went inside the residence with

Monique and Omar but Eric wasn't home. Rufus stated he then went back to his car and was outside when he heard gunshots. Rufus stated he then observed Omar and Monique come running outside and get into his car. Rufus stated he observed Omar holding a gun in his hand as he was running from 2539 Quincy. Rufus also stated the day of the homicide 12/06/13 he noticed his 9mm handgun was missing. Rufus stated he kept the gun at 2539 Quincy in the closet. Rufus stated he did not know what happened to his gun. Rufus denied his gun was used during the homicide.

On 12/11/13 at 1535 hours Omar Muhammad was arrested for DV Assault at 3232 Woodland which is Omar's mother's address. Omar was on the top floor of the residence when Officers arrived on scene. Omar's mother signed a consent to search of her residence at 3232 Woodland. Omar's mother advised Omar does not live at 3232 Woodland but when he visits he stays in a room on the third story. In the room on the third story I observed papers with Omar's name on them. In the closet I observed a missing piece of drywall which allowed access to the attic area. In the attic next to the bedroom closet I observed a rifle case which contained a Colt M-4 assault rifle. The rifle was reported stolen in a burglary on 12/06/13, the same day as the Homicide. A .45 caliber Glock handgun was also stolen during the burglary.

Omar was read his Miranda rights and denied all involvement in the homicide. Omar stated he had been with his girlfriend the entire day. Omar was charged with a burglary unrelated to the homicide and transported to the Jackson County Jail.

On 12/23/13 I contacted Witness #4 who stated he was in Jackson County Jail with Omar Muhammad. Witness #4 stated Omar had told him about the homicide on Quincy. Omar told Witness #4 he and a friend had been arguing with Eric and had guns pointed at him and were trying to rob him. They told Eric to go into the back room of the residence and Eric refused and attempted to grab the gun. The unknown friend shot first and shot Eric in the stomach. Eric then fell to the ground and Omar then shot the victim in the head. Witness #4 stated one of the guns was a 9mm that belonged to Monique's boyfriend (Rufus). Witness #4 stated it was Omar and one of Omar's friends that did the shooting. Omar had advised after the shooting they got into Monique's boyfriend's car and fled the scene. They then took apart the gun and threw it in a sewer. Witness #4 was shown a photo lineup of six black males all similar in appearance. Witness #4 positively identified the picture in position #2 as Omar Muhammad.
