Molestation

The facts supporting this belief are as follows:

On 04/27/2015 at approximately 1:50 p.m., officers of the Kansas City, Missouri Police Department were dispatched to Police Headquarters in regard to child molestation. Upon arrival officers contacted O.D. who stated her 9 year old son, [redacted], disclosed Mark A. Powell touched his private parts and rubbed his body.

On 05/05/2015 [redacted] participated in a forensic interview at the Child Protection Center. [redacted] disclosed that his uncle, Mark A. Powell, was touching on him when his mom was struggling. Powell took [redacted]s clothes and touched his "private parts," and he pointed to his groin area, when [redacted] took a bath. It happened about two times per week. Powell touched [redacted]s nipples and [redacted] was shaking. Powell told him not to tell and told him that he would hit [redacted] with the metal end of a belt and punch [redacted] "with all his might." Powell also touched [redacted]s feet, "knee bone," and "dingaling," all areas which [redacted] identified on an anatomically-correct drawing of a school-aged male. Throughout the interview, [redacted] used the words "dingaling," "nuts," and "dingdang" to identify areas of or around the penis. Powell used his hand to rub [redacted]s "dingaling." Powell also rubbed on the skin on the outside of [redacted]s "booty buns," which [redacted] indicated was the buttocks on the anatomically-correct drawing of the school-aged male.

Powell touched [redacted]s "nuts," which [redacted] stated are under the "dingaling." Powell usually put lotion on his hand before he rubbed [redacted]s "dingaling." [redacted] clarified that the lotion was cocoa butter and that it came from a brown container. [redacted] denied that anyone else ever saw Powell touch [redacted] because Powell had everyone leave.

█████ stated that the first incident occurred when he was eight years old and █████ was taking a bath. Powell used his hand to rub █████'s "dingaling" and nipples. Powell told █████ that he would punch █████ if he told. The last time something happened was also when he was eight years old. Powell was kissing on █████'s "dingaling" when █████ didn't have any clothes on. The incident occurred in the bathroom during █████'s bath. He was standing up and Powell was on his knees when Powell kissed █████'s "dingding," which █████ clarified was the same as the "dingaling." █████ stated that while Powell kissed his "dingding," Powell's hands were also on █████'s "dingding." Powell asked █████ why his "nuts" were "so shiny."

On 02/12/2015 Powell was in police custody and advised of his Miranda Warning and Waiver form. Powell agreed to provide a statement. Powell denied having any type of sexual contact with █████ or any other males.
