The facts supporting this belief are as follows:

On 01/23/2016 at 0325 hours officers of the Kansas City, Missouri Police Department were dispatched to 8602 Bristol Ave. in regard to a rape. Upon arrival officers contacted [redacted] who stated her brother, Donald Riley, strangled her causing her to lose consciousness. When she woke up she spoke to her 12 year old daughter, [redacted] who disclosed being raped.

Offices at the scene spoke to [redacted] who disclosed the following: On 01/23/2016 at 0123 hours [redacted] and Riley began to fight. [redacted] yelled for her to dial 911, but she did not know how to. Riley strangled [redacted] causing her to lose consciousness. Riley left [redacted] in their bedroom and came into her bedroom. He pulled her off the bed and strangled her. She lost consciousness. When she woke up Riley was pulling her shorts and underwear. He put his penis into her vagina. He was not wearing a condom and she was not sure if he ejaculated. He put her back into her bed and asked if she ever had sex before. She told him no. He then apologized and told her not to tell anyone. He left the residence in an unknown direction of travel. She put her underwear in the hamper in her mother's room. Her mother then woke up and dialed 911. She advised that she was feeling pain in her vaginal area.

[redacted] provided a formal statement at the hospital. Riley is her half-brother and has had a sexual relationship with him for 23 years. She and Riley both consumed a lot of alcohol. [redacted] described the alcohol as beer, Amsterdam, Malibu and Carlos Rossi. Riley "choked her out" causing her to go to sleep. While being choked she had an involuntary bowel movement. When she woke up she was laying on the bedroom floor. [redacted] came into her bedroom and told her Riley put his hands around her mouth and did sexual activity to her. [redacted] was not specific but did state Riley put his hands around her mouth and she tried to scream for [redacted]. [redacted] said Riley raped her. [redacted] stated she did not witness Riley rape [redacted].

On 01/25/2016 [redacted] responded to the Child Protection Center located at 3101 Broadway and participated in a forensic interview. [redacted] disclosed Riley and her [redacted] got into an argument. She was in her bedroom and heard them arguing. [redacted] told her to call the police but she didn't because it was "none of her business." She went back




to her bedroom. She saw **Riley** hitting [redacted] with a pillow and put her to sleep with a choke hold. [redacted] clarified she didn't see this, but her mom told her about it.

She was asleep in her room and woke up to **Riley** rubbing her thighs. She tried to run away but he was strong. They were wrestling on the bed. They ended up on the floor in her bedroom. **Riley** covered her mouth with his hand. **Riley** put her into a "head lock" and "put me to sleep." She woke up and he was taking off her pants and underwear. **Riley** had her legs open. **Riley** was naked when he came into her bedroom. He put his "private part" into her "private part." [redacted] labeled the vagina as "private part" and the penis as "private part" on an anatomically correct drawing of a school age female and male.

She was on her back and **Riley** was in front of her. Her "private part" hurt while **Riley** was putting his penis in her vagina. He asked her if she'd had sex before and she told him no. She doesn't know if **Riley** had something on his penis or if something came out of his penis. When he was finished, **Riley** got his things and left. He told her not to tell anyone what happened.
