Count I. Statutory Sodomy 1st Degree - Deviate Sexual Intercourse with Person Less Than 12 Years Old (566.062-001Y19951199.0)

The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, in violation of Section 566.062, RSMo, committed the **Felony of Statutory Sodomy in the First Degree**, punishable upon conviction under Section 566.062, RSMo, and subject to lifetime supervision under Sections 217.735 and 559.106, RSMo, in that on or about January 1, 2011 to August 1, 2013, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant, had deviate sexual intercourse with (DOB 4/26/2005), who was then less than twelve years old, by touching his penis to 's mouth.
