**Count I. Statutory Sodomy 1<sup>st</sup> Degree - Deviate Sexual Intercourse with Person Less Than  
12 Years Old (566.062-001Y19951199.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, in violation of Section 566.062, RSMo, committed the **Felony of Statutory Sodomy in the First Degree**, punishable upon conviction under Section 566.062, RSMo, and subject to lifetime supervision under Sections 217.735 and 559.106, RSMo, in that on or about January 1, 2011 to August 1, 2013, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant, had deviate sexual intercourse with [REDACTED] (DOB 4/26/2005), who was then less than twelve years old, by touching his penis to [REDACTED]'s mouth.

The range of punishment for the unclassified felony of first degree statutory sodomy where the victim is less than twelve years of age is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than ten years. An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

**Count II. Statutory Sodomy 1<sup>st</sup> Degree - Deviate Sexual Intercourse with Person Less Than 12 Years Old (566.062-001Y19951199.0)**

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

**Count III. Statutory Sodomy 1<sup>st</sup> Degree - Deviate Sexual Intercourse with Person Less Than 12 Years Old (566.062-001Y19951199.0)**

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

**Count IX. Statutory Sodomy 1<sup>st</sup> Degree - Deviate Sexual Intercourse with Person Less Than 12 Years Old (566.062-001Y19951199.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, in violation of Section 566.062, RSMo, committed the **Felony of Statutory Sodomy in the First Degree**, punishable upon conviction under Section 566.062, RSMo, and subject to lifetime supervision under Sections 217.735 and 559.106, RSMo, in that on or about January 1, 2011 to August 1, 2013, in the County of Jackson, State of Missouri, the defendant for the purpose of arousing or gratifying the sexual desire of the defendant, had deviate sexual intercourse with [REDACTED] (DOB 3/25/2003), who was then less than twelve years old, by touching his penis to [REDACTED] s mouth.

The range of punishment for the unclassified felony of first degree statutory sodomy where the victim is less than twelve years of age is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than ten years. An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

Wherefore this Indictment supersedes any Complaint, Information, or Indictment previously filed in the Associate Circuit Court.




The facts supporting this belief are as follows:

**Forcible Sodomy/  
Furnishing pornography to a minor/  
Child Abuse**

On 01/02/13 members of the Kansas City, MO Police Department were dispatched to the Central Patrol Division at 1200 E. Linwood in regard to a child abuse. Upon arrival contact was made with MT, the father of the seven-year-old female victim, [REDACTED] who stated she and her nine-year-old sister, [REDACTED] had been sexually assaulted by their step father, Eric J. Shores B/M 07/26/81 while at their residence near E. 60<sup>th</sup> and Indiana (the address was later determined to be [REDACTED] E. 60<sup>th</sup>, Kansas City, Jackson County, MO.)

Both [REDACTED] and [REDACTED] were later forensically interviewed, during which time [REDACTED] disclosed that both she and [REDACTED], along with her brother, get whooping's from Shores with a belt and that sometimes she gets struck in her legs. Shores makes both [REDACTED] and [REDACTED] suck on his "private part" and lick the "round things near his butt". Occasionally Shores makes the girls perform sex acts on him at the same time, or while in the presence of the other. Shores told them when to stop, then "white stuff" came out of his penis. He also makes the children suck on his butt cheeks and kiss him on his lips. In addition, Shores makes the children watch "naked" movies involving adults having anal, vaginal and oral sex. Shores assaults the children in his bedroom and threatens to whoop them if they refuse. Shores instructed both of them not to tell anybody.

During [REDACTED]'s interview she disclosed that she and [REDACTED] had been sexually molested by Shores, their step-father. She further stated that he began abusing [REDACTED] first, then began abusing her when she was nine-years-old. Both the girls witnessed each other being forced to perform oral sex on Shores. On occasion Shores would pick up [REDACTED] while she was asleep and carry her into the bedroom after her mother left for work. Shores made her perform oral sex on him while she was made to touch his penis. He told her that he made [REDACTED] so the same thing. Shores would also put his hand in her pants and rub the outside of her butt, then open up her "private part" and rub his figure around, moving his hand back and forth between her vagina and butt. Sometimes he would put his penis on her chest, moving it side to side. On another occasion she and her brother were on opposite ends of the couch while her brother was asleep. Shores came downstairs and made her perform oral sex on him approximately five minutes until her brother woke up. [REDACTED] also stated the she was forced to perform oral sex on him in the bathroom, and where the washer and dryer were located. She would complain that her jaw hurt but he would just pull her by her hair down to his penis. On one occasion [REDACTED] lost a tooth and the next day Shores made her perform oral sex on him, rubbing the hole in her mouth where the tooth had been with his penis. Shores made her watch pornographic movies involving rape scenes and teenager girls. He instructed her not to tell anybody about the sexual abuse.


The victims' mother, LL, confirmed that both girls disclosed that they had been touched inappropriately by Shores. She confronted Shores, who denied the allegations.

The girlfriend of [redacted] father, **BB**, was interviewed who stated during the 2010-2011 school year LL called her and told her that things were happening at home with [redacted] asked if [redacted] could stay with her. [redacted] later picked up [redacted] who disclosed to her that she has been physically and sexually abused by Shores, that he hit her and "made her touch parts (on his body) that she was not supposed to".

All efforts to locate Shores have met with negative results.
