COMPLAINT

Count I. Rape Or Attempted Rape - 1st Degree (566.030-001Y20131102.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 566.030, RSMo, committed the offense of rape in the first degree, punishable upon conviction under Section 566.030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that on or about August 3, 2016, in the County of Jackson, State of Missouri, the defendant knowingly had sexual intercourse with by the use of forcible compulsion while displaying a knife.

Defendant is a prior offender under Section 558.016, RSMo, in that he has been found guilty of a felony in that: on or about January 1, 2000, defendant was convicted of Child Molestation 1st Degree. in the Circuit Court of Jackson County, Missouri. Defendant is also a persistent sexual offender and is punishable by sentence to an extended term of imprisonment for life without eligibility for probation or parole, under Sections 558.018 and 557.036, RSMo, in that: on or about November 15, 1983, defendant was convicted of an Attempted Rape in the District Court of Chicot County, Arkansas.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

The facts supporting this belief are as follows:

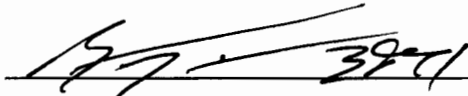
On 08/03/16 at 2:06 a.m. officers of the Kansas City, Missouri Police Department were dispatched to the area of 8th and Troost in regard to a rape. Upon arrival officers contacted the victim who told them she had been raped at her place of residence, 1100 E. 8th St., Kansas City, Jackson County, Missouri by an unknown black male.

In a statement to detectives on 08/16/17 the victim stated she was asleep in her locked bedroom. She was awoken by the suspect standing over her. When she screamed the suspect put his hand over her mouth and told her if she cooperated he would not harm her. The victim said the suspect was holding a knife to her throat. The suspect told the victim to remove her clothing which she did. The suspect removed his shorts and got on top of the victim as he held the knife to her throat. The suspect penetrated the victim's vagina with his penis and ejaculated inside her vagina. When the suspect was done he put his shorts back on and told the victim if she called the police he would kill her. The victim said the suspect left and a short while later she called 911. The victim responded to a local hospital where she had a sexual assault kit completed.

On 01/11/18 Lab report# 4 was received from the Kansas City Police Crime Lab. The report stated the genetic profile developed from the vaginal swabs contained in the sexual assault kit matched a Missouri convicted offender through the CODIS system. That offender was identified as Arthur Garrett (B/M, 09/28/60, SID# MO01145146). It was later discovered Arthur Garrett's legal name is **Arthur Norman Jr.** Norman is a registered sex offender.

On 02/06/18 **Norman** voluntarily responded to Police Headquarters where he was advised of his Miranda Warning. **Norman** waived his rights and made the following statement: He did know the victim but denied any kind of sexual contact with her and denied any kind of relationship with her. **Norman** denied ever being in the victim's residence.

A buccal swab was obtained from **Norman** and submitted for comparison. Lab results are pending.
