

PROBABLE CAUSE STATEMENT FORM

I, Joshua Kerr, a Police Officer with the Greenwood Police Department, upon my oath, and under penalties of perjury, knowing the facts contained herein are true, state as follows;

1. I have probable cause to believe between the year 2011 through March 31, 2017, Richard T. Woodbridge, a white male, date of birth December 26, 1984, social security number [REDACTED], violated one or more laws while in Jackson County, Missouri.

2. The facts supporting this belief are as follows:

On April 4, 2017 at approximately 1539 hours, I was contacted the Greenwood Police Department by Richard T. Woodbridge. Woodbridge stated he wanted to turn himself in for having sexual relations with a minor, who he identified as [REDACTED] (01[REDACTED]2003). Woodbridge signed a Miranda warning waiver and wished to speak with me without a lawyer present. Woodbridge stated the minor in question is [REDACTED] currently 14 years of age. Woodbridge stated the sexual contact began in 2011 by rubbing and touching. Woodbridge stated he and the juvenile would "grind" and "dry hump". Woodbridge also stated he would touch her vagina underneath her clothing and she would touch his penis underneath his clothing. Woodbridge stated this occurred from 2011 to 2017. Woodbridge stated he could not recall how many times this occurred. Woodbridge stated in 2014, he and the victim began having sexual intercourse by inserting his penis inside her vagina. Woodbridge stated they had sexual intercourse once in 2014, four (4) to five (5) times in 2015, four (4) to five (5) times in 2016 while under the age of 14 years old. Woodbridge stated they had sexual intercourse once in 2017, which occurred on March 31, 2017, while at the age of 14 years old. Woodbridge stated between the year 2014 and 2017 he used his finger several times, but could not remember how many times or the exact dates of occurrences. Woodbridge stated he performed oral sex on the victim one time in 2014 but could not remember the exact date. Woodbridge stated the victim performed oral sex on him several times between 2014 and 2017. Woodbridge stated he could not recall how many times or exact dates. Woodbridge did state he ejaculated inside the victim's mouth one time, but could not recall an exact date or year. Witness #1 stated that there were times when Woodbridge and the victim were alone together during the six (6) years of the victim residing inside the home. Witness #1 did not think Woodbridge was lying about the incidents with the victim.

On April 5, 2017 at approximately 1420 hours, I was contacted by the Missouri Department of Family Services (DFS). The DFS Investigator stated she interviewed [REDACTED] in reference to the suspect's admission. The DFS Investigator advised me that [REDACTED] confirmed the sexual intercourse between her and Woodbridge. The DFS Investigator advised me [REDACTED] stated the sexual contact began when she was eight (8) years old and did not end until last Thursday, March 31, 2017.
