The facts supporting this belief are as follows: On 06/22/2013 at 0635 hours, a [redacted] year old [redacted] victim reported to Kansas City Missouri Police Officers that [redacted] was raped by a stranger, (later identified as Justin Fields B/M 10/19/1989) at, [redacted] Kansas City, Jackson County, Missouri.

The victim stated that [redacted] met [redacted] cousin and Fields on 06-21-2013. The victim stated that they all partied and returned to [redacted] residence, where [redacted] cousin asked if he and Fields could stay. The victim agreed and went in [redacted] bedroom to use the phone. The victim stated that Fields came in the room and began to lick [redacted] thighs. The victim forced Fields off [redacted] and went back to the living room. The victim told [redacted] cousin that he needed to get Fields out of there. The victim stated [redacted] cousin told [redacted] that he was too intoxicated to drive, so [redacted] let them stay. The victim stated that all three of them fell asleep on the couch and [redacted] was awoken by Fields moving [redacted] to the side and sucking [redacted]. The victim told Fields to "stop" then Fields grabbed [redacted] by the arm, drug [redacted] into the bedroom and closed the door. The victim stated [redacted] attempted to fight Fields off, but he forced [redacted] on the bed and began to kiss [redacted] neck and [redacted]. The victim stated Fields pinned [redacted] arms down with one hand and forced oral sex on [redacted]. The victim stated that Fields rolled [redacted] on [redacted] stomach and penetrated [redacted] with his penis. The victim stated that Fields did not fully enter his penis into [redacted] because [redacted] was thrashing so much. The victim stated [redacted] was calling 911 with [redacted] free hand, but was unable to speak to the dispatcher due to having to fight off Fields. The victim stated Fields turned [redacted] on [redacted] side and attempted to insert his penis into [redacted] again, but failed. The victim stated at that time [redacted] cousin entered the room and Fields immediately got up. The victim told them both to leave the apartment or [redacted] would get a knife. The victim stated [redacted] cousin and Fields left the apartment. The victim responded to St. Luke's Hospital on the Plaza for a Sane Exam.

Witness#1 the victim's [redacted] friend stated that he received a phone call from the victim on 06-22-2013 at 0538 hours. During the call Witness#1 stated that the victim told [redacted] [redacted] wanted [redacted] to come get [redacted] and [redacted] could hear the victim tell someone to stop and get off [redacted]. Witness#1 stated [redacted] received another call about 0545 hours from the victim, but [redacted] could only hear a male voice in the background say "you [redacted] can't do it like me". Witness#1 stated another phone call about 10 minutes later and the victim told [redacted] that [redacted] had been raped by [redacted] cousin's friend.
