# **COMPLAINT**

# Count I. Assault 1<sup>st</sup> Degree or Attempt - Serious Physical Injury or Special Victim (565.050-001Y19841399.0)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.050, RSMo, committed the **Class A Felony of Assault in the First Degree**, punishable upon conviction under Section 558.011, RSMo, in that on or about June 9, 2018, in the County of Jackson, State of Missouri, the defendant knowingly caused serious physical injury to by pushing his thumb into the eye of

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

## Count II. Attempted Assault - 3<sup>rd</sup> Degree - Special Victim (565.054-001Y20171399.1)

The Prosecuting Attorney of the County of Jackson, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.054, RSMo, committed the **Class E Felony of Attempted Assault in the Third Degree**, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about June 9, 2018, in the County of Jackson, State of Missouri, the defendant knowingly attempted to cause physical injury to \_\_\_\_\_\_\_, a law enforcement officer, and special victim by striking her, and such conduct was a substantial step toward the commission of the offense of Assault in the Third Degree of \_\_\_\_\_\_, and was done for the purpose of committing such assault.

The range of punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than two (2) years and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that an arrest warrant be issued as provided by law.

The facts supporting this belief are as follows:

On 06/09/2018 at 1803 hours, Officers were dispatched to 5522 St. John Ave (Superior Minimart) on a reported Disturbance. Upon arrival, Officers made contact with the disturbing party whom they located behind the counter of the market. The officers attempted to take the SUS1 BRADBURY, TREVORWAYNE B/M 09/25/1975 into custody and he actively resisted arrest, physically assaulting the responding officers.

Contact was made with VIC1 at Research Hospital. VIC1 stated he is an Officer and currently assigned to East Patrol Division, 2640 Prospect Kansas City, Missouri, 40 sector. On, 06/09/2018 he was riding as a single person crew and his assisting car was operated by VIC2. Upon arrival a female was outside flagging them down and stated BRADBURY was at the counter and had stolen her daughter's cell phone and was causing a disturbance. Upon entering the establishment VIC1 observed BRADBURY to have his back to him and appeared to be going through something on the counter. VIC1 approached from the rear, removed his handcuffs and grabbed for BRADBURY's arm to place him in handcuffs. BRADBURY threw his elbow back striking VIC1 and creating distance, **BRADBURY** began assaulting VIC1 by striking him in the face. As VIC1 was attempting to take BRADBURY into custody he heard BRADBURY repeat "I'm not going back, I'm not going back, I'd rather die than go back." At one point during the struggle, VIC1 attempted to pin down BRADBURY; BRADBURY began gouging VIC1's right eye with his thumb. VIC1 felt he was going to lose his eye. Several attempts to tase BRADBURY met with negative results. At one point, VIC2 deployed the Taser which made contact with BRADBURY; however, BRADBURY pulled the prongs out of himself. BRADBURY continued to assault VIC1 and throw items at him; VIC1 then drew his service weapon and gave verbal commands to stop and get down. BRADBURY retreated to the storage closet. Assisting officers arrived and VIC1 was able to exit the business and receive medical treatment.

VIC2 stated she is an Officer for the Kansas City Missouri Police Department and currently is assigned to East Patrol Division, 2640 Prospect Ave., Kansas City, Missouri, 40 Sector. On 06/09/2018 she was riding the Patrol Wagon as a single person crew. Her assisting car was operated by VIC1. Upon arrival she was flagged down by a female who stated BRADBURY stole her daughters cell phone and was causing a disturbance. When VIC2 entered the store, she observed BRADBURY behind the counter and it appeared he was rifling through

BRADBURY turned around immediately and began assaulting her and VIC1. VIC2 stated the situation was a blur but she knows she was struck in the face and head several times by BRADBURY. At one point, BRADBURY attempted to place her in a chokehold but she was able to get out of it. VIC2 attempted to deploy her taser on BRADBURY several times but it had no effect. At one point BRADBURY had VIC1 on the ground and was "hunched over him" exposing his back. At that time, VIC2 delivered several strikes with her PR 24 into BRADBURY's middle lumbar region on his back. The strikes had little effect and he continued assaulting VIC1. At that time she struck BRADBURY on the head with her PR 24 and he still did not stop assaulting VIC1. VIC2 stated nothing seemed to have an effect on BRADBURY. She kept telling BRADBURY to let VIC1 go and to get down. She stated VIC1 and BRADBURY disengaged and BRADBURY began to go back to the corner of the office towards a storage door. Assisting officers arrived and she was able to receive medical treatment.

WIT1 stated she is an employee at the Superior Minimart and recognized BRADBURY when he entered the store on 06/09/2018 from an incident several months ago when he was trespassed from the property.

BRADBURY pushed past WIT1 and entered the employee area. WIT1 told BRADBURY to leave multiple times but he refused, stating he was staying and that he worked there. WIT1 told BRADBURY she was calling the police. BRADBURY told her to call the police. When WIT1 picked up the phone, BRADBURY grabbed the phone from her then gave it back. BRADBURY then grabbed a water and sat down. He said he wasn't leaving and to call whoever she wanted to. When the police arrived, BRADBURY became "all hyped up" and tried to hit the officers. The officers tried to arrest him but he attempted to run back to the cooler. One officer tried to grab him and pushed him into a corner. The officers began fighting with BRADBURY. WIT1 observed the officers on top of the male. BRADBURY poked the male officer in his eye with his finger. She observed the officer's eye to be bleeding and really red. The female officer tased BRADBURY but it didn't work.

BRADBURY then ran back to the cooler. He then came back and grabbed a mop. Other officers then arrived on scene and WIT1 was told to exit the store.

WIT2 stated he is an employee at the gas station and has been working there for approximately one month. He was working in the back cooler area when **BRADBURY** came in the back. WIT2 asked what he was doing and **BRADBURY** stated, "none of your business, I'm just here". WIT2 asked another employee if the suspect worked there and she told him no and he needed to leave. She told him to call the police. WIT2 told **BRADBURY** again that he needed to leave and **BRADBURY** told him no and to do whatever he needed to do. WIT2 stated **BRADBURY** was stumbling while walking and his eyes were red so he thought he might be under the influence of some substance. The police officers arrived and began fighting with **BRADBURY**. **BRADBURY** began throwing things at the officers. **BRADBURY** was saying he didn't want to go to jail. **BRADBURY** fell down in the corner and fighting the officers. He grabbed the hair of the female officer and tried to kick and hit the male officer. The officers attempted to tase **BRADBURY** but he pulled the wire off. Other officers arrived and WIT2 observed the male officer's eye to be bleeding and he stated he couldn't see. **BRADBURY** was at the back door at that point with a mop in his hand. WIT2 was then told to exit the store.

WIT3 stated he was on a civilian ride along with VIC1. They arrived at the location and entered the business. He observed **BRADBURY** behind the counter where the cash register was located sitting on a stool. **BRADBURY** stated "this is my store, I'm not going". The officers attempted to detain **BRADBURY** and took him to the

ground. **BRADBURY** started fighting the officers and was hitting/kicking the officers. VIC1 attempted to put the suspect in handcuffs. The taser was deployed and **BRADBURY** pulled the probes of the conductive energy device out and threw them at VIC1. **BRADBURY** tripped VIC1 and he was on the ground on his front side and **BRADBURY** was on VIC1's back. **BRADBURY** had his hands on VIC1's head, hitting him and attempting to bang VIC1's head into the floor. He thought at that time **BRADBURY** injured VIC1's eye. At one point VIC2 used her PR-24 (described as a club) and hit **BRADBURY** with her PR-24. **BRADBURY** again entered the back room and officers arrived on scene. WIT3 stated that an unknown b/m citizen helped the officers during the struggle. Other officers arrived on scene and he exited the business.

WIT4 stated **BRADBURY** was behind the employee area when he arrived to the store. WIT4 observed **BRADBURY** sitting on a chair and appeared calm and cool. When officers arrived, **BRADBURY** began to fight them. The male officer went to his knees and **BRADBURY** was over the top of him. **BRADBURY** was hitting the male officer. The female officer attempted to tase **BRADBURY** but it didn't have any effect on him. **BRADBURY** had grabbed the taser and pointed it at the female officer. Since the probes had already been discharged, it did not fire. **BRADBURY** threw the taser at the female officer. The female officer grabbed her baton and began hitting **BRADBURY** telling him to "get off of him". **BRADBURY** then grabbed the female officer's hair. WIT4 grabbed **BRADBURY**'s hand and threw it off the officer. WIT4 attempted to help the officers, but the civilian who was riding with the male officer told them not to interfere unless the officers asked for help. WIT4 observed the male officer to have a puffy red and bloody eye. The suspect had blood on the back of his head as well. WIT4 sustained a minor injury to his finger when **BRADBURY** shut the door on him prior to officers arrival.

The incident was captured on the store's surveillance system. It shows **BRADBURY** push his way through the door of the employee cashstand area and sit behind the counter area. When **BRADBURY** observes officers enter the front door, he obtains his property bag from the storage room and he begins to rummage through it at the counter. As the officers enter the employee area, **BRADBURY**'s back is to them. VIC1 attempts to place handcuffs on **BRADBURY** and **BRADBURY** actively resists officers and assaults them repeatedly. VIC1 and VIC2 both attempted to tase **BRADBURY**, at which one point, **BRADBURY** removes the taser prongs from his body. In one frame it is apparent that VIC1 is bleeding from his right eye. **BRADBURY** attempted several times to grab the taser from VIC1. **BRADBURY** pulled VIC1 to the ground by grabbing onto his outer vest. As **BRADBURY** was hovering over VIC1, VIC2 began striking **BRADBURY** with her PR-24. **BRADBURY** grabs onto VIC2's arm with one hand, and her head with the other hand. A citizen stepped in and removed his hand from her head. **BRADBURY** quickly stood up and pulled VIC2's taser from her left leg holster and attempted to tase her. When it did not work, **BRADBURY** threw the taser at VIC2. VIC1 then pulled his duty weapon and **BRADBURY** retreated out of camera view.

**BRADBURY** refused to leave his cell at Jackson County Detention. **BRADBURY** stated to detectives "You all keep fucking with me I'm going to kill you all."

When assisting officers arrived to relieve injured VIC1 and injured VIC2, **BRADBURY** had barricaded himself in the storage closet. An operation 100 was called but subsequently called off when **BRADBURY** eventually surrendered without incident. VIC 1 sustained a corneal laceration and severe trauma and bleeding to his right
